

# COMPLAINT

The CHRB hereby files a complaint against **DOUGLAS F. O'NEILL** for violation of CHRB Rule **1843(a)**, **1843.6 (d) (1)(2)**, **1887 (a)** . The person named in this complaint holds a license as a **TRAINER**, license number **112723**. The offense alleged occurred on or about **AUGUST 25, 2010** and is as follows:

**THE OFFICIAL BLOOD SAMPLE #TC 222699L TAKEN ON AUGUST 25, 2010 AT DEL MAR THOROUGHBRED CLUB WAS REPORTED BY SCOTT STANLEY OF U.C. DAVIS LABORATORIES TO CONTAIN 39.4 MILLIMOLES PER LITER OF TOTAL CARBON DIOXIDE (TC02). THIS PRE RACE BLOOD SAMPLE WAS OBTAINED FROM THE HORSE "ARGENTA" WHICH RAN IN THE 6<sup>TH</sup> RACE AT DEL MAR FINISHING OUT OF THE MONEY. THE TRAINER OF RECORD IS DOUGLAS F. O'NEILL.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
