

## COMPLAINT

CASE NUMBER: **10GG0224**

The CHRB hereby files a complaint against **Alfonso Coyt** for violation of CHRB Rule **1843(a)b)c)d), 1844(a) 1844 (e)9), 1844(f), 1887(a),1922**. The person named in this complaint holds a license as a **Owner**, license number **305163-05/2012**. The offense alleged occurred on or about **11/13/10** and is as follows:

**On 11/10/11 Alfonso Coyt gave 5 cc of Clenbuterol in paste form to the horse "Don'tblocktheshot" in the morning feed at the ranch in Salinas, Ca. He is the groom and exercise rider for "Don'tblocktheshot" at the ranch. The horse was scheduled to run at Golden Gate Fields on 11/13/10. A. Coyt is the cousin of "Don'tblocktheshot"'s owner Jesus Coyt. See A. Coyt's written statement. "Don'tblocktheshot" was transported from the ranch to the Alameda County Race Track, Pleasanton on 11/12/10 arriving at 0640 hours. Alfonso Coyt had loaned a relative, Carlos Coyt his CHRB license so the relative would have no trouble going through the stable gate. Carlos Coyt does not possess a CHRB license.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
