

## COMPLAINT

CASE NUMBER: **15GG0117**

The CHRB hereby files a complaint against **Miguel Gonzalez** for violation of CHRB Rule **1843(a),(b)&(d), 1843.1(a), 1844(a), 1844(e)(6), 1887(a), 1894, 1588(j), 1859.5**. The person named in this complaint holds a license as a **Trainer**, license number **283245 Exp. 9/2016**. The offense alleged occurred on or about **9/11/15** and is as follows:

**- NOTE: AMMENDED COMPLAINT DUE TO CHANGE OF DATE -**  
**Trainer Miguel Gonzalez allowed two horse owners, Samuel and Candido Galeote, to enter two horses under his name at the San Joaquin County Fair without him actually seeing or training the horses. He was unaware who transported the horses to the track or who paddocked them prior to the race. The two horses subsequently tested positive for Clenbuterol. The horses were apparently brought directly to the track on race day from a ranch and were not stabled 24 hours prior to the race at a CHRB authorized auxiliary racing facility.**

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
