07-04-12² **RULING NO. 10 – VILLALOBOS**

Jockey **CARLOS VILLALOBOS** is fined the sum of fifty dollars (\$50.00) for exercising horses on the grounds of the Alameda County Fair (Pleasanton) without an approved helmet on July 4, 2012; a violation of California Horse Racing Board rule #1689 (Safety Helmet Required).

The above ruling was issued after Villalobos appeared and admitted that he left his approved helmet at Golden Gate Fields and substituted an old unapproved version.

Subject had been warned previously by outrider Jane Schvaneveldt and safety steward Paul Nicolo so the fine was imposed by the stewards.

07-04-12³ **EATON HEARING** (Case #12GG099)

A telephonic hearing was conducted for trainer Terri Eaton whose horse CITY CHAPEL showed a bute level of 3.15 ug/ml in a post race test sample on May 26, 2012. The hearing was to be held on July 7, but Eaton waived her right to notice. Since Eaton has not had a medication violation in over three years, she was given a warning.

07-04-12⁴ **FILM REVIEW**

Jockey **Jesus Arriaga** viewed the tapes of last Sunday's first race in which his mount was the subject of an inquiry. His quarterhorse ducked in just before the wire and squeezed a competitor. The films showed that a horse to Arriaga's outside influenced his mount's actions and by majority vote (Steward McHargue dissenting) Arriaga was held blameless.

07-04-12⁵ **ONE HOUR POST TIME DELAY**

Third race post time was unavoidably pushed back due to a mechanical breakdown on the starting gate. As the gate was about to be set for the mile and 70 yard event the chain which connects to the steering mechanism for the front two wheels broke making the gate unsteerable. While the experts attempted to correct the problem the horses were returned to the paddock and unsaddled.

Originally it was estimated that repairs would take fifteen minutes but perception did not translate into reality in this instance. The scheduled post time was 2:15 p.m. and the race finally went off at 3:15 p.m. Trainers were given the opportunity to take their horse out of the race if that horse was not handling the delay and one trainer in the seven horse field chose to scratch. Brian Pitnick asked that his horse, SHE'S STELLA MARIE, be declared and the stewards complied. The refund amounted to \$12,991.86.

Although the steering chain was never repaired on track the gate was maneuvered around the oval by hooking up the tractor to the rear tow bar and utilizing the expert driving talents of Butch Zollinger, who had to set the gate at the various distances by methods completely contrary to normal procedures. We were assured the gate would be repaired by the morrow.

07-04-12⁶ **LATE SCRATCH – Fifth Race – REFUND**

#3 ERMA'S FIRST LOVE, trained by John Piches, was scratched by the stewards on the recommendation of track veterinarian Sara Sporer D.V.M. as the field approached the starting gate. Dr. Sporer relayed that the filly was off on the left front. On Vet's list. The refund totaled \$6,911.28.

07-04-12⁷ **LATE SCRATCH – Seventh Race – REFUND**

#7 JESSABOOM, trained by J. M. Chandler, was scratched on the advice of Dr. Sporer two minutes before post time after she reported the mare failed to warm up properly. On vet's list. The refund was \$7,193.76.

07-05-12² **FILM REVIEW**

Jockey Abel Cedillo viewed the tapes of yesterday's ninth race and was cautioned to react quicker when his mount veers off course leaving the starting gate.

07-05-12³ **STEWARDS' INQUIRY – First Race – NO CHANGE**

The stewards conducted an inquiry to evaluate an incident at the 1/16 involving the fourth place horse #2 CLEVER CAYENNE, ridden by Pablo Flores, and the fifth place horse #4 LADY ROCHELLE, with Russell Baze in the irons, after Baze steadied his mount behind Flores' horse. After a thorough review the stewards affirmed the original order of finish.

Tapes showed that racing on the lead CLEVER CAYENNE was backing up rapidly and LADY ROCHELLE was closing ground. Both horses shifted at the same time, CLEVER CAYENNE to the outside and LADY ROCHELLE to the inside, which resulted in Baze being on Flores' heels. Since both horses were equally responsible the stewards took no action.

07-05-12⁴ **STEWARDS' INQUIRY / ACCIDENT – Eighth Race – NO CHANGE**

The stewards posted the inquiry sign to determine the cause of an accident as the field approached the 3/8 after jockey **Jorge Herrera** was unseated from his mount, #8 MORITO, trained by Jose Godinez. MORITO appeared to clip heels and stumble thereby unseating Herrera. After an extensive film review the stewards affirmed the order of finish as posted on the tote board.

Tapes showed that as the field raced down the backstretch Herrera and MORITO were racing seventh toward the rear of the field. Herrera positioned his horse in the middle of the track between and behind #9 TRIBAL SUN, ridden by Frank Alvarado, to his outside and #5 DEVIL ON THE MOVE, David Essman in the saddle, to his inside. As this trio approached the turn Herrera shifted slightly to the inside putting MORITO close to the heels of DEVIL ON THE MOVE. He then reacted to the close quarters by steering MORITO to the outside. This last action took MORITO out over the heels of TRIBAL SUN and caused MORITO to clip the heels of that horse.

MORITO stumbled from the contact with TRIBAL SUN and Herrera was thrown over MORITO's head to the ground. It appeared from the replays that MORITO stepped on, or kicked, the downed rider. MORITO continued behind the field and was captured without incident by the outrider after the race.

Herrera was attended to by the paramedics in the ambulance trailing the field and then transported to Eden Trauma Center.

07-06-12²**STATUS CONFERENCE ON THE EIGHTH RACE 07-05-12**

A conference was held in the stewards' office this morning to update all interested parties regarding yesterday's tragic accident in the eighth and final race in which jockey Jorge Herrera died of the injuries suffered in a spill. Present at the meeting were Larry Swartzlander representing California Authority of Racing Fairs, Jeanne Wasserman, Director of Operations for the Alameda County Fair, Rick Pickering, CEO for the Alameda County Fair, Alameda County Fire Department Division Chief J. R. Schnepf and Deputy Fire Chief David Rocha, track veterinarian Dr. Sara Sporer, stable and track superintendent Jim Burns, CHRB Senior Investigators Carol Kane and Barbara Chimero, Jockey Guild Regional Manager Darrell Haire and Safety Steward Paul Nicolo.

While the main thrust of the conference began by discussing yesterday's events the CHRB investigators requested that they be given the opportunity to interview all parties individually prior to a group discussion. The request was granted and the conversation then centered on what recommendations can be made going forward.

The main concern was that by having only EMT personnel in the chase ambulance care to a downed rider could be compromised in emergency situations and that having paramedics instead of EMT's would be a better alternative. Rick Pickering stated that starting today a paramedic would accompany the EMT's in the chase ambulance. Various other topics and recommendations were discussed before the meeting was adjourned.

07-06-12³**PALDANIUS HEARING** (Case #12GG048)

A formal hearing was conducted for trainer **Sheldon Paldanius** who was the subject of a complaint alleging violation of California Horse Racing Board rules #1843 (a) & (d) (Medication, Drugs and Other Substances), #1844 (e) (1) Authorized Medication) and #1887 (Trainer to Insure Condition of Horse). The horse, MOOSE HIGH, trained by Paldanius, showed the presence of 2- (1-Hydroxyethyl) promazine, a metabolite of Acepromazine, in excess of the permitted level after a post race sample was obtained on March 1, 2012.

Present at the hearing were Paldanius and his attorney Brian Pitnick along with CHRB senior investigator Barbara Chimero and Deputy Attorney General Bill McMahon. On behalf of his client, Pitnick stipulated to all the evidence contained in the complaint packet choosing not to challenge the chain of custody or the findings from the lab. Instead, Pitnick wanted to concentrate on the mitigating factors which the stewards should consider before reaching a decision on the penalty. The stewards took the matter under submission and will render a decision in the near future.

07-06-12⁴**STEWARDS' INQUIRY / OBJECTION – First Race – NO CHANGE**

The stewards lit the inquiry lamp to evaluate the actions of #4 BAR JF EASY MONEY (1st, Anthony Ayala) in the final yards of this 350 yard mule race. Jockey Jesus Arriaga, aboard the third place finisher #2 BAR JF FLYIN, also lodged an objection against the winner. After a thorough review the stewards affirmed the original order of finish.

The tapes showed that BAR JF EASY MONEY did drift in and cause close quarters but not to the extent that a disqualification was warranted.

07-06-12⁵ **LATE SCRATCH – Sixth Race – REFUND**

#1 DREWTHE TIGER, trained by Ed Moger, was scratched by the stewards after the colt unseated the jockey leaving the paddock and ran off. The horse ran approximately ¾ of a mile before being captured. The refund totaled \$ 3,264.32.

07-06-12⁶ **STEWARDS' INQUIRY – Sixth Race – NO CHANGE**

The stewards posted the inquiry sign to evaluate an incident at the 1/16 involving the winner #6 REBEL MY MAN, ridden by Russell Baze, and the show horse #9 SLIPPERY SLEWP with Frank Alvarado in the saddle. Alvarado was observed to check his mount behind Baze at the 1/16. After a thorough review the stewards made no change to the placings.

Tapes showed that while REBEL MY MAN did drift out from the rail, SLIPPERY SLEWP was lugging in at the same time. Since both horses contributed to the incident blame could not be placed solely on REBEL MY MAN.

07-07-12³ **FILM REVIEW**

Jockeys **Abel Cedillo**, **Jesus Arriaga** and **Russell Baze** viewed the tapes of yesterday's races with the stewards and each was cautioned as to what the stewards expect in the particular circumstance each rider found himself confronted with.

07-07-12³ **STEWARDS INQUIRY – Second Race – DISQUALIFICATION**

The stewards posted the inquiry sign to review observed and reported interference shortly after the start of this 350 yard mule race. After an extensive evaluation the stewards disqualified #3 CHASE THE MONEY, ridden by Anthony Ayala, from second and placed him sixth for interference to most of the field. Tapes showed that CHASE THE MONEY ducked out sharply about the 1/8 bumping and impeding everybody on his outside up to and including #7 OKIE PRIDE LARRY, who finished sixth.

Official order of finish: 2 – 4 – 5 – 6 – 7 – (3) – 1

07-07-12⁴ **LATE SCRATCH – Third Race – REFUND**

#5 FLYING PROMISES, trained by Humberto Loma, was scratched on the advice of the track veterinarian after Dr. Sporer reported the horse slipped in the starting gate and was injured. On Vet's List. The refund was \$10,919.03.

07-07-12⁵ **STEWARDS' INQUIRY – Eighth Race – NO CHANGE**

The stewards illuminated the inquiry light to evaluate the actions of #6 MR. KINGOFTHEROAD, ridden by Jesus Velazquez, after the horse was observed weaving at the top of the far turn. After a thorough review the stewards affirmed the posted order of finish.

Tapes showed that Velazquez steered his mount toward the inside approaching the 3/8 causing #2 LITTLE SIBERIAN (4th, Ronald Richard) to steady. Velazquez then altered course to the outside taking #5 TOP BOSS (6th, Julien Couton) off his path.

No disqualification was warranted as MR. KINGOFTHEROAD finished last but Velazquez will view the tapes of the race with the stewards in the morning and explain his actions.

07-08-12² **PALDANIUS DECISION** (Refer 07-06-12³)/ **RULINGS # 11 & 12**

Acting upon a report from University of California at Davis Maddy Laboratories, the official Laboratory for the California Horse Racing Board, that the post race urine sample #GG13766, taken from the horse **MOOSE HIGH**, second place finisher in the fifth race at Golden Gate Fields on March 1, 2012, contained the prohibited substance 2-(1-Hydroxyethyl) promazine, a metabolite of Acepromazine, in excess of the permitted level, 318 ng/ml (Class 3), it is hereby ordered that MOOSE HIGH be disqualified from all purse monies earned and deemed unplaced, in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies (\$1,720.00) earned or awarded to owner William L. Hedrick, trainer Sheldon W. Paldanius and jockey Barrington Harvey be returned to the Paymaster of Purses for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The revised order of finish is as follows:

2nd - DR. JJ
 3rd - YORKVILLE KID
 4th - MY CHARMING CHANCE
 5th - AMERICA'S KID

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1956 (Race Declared Official), this ruling shall not affect the pari-mutuel payoffs.

Trainer **SHELDON W. PALDANIUS**, who started the horse MOOSE HIGH, second place finisher in the fifth race on March 1, 2012, is suspended thirty (30) days, July 11, 2012 through August 9, 2012, and fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843 (a) & (d) (Medication, Drugs and Other Substances) and #1844 (e) (1) (Authorized Medication: 2- (1-Hydroxyethyl) promazine, a metabolite of Acepromazine, in excess of permitted level – 318 ng/ml [Class 3]).

During the term of this suspension, all licenses and license privileges of SHELDON W. PALDANIUS are suspended and pursuant to California Horse Racing Board rule #1958 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above rulings were issued following Friday's formal hearing. The disqualification of the horse MOOSE HIGH was mandated by rule and the penalty imposed on Paldanius was deemed appropriate and within the guidelines after considering the evidence and testimony presented.

07-08-12³ **FILM REVIEW / RULING NO. 13**

Jockeys **Anthony Ayala, Shyann Garcia, Alejandro Gomez** and **Jesus Velazquez** viewed the tapes of yesterday's races with the stewards. The first three riders listed above were called in for educational purposes while the Velazquez matter was a little more serious as he put other riders in tight quarters heading for the 3/8. Jesus was unable to offer an explanation that would shift the blame for the incident off his shoulders so the following ruling was issued:

Jockey **JESUS VELAZQUEZ**, who rode **MR. KINGOFHEROAD** in the eighth race at the Alameda County Fair (Pleasanton) on Saturday, July 7, 2012, is suspended three (3) racing days (July 15, 19 and 20, 2012) for altering course without sufficient clearance around the far turn and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-08-12⁴ **JOCKEY OBJECTION – Second Race – NO CHANGE**

The stewards conducted a review of the second race at the behest of jockey Jesus Velazquez aboard the show horse, #5 RED DEPUTY, who lodged a claim of foul against the winner, #6 UNCLE ENROY, ridden by Julien Couton. Velazquez alleged interference in the stretch drive stating that the winner drifted in and took his path. After a thorough review the stewards dismissed the claim of foul.

Tapes showed that it was Velazquez who caused his own problems by letting his mount drift out behind UNCLE ENROY. The objection bordered on frivolous and Velazquez will meet with the stewards on Thursday in Sacramento.

07-08-12⁵ **LATE SCRATCH – Fifth Race – REFUND**

#8 RULLOKE, trained by W. R. Whitehouse, was scratched by the stewards after the horse escaped from the paddock while being saddled, ran down the track, jumped the outside rail and returned to the barn area. The refund was \$1,103.54. No report yet on the fugitive's condition.

07-08-12⁶ **LATE SCRATCH – Eighth Race – REFUND**
 #2 KAREN'S GOOD BOY, trained by Don Roberson, was scratched on the advice of Dr. Sporer as the field neared the starting gate when she diagnosed the horse as off on the right front. On Vet's list. The refund amounted to \$6,798.74.

07-08-12⁷ **LATE SCRATCH – Ninth Race – REFUND**
 #1 AMERICA'S KID, trained by Humberto Loma, was scratched by the stewards minutes before post time after Dr. Sporer reported the horse failed to warm up properly. On Vet's List. \$17,972.60 was returned to the public.
