Scratches for Wednesday's opening day were conducted at 10:00 a.m. There was one declaration and six jockey changes.

Tuesday10-02-07¹**ENTRIES / SCRATCHES**

Stewards **Kim Sawyer** and **Paul Nicolo** were on duty to oversee entries, scratches and were available for the approval of licensing.

Scratch time for Thursday was conducted at 10:00 a.m. There was one declaration and five jockey changes.

10-03-07¹ **SCRATCHES FOR FRIDAY**

Friday’s scratches were conducted at 10:00 a.m. There was one declaration and three jockey changes.

10-03-07² **JOCKEYS’ MEETING**

The stewards met with the jockey colony in the Jockeys’ Room for the start of the meeting. Many jockeys were present. Among the topics discussed were signing in, safe riding and horse welfare.

The stewards advised the jockeys of an open door policy with the stewards if they have any complaints or concerns that need to be addressed.

10-03-07³ **TRAINER OBJECTION – NO CHANGE – Third Race (350 yards)**

The objection sign was posted upon receiving a phone call from trainer **BRET LAYNE**, the trainer of the #5 horse DASH DECISION (5th). Trainer **LAYNE** lodged a claim of foul against #4 STRAW FLYING SNEAKERS (3rd, Daniel Boag) for possible interference just inside the 1/16 pole.

After review of the films and speaking with the trainer and patrol judge, the stewards made a unanimous decision that there would be no change. The films show that the #5 (Jockey Otto Arriaga) caused his own problem. While under the whip, #5 drifted in and bumped the back end of the #4 horse, tipping the #4 back into #5.

10-03-07⁴ **SMOOTH SAILING**

Beside the trainer objection in the third race, the other eight races on the card were completed without noteworthy incident.

INQUIRY – ACCIDENT – NO CHANGE – Fourth Race (Report Attached)

The stewards posted the inquiry sign following the running of the fourth race (Thoroughbreds – 5 ½ furlongs) to review an incident just inside the 1/16 pole. Involved was the #4 horse DEMEO AND DEMEO (Jockey Alvaro Rojas).

#4 went wrong just inside the 1/16 pole, falling and unseating the rider. The rider got up but was transported to first aid. He was taken off his remaining mounts because of a bruised shoulder. The horse was euthanized on the track as a result of her injuries.

After reviewing the tape replays, no change was made as the stewards unanimously agreed the filly was by herself when she fell and was not bothered by any other horse.

JOCKEYS APPEAR

Jockey **Alejandro Luna** appeared to discuss questionable riding in the second race on the card (Quarter Horse – 350 yards). Luna's mount was in the lead just inside the 1/16 pole and under a left handed whip drifted out in front of the second place finisher. While Luna was in the clear, he was cautioned that he needs to maintain a straight course. Mr. Luna acknowledged the error and said he will make a better effort in the future.

Jockey **Jesus Arriaga** appeared to discuss questionable riding in the second race on the card (Quarter Horse – 350 yards). Arriaga's mount broke in leaving the gate. He was warned that he needs to make a better effort to take hold of his mount sooner, and maintain a straight course.

10-05-07¹ **SCRATCHES AND CHANGES FOR SUNDAY**

Sunday’s scratches were conducted at 10:00 a.m. There was one scratch and two jockey changes.

10-05-07² **INQUIRY – NO CHANGE – Third Race**

The stewards posted the inquiry sign after the running of the third race (Thoroughbred – 5 furlongs). The #3 horse, SMART OLIVIA, unseated the rider (Jockey Jorge Ayarza) out of the gate.

After review of the films, the stewards unanimously determined there would be no change. The films show #3 SMART OLIVIA break inward and the #1 FRANCESCAS REDROSE (Jockey Otto Arriaga) ducked out sharply. The resulting collision caused the rider of #3 (Jockey Jorge Ayarza) to lose his balance and become unseated.

10-05-07³ **INQUIRY – DISQUALIFICATION – Sixth Race**

The inquiry sign was immediately posted after the running of the sixth race (Thoroughbred – 6 furlongs) to review an incident that occurred in the stretch run. Involved were #3 TORMENTO DE ORO (2nd, Jockey Sergio Ruiz) and #9 MARYSLANETAFAME (5th, Jockey Victor Navarro).

After review of the tape replay and speaking with the patrol judge and both riders involved, the stewards unanimously agreed that the #3 TORMENTO DE ORO (Jockey Sergio Ruiz), under right handed urging drifted down in front of the #9 MARYSLANETAFAME (Jockey Victor Navarro) taking his path. As a result, the #3 (Jockey Sergio Ruiz) caused #9 (Jockey Victor Navarro) to steady and cost him the chance of a better placing. The #3 was disqualified and placed behind the #9.

10-06-07¹ **SCRATCHES AND CHANGES FOR MONDAY**

Scratches for Monday were conducted at 10:00 a.m. There were no declarations and one jockey change.

10-06-07² **FILM REVIEW**

Jockey Robert Boyce appeared before the Stewards to review questionable ride in the first race on Friday, October 5, 2007. While jockey Boyce was in the clear, he drifted down in front of another rider. He was advised to stay straight by using the reins to steer, not the whip.

Mr. Boyce agreed and indicated he will make a better effort in the future.

10-06-07³ **NEW WORLD RECORD**

A \$50,000 Match Race – Winner Takes All (Mules - 440 yards) was held as the fourth race. The winning Mule, **BAR JF HOT TICKET** set a new World Record of 24.55.

10-06-07⁴ **NO SHOW WAGERING**

The fifth race on the card had an entry “SANDYTIKI” with a morning line at even odds. The Racing Secretary received permission from the California Horse Racing Board to have no show wagering on this race.

After the final program returned from the printer, show wagering was not deleted from the header on race five. Management decided to go forward, they had the change repeatedly announced, listed on the crawl of the television and listed on the alpha board from the time the windows were opened for wagering.

When betting appeared for Race 5, the Stewards noticed they were taking show wagering. The Mutuel Manager was immediately notified and he declared he would remedy the situation. At approximately 15 minutes to post, all show wagering was cleared from the board. The announcer once again made the public aware by repeated broadcast. The total refund was \$5,127.40, of which \$751.00 was on track.

10-06-07⁵ **INQUIRY –DISQUALIFICATION – Tenth Race**

The stewards immediately posted the inquiry sign following the running of the tenth race (Thoroughbred – 6 furlongs) to review an incident inside the 1/16 pole. Involved were #7 SAY DUBAI BYE (1st, Jockey Jorge Ayarza), and #2 PRANCIN’ N DANCIN’ (3rd, Jockey Robert Boyce).

After reviewing the tape replays and speaking with the riders involved and patrol judge, the #7 SAY DUBAI BYE was disqualified from 1st to 3rd. The stewards unanimously agreed the #7 (Jockey Jorge Ayarza) allowed his mount to drift out in front of the #2 (Jockey Robert Boyce), causing the #2 horse to take up and costing him a chance at a better placing.

10-07-07² **FILM REVIEW**

Jockey **Carlos Villalobos** appeared to discuss questionable riding in the third race, Saturday, October 6, 2007 (Quarter Horses – 350 yards). He was warned that he needs to make a stronger effort to guide his horse when he drifted in. Jockey Villalobos acknowledged his error and stated he will do better.

Jockey **Sergio Ruiz** appeared before the stewards to review the films from Friday, October 5th, 2007. He was warned that he needs to make a better effort to maintain a straight course.

10-07-07³ **RULING NO. 1 – RUIZ**

Jockey **SERGIO RUIZ**, who rode **TORMENTO DE ORO** in the sixth race at The Big Fresno Fair on Friday, October 5, 2007, is suspended three (3) racing days (October 13, 14 and 17, 2007) for failure to maintain a straight course in the stretch and causing interference, resulting in the disqualification of his mount from second to fifth – a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Ruiz appeared before the Board of Stewards to review the films and admitted he made a mistake.

10-07-07⁴ **RULING NO. 2 - ARRIAGA**

Jockey **JESUS ARRIAGA** is fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) on Friday, October 5, 2007.

The above ruling was issued after the Board of Stewards determined the jockey had no legitimate reason for missing his mount.

10-07-07⁵ **RULING NO. 3 - AYARZA**

Jockey **JORGE L. AYARZA**, who rode **SAY DUBAI BYE** in the tenth race at The Big Fresno Fair on Saturday, October 6, 2007, is suspended three (3) racing days (October 14, 17 and 18, 2007) for failure to maintain a straight course in the stretch and causing interference, resulting in the disqualification of his mount from first to third – a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Ayarza appeared to review the films with the Board of stewards. Mr. Ayarza indicated he would make a better effort in the future.

10-07-07⁶ **INQUIRY – NO CHANGE – Fourth Race**

The stewards posted the inquiry sign after the running of the fourth race (Thoroughbred – 5 ½ furlongs). The #1 horse, SEA TOPPER (1st, Jockey Jorge Ayarza), drifted out and crossed in front of the #3 horse EXPLOITED DREAM (3rd, Jockey Modesto Linares).

After review of the films, and speaking with the patrol judge and riders involved, the stewards unanimously determined there would be no change. The #1 was in the clear and did not affect the order of finish or cost the #3 a better placing.

Monday10-08-07¹**SCRATCHES AND CHANGES FOR THURSDAY**

Scratch time was conducted promptly at 10:00 a.m. There was one declaration and three jockey changes.

10-08-07²**FILM REVIEW**

Jockey **Jorge Ayarza** appeared to discuss questionable riding in the fourth race, Sunday, October 7, 2007 (Thoroughbred – 5 ½ furlongs) resulting from a stewards' inquiry. By majority vote, no penalty was given, as it appeared Ayarza tried to correct himself after his horse drifted out. However, the jockey behind him quickly moved to the inside such that Ayarza cut in front of him again when moving back into his lane. He was strenuously advised that he would be penalized if he continues to ride sloppy. Steward Nicolo dissented, believing the rider should have received a penalty for sloppy riding.

Jockey **Jesus Arriaga** appeared before the stewards to review the films from the second race on Sunday, October 7, 2007. The stewards advised him that the jockeys need to take care of each other. Arriaga was told he should get in the habit of looking before dropping down into the turn, even if he is in the clear. He agreed and will do better.

10-08-07³**RULING NO. 4 – ALFEREZ**

Jockey **JOSE ALFEREZ** is fined the sum of one hundred dollars (\$100.00)* for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) on Sunday, October 7, 2007.

The above ruling was issued after Mr. Alferéz could not provide a good reason to the stewards for not showing up for his mount.

10-08-07⁴**HEARING COFFEE (CASE #07SW0080)**

Trainer **Candice Coffee** appeared before the Board of Stewards concerning the above referenced complaint. Ms. Coffee waived her right to counsel and stated she was ready to proceed informally. Present were stewards Nicolo, Peluso and Sawyer.

Trainer Coffee stated that she accepts full responsibility. However, she believed her practicing veterinarian inaccurately treated the horse.

After reviewing documentary and the testimonial evidence, the hearing was adjourned for decision.

10-08-07⁵**RULING NO. 5 – COFFEE**

Trainer **CANDICE COFFEE**, who started the mule **GAMBLERS CASH** in the first race at the Los Angeles County Fair on September 15, 2007, is fined the sum of four hundred dollars (\$400.00) pursuant to California Horse Racing Board rule #1888 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances: Flunixin – in excess of permitted level – 474 ng/ml [Class VI]).

The above ruling was issued after Trainer Coffee agreed to accept full responsibility for the error.
10-08-07⁶ **TOTE SYSTEM LOST HOST**

Following the running of the fifth race on the card, the Tote System lost contact with the host (QDC). The problem occurred in some, but not all, of the Northern California racing sites. The post for the sixth race was delayed approximately fifteen minutes. (See attached letter)
