10-08-09² **STEWARDS MEET WITH JOCKEY COLONY**
The stewards met with the jockeys today and discussed various topics and procedures to insure the meeting goes smoothly and safely.

10-08-09³ **STEWARDS' INQUIRY – First Race (Mules) – DISQUALIFICATION**
The stewards posted the inquiry sign to evaluate the mid point of this 350 yard dash with respect to #8 **BAR JF PARTY GIRL** (3rd, **Genaro Tapia**) and #9 **BLINKIE** (7th, Macario Rodriguez). After a thorough review the stewards disqualified **BAR JF PARTY GIRL** from third and placed her seventh behind **BLINKIE**.

Tapes showed that **BAR JF PARTY GIRL** bore out sharply midway through the race, took **BLINKIE** off his path and, in the unanimous opinion of the stewards, caused that mule to lose the opportunity at a better placing.

#7 **HELMSMAN HANK**, trained by Charles Hiatt, was scratched as the field was warming up on the recommendation of track veterinarian Shan Collette, D.V.M. who reported the horse was off in the left front. The refund was \$5,060.82.
#2 **ELOY** was scratched by the stewards after the horse acted up in the starting gate and injured himself. Dr. Collette recommended the scratch after examining the W. R. Whitehouse trainee. The refund amounted to \$9,794.78.

LEWIS RE-INSTATEMENT (Case #09GG269)

Assistant Trainer **BILLY G. LEWIS, JR.** appeared this morning seeking re-instatement of his license privileges which had been suspended for thirty days by the Ferndale stewards in ruling #08, dated August 22, 2009.

Per the ruling, Lewis was required to show proof of completion of a substance abuse rehabilitation program acceptable to the stewards and sign a testing agreement with the California Horse Racing Board. Lewis demonstrated he was in compliance with both stipulations and also offered a contract with the Winners Foundation that requires him to attend four AA meetings a week through February 23, 2010.

Lewis was admonished that he will remain on probation through the term of his license (08-31-2010) and any failure to maintain his sobriety would result in action against his license privileges.

FILM REVIEWS

Jockeys **GENARO TAPIA** and **MICHAEL MARTINEZ** appeared in the stewards' office to review tapes of yesterday's races in which their mounts created unsafe riding conditions. Neither rider could convince the stewards that they exerted sufficient effort to correct their horses' errant path and the following rulings were issued.

Ruling #1 Jockey **GENARO TAPIA**, who rode **BAR JF PARTY GIRL** in the first race at the Big Fresno Fair (Fresno) on Thursday, October 8, 2009, is suspended three (3) racing days (October 16, 17 and 18, 2009) for failure to make the proper effort to maintain a straight course in the stretch resulting in the disqualification of his mount from third to seventh; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

Ruling #2 Jockey **MICHAEL MARTINEZ**, who rode **PALI CAT** in the seventh race at the Big Fresno Fair (Fresno) on Thursday, October 8, 2009, is suspended three (3) racing days (October 16, 17 and 18, 2009) for altering course without sufficient clearance and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

10-09-09⁴ **HINDS HEARING** (Case #09SW-0137)
The stewards conducted a formal hearing for Tulare County Fair CEO **Geoff Hinds**, who was alleged to have violated California Horse Racing Board rule #2057 (Initial Application and Approval of a Simulcast Facility) (g) (6, 7, and 8) in a complaint filed by Senior Supervising Investigator Martin Snezek, II. The charges stemmed from an inspection conducted by Snezek at the Tulare County facility on August 12, 2009 which allegedly found that a security guard was not present while the site was conducting simulcast wagering.

Testimony was presented and evidence was collected relevant to the complaint. The stewards will take the matter under submission and a decision will be rendered in the near future.

10-09-09⁵ **LATE SCRATCH – Second Race – REFUND**
#5 MADRIGALS MAGIC, trained by Rene Glass, was scratched during the warm up on the recommendation of Dr. Collette after he reported the filly was not traveling well in the rear. On Vet's List. The refund was \$5,119.84.

10-09-09⁶ **STEWARDS' INQUIRY – ACCIDENT – Third Race – NO CHANGE**
The stewards posted the inquiry sign to review an accident just inside the 1/16 where #2 **SERENE SERENA**, with Joy Scott in the saddle, collided with the inside rail and dislodged the jockey. After a thorough review the stewards affirmed the order of finish on the tote board.

Tapes show that through the lane Scott was urging a tiring filly who changed leads passing the 1/16 and ducked inward, making contact with the inside rail. No other horses were involved. Scott walked away unscathed and SERENE SERENA sustained minor lacerations to her left hind leg.

10-09-09⁷ **STEWARDS' INQUIRY – Ninth Race – NO CHANGE**
The stewards posted the inquiry sign to evaluate an incident at the 3/8 between #8 COME BACK NATIVE (6th, Diego Sanchez), #6 DEPUTY PRIZEW (7th, Barrington Harvey) and #4 A K RACER (8th, Catalino Martinez) after DEPUTY PRIZE steadied at the top of the far turn. After a thorough review the stewards let the order of finish stand.

Tapes showed close quarters between the three horses with DEPUTY PRIZE between two others. Some jostling occurred and Harvey took his mount back to avoid further pressure.

10-10-09² **HEARING CONTINUED** (Case #09SW-0137)

A formal hearing scheduled for this morning into a complaint filed against Sonoma County Fair Association and Fair Manager **Tawny Tesconi** was continued by the stewards when concerns arose over due process issues. The charges alleged violation of California Horse Racing Board rules #1629 (Penalty for Late Declaration) and #1530 (Cases Not Covered by Rules and Regulations) on August 9, 2009. The hearing will be rescheduled in the near future.

10-10-09³ **STEWARDS' INQUIRY – Second Race – DISQUALIFICATION**

The stewards posted the inquiry sign to review the start of #6 **CHECKTHISMEMO** ridden by **Eulices Gomez**. After a thorough review the stewards disqualified CHECKTHISMEMO from ninth and placed him tenth. Tapes showed that CHECKTHISMEMO broke in severely, bumping and impeding both #5 SILVER EGO (8th, Dihigi Gladney) and #4 CASHMEIN BOBBIE (10th, Sergio Ruiz). SILVER EGO rallied to out finish CHECKTHISMEMO but CASHMEIN BOBBIE did not and, in the stewards' opinion, was eliminated from contention due to the contact.

Jockey **Sergio Ruiz** returned to the saddling area and was attended to by the paramedics for pain resulting from the contact between the horses.

10-11-09² **HINDS DECISION – RULING NO. 3**

Tulare County Chief Executive Officer **GEOFF R. HINDS** is suspended thirty (30) days and fined the sum of five hundred dollars (\$500.00)* for failure to provide security personnel within the simulcast wagering facility on August 12, 2009, which constitutes a violation of California Horse Racing Board rule #2057 (G) (8) (Initial Application and Approval of Simulcast Facility).

For cause, the thirty (30) day suspension is stayed provided that neither Geoff R. Hinds nor the Tulare County Fair is found to be in violation of CHRB simulcast regulations for a period of one year from the date of this ruling. Should a simulcast regulation violation be proven the stay of the thirty (30) day suspension shall be rescinded and Mr. Hinds will be required to serve the penalty.

The above ruling was issued following Friday's formal hearing. The stewards considered the evidence and testimony presented and felt the above penalty was appropriate.

10-11-09³ **JOCKEY OBJECTION – Third Race – NO CHANGE**

The jockey aboard the place horse, #5 CALL ME LITTE ROSE, Rodrigo Maldonado, lodged a claim of foul against the winner #7 DONE DEAL DARLIN with Sergio Ruiz in the saddle. Rodrigo felt he was impeded shortly after the start of this 400 yard event. After a thorough review the stewards dismissed the claim of foul.

Tapes showed that Ruiz allowed his mount to drift in and make contact with CALL ME LITTLE ROSE but the contact was minor and the margin at the finish showed the incident did not affect the placings. Ruiz will meet with the stewards in the morning to review the race.

10-11-09⁴ **STEWARDS' INQUIRY – Tenth Race – DISQUALIFICATION**

The stewards posted the inquiry sign to review an incident near the 5/8 which saw the show horse #2 FLAMING BULLET, Alex Bisonso up, clip heels with the winner, #3 **DON ELIAS M.** ridden by **Dihigi Gladney**. After a thorough review the stewards disqualified DON ELIAS M. from first and placed him third behind FLAMING BULLET.

Tapes showed that DON ELIAS M. drifted in toward the rail as the field approached the 5/8 and took the path of FLAMING BULLET causing the latter to clip heels and, in the stewards' opinion, costing FLAMING BULLET the opportunity at a better placing.

Jockey **DIHIGI GLADNEY** is fined the sum of one hundred dollars (\$100.00) for failure to ride his mount in the first race on Saturday, October 10, 2009; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The foregoing ruling was issued after Dihigi related that he thought post time was later than it actually was causing him to arrive too late to ride the first.

10-12-09⁴ **FILM REVIEW**

The stewards reviewed the tapes of yesterday's tenth race in which **Dihigi Gladney's** mount was disqualified from first to third. Gladney communicated telephonically and jockey Eulices Gomez appeared in person on Dihigi's behalf. Neither rider was able to convince the stewards that Gladney was not at fault for allowing his mount to drift in and take the path of FLAMING BULLET who clipped heels with DON ELIAS M. on the backstretch. The following ruling was issued:

NO. 5 Jockey **DIHIGI GLADNEY**, who rode **DON ELIAS M.** in the tenth race at the Big Fresno Fair (Fresno) on Sunday, October 11, 2009, is suspended three (3) racing days (October 21, 22 and 23, 2009) for failure to make the proper effort to maintain a straight course shortly after the start and causing interference resulting in the disqualification of his mount from first to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

10-12-09⁵ **JOCKEY OBJECTION – Seventh Race – NO CHANGE**

The stewards posted the objection sign at the request of **Eulices Gomez** (3rd, #10 SONNY'S TORNADO) who lodged a claim of foul against the winner, #7 OHSOKOOL, with Michael Martinez in the irons. After a thorough review the stewards dismissed the claim of foul.

Tapes showed that OHSOKOOL drifted out inside the 1/8 making slight contact with SONNY'S TORNADO and Gomez steadied briefly. In the stewards opinion the incident did not affect the placings but Martinez will view the tapes of the race with the stewards on Thursday.
