Proceedings of the Board of Stewards for the period of Monday, September 17, 2007 through Sunday, September 23, 2007. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

The race office was open this morning taking entries for Friday September 21, 2007.

At the draw conducted this morning, there were one hundred seventeen (117) horses drawn into fourteen (14) races. Scratch time will be at 9:00 a.m. tomorrow (September 19, 2007).

Due to track re-surfacing, racing will be conducted on only two (2) days this week, Friday September 21, 2007 and Saturday September 22, 2007.

**Entries for Qualifying Races**

The race office was open today taking entries for the qualifying races to be conducted at 4:00 p.m. today. Forty-three (43) horses were scheduled to compete in seven (7) races.

09/21/07 (2)

**Qualifying Races**

Seven (7) qualifying races were held beginning at 4:00 p.m., under the supervision of Stewards Baker and Meyers. In these events thirty-one (31) horses were successful in their qualifying efforts.

**Second Race – Driver Sanction**

Immediately after the finish of Race #2, the driver of #3 “Metekas” (Rick Plano) was contacted by the stewards and questioned concerning the stretch drive, during which Driver Plano was observed with his right foot out of the stirrup. Driver Plano affirmed the stewards’ observation. Driver Plano was assessed a fifty-dollar (\$50) fine. See Ruling #36.

**Third Race – Driver Review**

After the conclusion of Race #3 Driver Scott U’Ren was contacted by the stewards and was told to appear in the Stewards’ Office tomorrow, September 22, 2007 at 4:00 p.m. to review films of the final quarter of this event, specifically his actions which followed a break in stride by his horse #8 “A Dane’s Babe”, who finished tenth (10<sup>th</sup>) and last in the event. More to follow.

09/21/07 (5) **Fifth Race – Refusal- Pari-Mutual Refund**

When the starter called the field ‘to the gate’, to begin Race #5, the pre-race favorite #5 “Cautious Spirit N”, driven by Rick Plano, refused to hit ‘his gait’ and attempted to veer sharply to his right. The starter proceeded with the start and the stewards posted the ‘inquiry’ sign.

At the conclusion of the race, after communication with Starter Bill Vallandingham and Driver Rick Plano, the stewards concluded that #5 “Cautious Spirit N” had refused to come to the gate, thus did not receive a fair start and thus ordered a refund of all pari-mutuel wagers. The total refund amount was \$25,499, which includes the ‘on track’ refund amount of \$1325.

Subsequently, #5 “Cautious Spirit N” was placed on the ‘Steward’s List’ for a period of thirty (30) days and was required to qualify twice before being allowed to participate in any pari-mutuel event. The horse will be allowed to ‘qualify’ during his time on the Steward’s List. Driver/Trainer Plano was advised that any further incidents of this nature would result in the horse being ‘barred’ from further participation at this meet.

Driver Plano was held blameless in this situation.

09/21/07 (6) **Fifth Race – Claim**

#6 “Interview Hanover” was claimed from Gilbert Herrera for \$5,000. The owner will be Drew Anderson and the trainer will be Bob Johnson.

09/21/07 (7) **Eighth Race – Inquiry/No Change**

During the stretch in this event, #3 “Can’t Fault Sam”, driven by Tim Maier, was observed making a very brief ‘break in stride’ mid stretch. After reviewing films, the stewards concluded that both the horse and Driver Maier had ‘complied’ with the breaking rule and no change was warranted.

09/21/07 (8) **Ninth Race – Claim**

#9 “Only In California” was claimed from Kennedy and Cynthia Lindsey for \$5,850. The owner will be Frank Petrelli and Bardonia Stables and the trainer will be Frank Petrelli.

09/21/07 (9) **Twelfth Race – Inquiry/Placing**

During the stretch drive #4 “Anns Nestegg”, driven by Luke Plano, broke stride and continued ‘off stride’ through the finish. After reviewing films the stewards concluded that #3 “Chicote” was the only remaining participant that had a reasonable opportunity to finish ahead of #4 because the remainder of the field had taken themselves out of contention by earlier breaks in stride. Therefore, #4 was disqualified and placed behind #2 in the official order of finish.

Driver Luke Plano was held blameless in this situation.

09/21/07 (10) **Thirteenth Race – Inquiry/Disqualification**

During the stretch drive #1 “Rompaway Vincent” made a ‘break in stride’ that continued through the finish. The stewards immediately posted the ‘inquiry’ sign and, after reviewing films, concluded that #1 was in violation of the ‘breaking rule’ in that #1:

- Made an extended break (in excess of 1/16 mile)
- Failed to lose ground while on a break

Additionally, #1 was ‘lapped on’ by #7 “Green Grass N” at the finish.

Subsequently, the stewards disqualified #1, who finished fourth (4<sup>th</sup>) and placed him eighth (8<sup>th</sup>), as it was the opinion of the stewards that #'s 2,3,4 and 7 would have had an opportunity for a ‘better placing’ had #1 not had multiple violations of the ‘breaking rule’.

Driver Gilbert Herrera was held blameless in this incident.

Upon announcement of the official order of finish, the Trainer of #1 “Rompaway Vincent”, R. Bertrand, contacted the stewards by telephone and was quite vocal in expressing his disagreement with the stewards’ decision. Mr. Bertrand was invited to the stewards’ office tomorrow, September 22, 2007 to review films of the race.

09/22/07 (2) **Film Review – Scott U'Ren**

Driver Scott U'Ren attended with the stewards to review films of Race #3 from the September 21<sup>st</sup> card. Past the 3/4 pole, Driver U'Ren's mount #8 "A Dane's Babe" broke stride and Driver U'Ren was observed whipping the horse while on a break and again after the horse came back to it's proper gait.

Driver U'Ren was very forthcoming concerning allowing his emotions to get the better of him and agreed this was not proper.

The stewards unanimously agreed that in light of Mr. U'Ren's clean record and candid attitude that a warning was in order.

Mr. U'Ren seemed appreciative of this result and promised to avoid any re-occurrence.
