Proceedings of the Board of Stewards for the period of Monday, May 19, 2008 through Sunday, May 25, 2008. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

Monday

05/19/08 (1) **Draw for Thursday 05/22/08**

Entries were taken and a draw held at 11:00 a.m. for the program to be raced on Thursday May 22, 2008.

Seventy-three (73) head drew in to compete in ten (10) races.

Scratch time will be Tuesday May 20, 2008 at 9:00 a.m.

05/19/08 (2) **Dark Day**

05/20/08 (1) **Scratch Time for Thursday 05/22/08**

At scratch time there were eleven (11) driver changes and no scratches.

05/20/08 (2) **Draw for Friday 05/23/08**

Entries were taken and a draw conducted at 12:00 noon for the program to be raced on Friday May 22, 2008.

One hundred eight (108) horses drew in to thirteen (13) events.

Scratch time will be Wednesday May 21, 2008 at 9:00 a.m.

Wednesday

05/21/08 (1) **Scratch Time for Friday 05/23/08**

At scratch time there were ten (10) driver changes, one (1) trainer correction and no scratches.

05/21/08 (2) **Qualifying Draw for Thursday 05/22/08**

Entries were taken and a qualifying sheet produced for five (5) qualifying races with thirty-three (33) horses participating. These races are scheduled for Thursday May 22, 2008 at 4:30 p.m.

05/21/08 (3) **Draw for Saturday 05/24/08**

Entries were taken and a draw conducted for Saturday's thirteen (13) race card, with ninety-two (92) horses scheduled to compete. Scratch time was 'at the draw' with two (2) driver changes the only revisions.

05/21/08 (4) **3 Year Old California Sire Stakes Finals**

There are four (4) 3 Year-Old California Sire Stakes scheduled on Saturday's card with twenty-seven (27) Cal Bred horses scheduled to compete for a purse of Twenty-Five Thousand (\$25,000) Dollars each division.

05/22/08 (1) **Qualifying Races**

Five (5) qualifying races were held today commencing at 4:30 p.m. under the supervision of Stewards McLaren and Meyers. In these events twenty (20) of thirty-one (31) competitors were successful in their qualifying efforts.

05/22/08 (2) **Owner Juan Pablo Ramirez Ruling [Ref. 05/06/08 (1)]**

As a result of a formal hearing held May 16, 2008 and due deliberation, the stewards issued the following Ruling #32 in response to California Horse Racing Board Complaint #08SW-0057:

Ruling # 32

Owner Juan Pablo Ramirez is hereby Suspended for One Hundred Eighty (180) Days commencing Monday, May 26, 2008 through Friday, November 21, 2008 for violation of California Horse Racing Board Rule #1890 (Possession of Contraband – Multiple Syringes, Needles and Vials of Therapeutic Medications While on the Premises of Cal-Expo).

It is further ordered that Owner Juan Pablo Ramirez be placed on Probation for the term of his license for any similar violations.

During the term of suspension, all license privileges of Juan Pablo Ramirez are suspended and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards to Suspend or Fine), subject is denied access to all premises in this jurisdiction.

05/22/08 (3) **Race #5 – Inquiry/Change in Order**

The stewards flashed the ‘inquiry’ sign at the conclusion of the event (a NWI trot) to review several instances of horses ‘breaking stride’ in order to ensure that there were no rule violations. “PJ’s Web” (Steve Wiseman) was found to be in violation of the breaking rule ‘Lapped on Break’. Thus #6 “Ray’s Pride” (Robert Richie), who finished seventh (7th) was placed sixth (6th) while #8 finished sixth (6th) was placed seventh (7th).

05/22/08 (4) **Race #8 – Inquiry/No Change**

The inquiry sign was lit after Race #8 to investigate an incident approaching the 1/2 mile pole involving #2 “Larry Horse” (Luke Plano), #4 “Pirate Hall” (Steve Wiseman) and #8 “Special Edition N” (James Lackey) when the three were in very close quarters. After reviewing films and speaking with the drivers involved, the stewards unanimously concluded there were no rule violations, thus no change.

05/24/08 (1) **Race #3 – Inquiry/No Change**
 The 'inquiry' sign was lit following Race #3 when #1 "London Calling" (Tim Maier), #2 "Mighty Kicker" (Ed Hensley) and #3 "Phipps" (Lou Pena) where all 'offstride' at the wire. After viewing films, the stewards determined that all competitors complied with the 'breaking rule'. Thus no change.

05/24/08 (2) **Race #4 – Inquiry/Disqualification**
 The 'inquiry' sign was lit following Race #4 to investigate an incident in the first turn when several horses went 'off stride' immediately after the start. Of special interest was #1 "Hydropedes" (Lou Pena), who went inside several pylons and was completely off the course. After viewing films, the stewards unanimously voted to disqualify #1 and place him seventh (7th). Lou Pena contacted the stewards by telephone and expressed his dissatisfaction with the decision.
