A hearing was held today for former Exercise Rider Rodney "Jay" Browning. Browning was refused at Fresno while under probation, for a drug conviction in 2003. Browning produced documentation that he is free of supervision from the courts.

Browning was deemed eligible for an exercise rider's license with a few stipulations: A one hundred dollar (\$100) fine for a pending complaint of working without a license, a signed testing agreement, and he shall lose all license privileges if caught shoeing any horses before he passes the farrier's test.

Questions arose concerning the validity of the complaint and Tessier and his helper Minister Bobbi Jean Melbourn were given an opportunity to continue the hearing in order to gain more information and witnesses. Case continued.

06/07/08 (2) **First Race – Inquiry/Accident – No Change**

The inquiry sign was posted to review an accident after the first quarter involving three (3) horses, #1A “Eicarl’s Colonel D” (Lemoyne Svendsen, 6th), #4 “Hanover D G N” (James Lackey, DNF). After review, it was determined that #5 caused the accident by getting his front legs tangled in the sulky of #4 from behind. All drivers and horses were checked and reported uninjured, although Jim Lackey took himself off later in the card after reporting stiffness setting in. The culprit did not finish, so no change was ordered. Driver Shaw was ordered to the Stewards.

06/07/08 (3) **Seventh Race – Inquiry/No Change**

The stewards posted the inquiry sign to review an incident in the first turn, involving several horses. After review, it was determined that all interference was caused by #2 “Tu Charming” (Tim Maier), who finished eighth (last). No change.
