- 06/13/08 (1) **Steward's Replacement**
Steward Grant Baker replaced Steward Wayne Oke again this evening.
- 06/13/08 (2) **Shaw Ruling**
At 4:00 p.m. Driver Sabrina Shaw came to the steward's office to discuss Race #1 on Saturday, June 7, 2008.
- The stewards explained that they felt that it was her responsibility to keep control of her horse. Going past the 1/4 pole, her horse, #5 "Pandoori", stepped into the bike of "Hanover D G N", driven by James Lackey, causing both horses to not finish the race. She felt that it wasn't her fault, but rather that Mr. Lackey was at fault.
- After discussion, the stewards suspended her three (3) days from driving, June 19th, 20th and 21st 2008.
- 06/13/08 (3) **Seventh Race – Inquiry/Fine**
The stewards hung the inquiry sign concerning #6 "Edgar Allen Coe", driven by James Lackey, for a possible violation of the pylon rule. After reviewing the tapes the stewards left the horse up, but fined the driver James Lackey one hundred (\$100) dollars for going inside one (1) pylon in the turn.
- 06/13/08 (4) **Tenth Race – Inquiry/Change of Finish Order**
There was a general inquiry by the stewards involving the breaking horses at the top of the stretch. After review, the #1 "Clambake", who finished seventh (7th), was placed sixth (6th) and #4 "Catmando", who finished sixth (6th), was placed seventh (7th) for interference while on a break.
- 06/13/08 (5) **Driver Excused**
After the eleventh race Driver Lemoyne Svendsen asked to be excused from his twelfth and thirteenth race drives. His back was very sore. He was excused and was required to get a doctor's clearance for Saturday night.
