Proceedings of the Board of Stewards for the period of Thursday, September 11, 2008 through Sunday, September 21, 2008. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

**Qualifying Entries and Draw**

Entries were taken and sheets produced for qualifying races to be conducted on Friday September 12, 2008 and Saturday September 13, 2008.

On Friday there will be one hundred (100) head participating in thirteen (13) races.

On Saturday there will be one hundred one (101) head participating in seventeen (17) races.

Post time each day is 11:00 a.m.

**Qualifying Races**

Thirteen (13) qualifying races were conducted with first post at 11:00 a.m.

These races were contested by ninety-nine (99) horses with ninety seven (97) head being successful in their qualifying effort.

09/13/08 (1) **Qualifying Races**

Seventeen (17) qualifying races were conducted with first post at 11:00 a.m.

These races were contested by ninety nine (99) horses with ninety (90) horses being successful in their qualifying effort.

The stewards were very impressed with the track condition, as witnessed by the performance of the horses during the past two day's qualifying events.

09/15/08 (1) **Entries and Draw for Thursday 09/18/08**

Due to the cancellation by Cal-Expo management of the first two (2) days of racing for the new meet (ostensibly due to track conditions, however qualifiers were held on both days over a track that was in excellent condition), entries were taken for Thursday's opening card. The entry box closed at 9:00 a.m.

The draw was held at 2:30 p.m. with fifty-eight (58) horses drawn to compete in eight (8) events.

Scratch time will be on Tuesday at 9:00 a.m.

Entries were taken and a draw conducted for Friday's card. The entry box closed at 9:00 a.m.

The draw was conducted at 11:00 a.m. with seventy nine (79) horses drawn to compete in eleven (11) races. Scratch time will be Wednesday at 9:00 a.m.

09/16/08 (2) **Request for Association Rule Change**

Cal-Expo management requested permission to change their rule concerning 'Trainer Entries'.

The old rule limited the number of trainer entries in these classes to 'two (2)'.

Cal-Expo wished to eliminate this restriction in order to afford the better horses at each gait more frequent racing opportunities.

After discussions with Executive Director Kirk Breed, permission was granted. A copy of the new rule is attached.

Additionally, Cal-Expo requested the California Horse Racing Board include standardbreds in the exemption granted to quarter horses in California Horse Racing Board Rule #1606(B).

A well attended meeting with a discussion of each official's responsibilities and a procedure developed for handling individual problems as they occur. An enthusiastic group, who appeared ready and eager for the upcoming meet.

09/18/08 (3) **Driver/Trainer Meeting**

A meeting was held in the driver's room at 5:00 p.m. today.

The purpose of the meeting was to re-familiarize those present with procedures and responsibilities for the entry of horses, paddock procedures and the actual contesting of the race. A well attended meeting with a lively exchange between the stewards and the licensees.

09/18/08 (4) **Seventh Race – Inquiry/Disqualification**

The inquiry sign was lit following Race #7 to investigate an incident in the first turn when eventual third (3<sup>rd</sup>) place finisher, #1 “Jam And Jelly” (Steve Wiseman), was observed inside multiple pylons in the first turn. After reviewing films, the stewards unanimously agreed to disqualify #1 and placed her seventh (7<sup>th</sup>) and last for violation of the pylon rule. Driver Steve Wiseman was ordered to film review.

Driver Steve Wiseman attended with the stewards to review Thursday's seventh race in which Driver Wiseman's horse was disqualified for violation of the 'pylon rule'. Driver Wiseman readily accepted responsibility for the violation and accepted the following penalty without complaint.

**Ruling # 03**

Driver Steve Wiseman, who drove “Jam And Jelly” in the Seventh Race on Thursday September 18, 2008, is hereby fined the sum of Two Hundred Dollars (\$200) for violation of California Horse Racing Board Rule #1721 (K)

(Driving Rules – Careless Driving – Raced Inside Multiple Pylons After the Start Resulting in a Disqualification – Unfair Advantage).

09/20/08 (1) **Qualifying Entries and Draw**

Entries were taken and a qualifying sheet produced for qualifying races to be held this afternoon at 4:30 p.m.

There will be thirty two (32) horses attempting to qualify in six (6) events.

09/20/08 (2) **Qualifying Races**

Six (6) qualifying races were held starting at 4:30 p.m. under the supervision of Stewards Baker and McLaren. In these events, twenty four (24) of thirty one (31) horses were successful in their qualifying efforts.

09/20/08 (3) **Fifth Race – Inquiry/Disqualification**

The inquiry sign was lit following Race #5 to investigate an incident in the first turn when #2 “Little Walter” (Gilbert Garcia-Herrera) made a break and caused #4 “Titan Seelster” (Steve Wiseman) to abruptly alter course and briefly ‘hook wheels’, causing #4 to break stride. After reviewing films, the stewards unanimously agreed to disqualify #4, who finished fifth (5<sup>th</sup>) and placed him sixth (6<sup>th</sup>) for ‘interference while on a break’.

- 09/20/08 (4) **Seventh Race – Driver Caution**  
 During the stretch drive in Race #7, #8 “Jill’s Sooter” (David Siegel) was observed moving to her right, forcing eventual race winner #3 “Nikoleta” (James Kennedy) to take evasive action. As #3 finished ahead of #8, there was no placing. Driver Siegel was ordered to film review.
- 09/20/08 (5) **Tenth Race – Claim**  
 #5 “Whitman” was claimed by K.C. Carvalho from Owen Eiler, Jr. for \$10,000. The new trainer will be Tom Wine.
- 09/20/08 (6) **Eleventh Race – Inquiry/No Change**  
 The inquiry sign was posted at the conclusion of Race #7 to investigate an incident past the 3/4 mile pole when #2 “S A Sunset”, the eventual second (2<sup>nd</sup>) place finisher, was observed striking a single pylon. After reviewing films, stewards felt there was not conclusive evidence that #2 had violated the pylon rule, thus no change.
