Proceedings of the Board of Stewards for the period of Monday, November 10, 2008 through Sunday, November 16, 2008. Steward Brent McLaren was the Reporting and Duty Steward for the enclosed period.

Monday

- 11/10/08 (1) **Entries for Thursday**
We had a good box today; one hundred twenty one (121) entries to fill thirteen (13) races with full fields.
- 11/10/08 (2) **Dark Day**

Tuesday

- 11/11/08 (1) **Scratch Time/Entries**
Scratch time for Thursday, November 13th took place at 9:00 a.m. today in the racing office. There were twelve (12) driver changes, with no scratches.
- Entries were taken in the racing office this morning for racing on Friday, November 14th. Fifteen (15) races were drawn for Friday's card. One hundred twenty five (125) horses are scheduled to start.
- Five (5) out of the fifteen (15) pari-mutuel races for November 15th were also drawn today.

11/12/08 (1) **Scratch Time for Friday**

There were a total of twenty one (21) driver corrections on the board. No scratches.

11/12/08 (2) **Draw**

We had a very good box; one hundred thirty six (136) entries to fill sixteen (16) races. Fifteen (15) pari-mutuel with one (1) non betting stakes race. Eleven (11) races finish the card for Saturday.

11/13/08 (1) **Scratch Time for Saturday**

We had eleven (11) driver corrections for Saturday, and one (1) scratch.

Because of an error in the race office, there was a re-draw of the thirteenth race for Saturday. The horse "Trisha Mae" should have drawn into the race because of eligibility date, but was left out. This was rectified early Thursday morning with all parties notified. The matter went off without a problem.

11/13/08 (2) **Qualifiers Draw**

There are twenty nine (29) entries to fill four (4) qualifying races to begin at 4:00 p.m. today.

11/13/08 (3) **Qualifying Results**

There were twenty two (22) horses that qualified out of twenty six (26) entries.

11/13/08 (4) **Driver Review**

Driver Rocky Stidham came in at 3:30 to watch the tenth race on November 8, 2008 concerning his drive on #4 "Noam N" past the half mile pole.

We showed him our concerns on the tape where he was very close to #5 "Barney Ryan", driven by Jason Ricco. He agreed and will be more observant.

11/13/08 (5) **Fourth Race – Inquiry**

The stewards hung the inquiry sign concerning the #2 horse "Mo Valley Stoner", driven by Lemoyne Svendsen, for a possible violation of the breaking rule in the stretch. After review, the stewards felt Mr. Svendsen complied with the rule. No changes were needed.

- 11/14/08 (1) **Second Race – Inquiry**
 The stewards hung a general inquiry concerning breaking horses around the 1/2 mile pole. No problems were seen.
- 11/14/08 (2) **Third Race – Inquiry/Disqualification**
 The stewards hung the inquiry sign concerning possible interference between #6 “Stanza”, driven by Steve Desomer, #7 “The Chazz Guy”, driven by Rocky Stidham and #8 “Gee Gee Cyril Lee”, driven by Luke Plano, after the start. The stewards disqualified #6 “Stanza” for interference with #7 “The Chazz Guy” and #8 “Gee Gee Cyril Lee”.

- 11/14/08 (3) **Ninth Race - Inquiry**
 The stewards hung an inquiry concerning possible interference between #7 “A Z Mutanto”, driven by Steve Wiseman and #5 “Mattreality”, driven by Lou Pena past the 3/4 pole. After reviewing the tapes, there was no change.

11/14/08 (4) **Fifteenth Race – Inquiry/Disqualification**

The stewards put up the inquiry concerning possible violation of the breaking rule by #7 “Cast British”, driven by Rocky Stidham and #8 “N V Warlord”, driven by Rick Plano. Both occurred in the stretch and past the wire. Both horses were placed behind the #5 horse, who finished seventh (7th).

Saturday11/15/08 (1) **Driver Review – Lemoyne Svendsen**

Driver Lemoyne Svendsen came into the steward’s office to watch Race #5 - #3 “Develish Donnie”, driven by Mr. Svendsen. The driver explained that his horse was on the left line, causing him to come off the rail in the stretch. The stewards understood the situation.

11/15/08 (2) **Driver Review – Steve Desomer**

Driver Steve Desomer came to the steward’s office to view the third race. After discussion with the stewards, Mr. Desomer agreed about his horse causing interference after the start. The following ruling was issued:

Ruling # 38

Driver Steve Desomer, who drove “Stanza” in the Third Race on Friday, November 14, 2008, is hereby fined the sum of Two Hundred Dollars (\$200) for violation of California Horse Racing Board Rule #1721 (I) (Driving Rules – Commit an Act Which Shall Impede the Progress of Another Horse – Resulting in a Disqualification).

Steward Wayne Oke was in dissent with the decision.

11/15/08 (3) **Second Race – Inquiry**

In the second race, an inquiry was hung by the stewards concerning #3 “Pacinello”, driven by Luke Plano, for breaking past the 3/4 pole. There was interference with #1A “Holme Invasion”, #4 “Hi Ho Legacy” and #5 “The deadliest catch”. No action was taken.

11/15/08 (4) **Fourteenth Race – Inquiry**

The stewards hung the inquiry sign concerning the breaking horse in the stretch. Race 14, #4 “Cam Diaz”, driven by Etienne Desomer, broke in the stretch. “Cam Diaz” didn’t finish, but did interfere with #5 “Silver Rocket”, driven by Gene Vallandingham and #7 “Speedy Feldy”, driven by Paul Welence. No action was taken.
