Driver Darren Lupul, who drove “Spinreel” in the 13th Race on Friday, October 15th, came to the steward’s office to discuss his drive. After review of the race, the stewards felt that the argument with Driver Lemoyne Svendsen during the running of the race was unprofessional. A One Hundred (\$100) Dollar fine was assessed.

10/16/10 (3) **Driver Review – Lemoyne Svendsen**

Driver Lemoyne Svendsen, who drove “Fishy’s Sushi” in the 13th Race on Friday, October 15th, came to the steward’s office to discuss his drive. After review of the race, the stewards felt that the argument with Driver Darren Lupul during the running of the race was unprofessional. A One Hundred (\$100) Dollar fine was assessed.

10/16/10 (4) **Thirteenth Race – Recall**

There was a recall caused by #5 “KD Rowdy One”, driven by Ralph Silvestri III, for failure to turn to the gate.

10/16/10 (5) **Ninth Race – Inquiry**

The stewards hung the inquiry sign concerning the breaking horse #7 “Latino Hall”, driven by James Kennedy, after the half mile pole. After review there was no change in the official finish.

10/16/10 (6) **Tenth Race – Inquiry/Disqualification**

The stewards hung the inquiry sign concerning possible interference between #2 “Sandra Hotspur”, driven by Luke Plano and #6 “Tootin Lady”, driven by Steve Wiseman in late stretch.

After review of the incident, the stewards felt that Luke Plano, behind “Sandra Hotspur”, had come out into #6 “Tootin Lady”, causing interference in the stretch. #2, who finished third (3rd), was placed fifth (5th).

After review, the stewards placed #3 from fourth (4th) to ninth (9th) for failure to lose sufficient ground while breaking in the stretch well through the wire.
