Proceedings of the Board of Stewards for the period of Monday, November 01, 2010 through Sunday, November 07, 2010. Steward Brent McLaren was the Reporting and Duty Steward for the enclosed period.

11/01/10 (1) **Entries and Draw**

We took entries for Thursday, Friday and Saturday today. A total of three hundred forty three (343) entries were taken. Thursday's entries total eighty six (86) to fill eleven (11) races.

With a scratch time of 9:00 a.m., we had ten (10) driver corrections and one (1) early scratch.

11/02/10 (2) **Draw for Friday and Saturday**

Friday's card had one hundred twenty eight (128) entries to fill sixteen (16) races, one (1) non-betting and fifteen (15) for the regular card.

Saturday's card had one hundred thirty (130) entries to fill seventeen (17) races, two (2) non-betting and fifteen (15) for the regular card.

There were fifteen (15) entries to fill three (3) qualifying races for tonight at 4:30 p.m.

The results of the qualifiers were that nine (9) out of fifteen (15) entries made qualifying standards.

11/04/10 (2) **Expired Horse**

It was reported to the stewards by Dr. Goodbary that the horse "Big Gun" had fallen and hit his head on the back side before the 4<sup>th</sup> Race in which he was suppose to race. The result was that because of this, the horse had died. Further reports will follow.

11/04/10 (3) **Seventh Race – Inquiry**

The stewards hung the inquiry sign concerning the #4 "Bettor Approval", driven by Tim Maier, for a possible lapped on break at the wire. After review, the stewards confirmed that the horse was lapped on by trailing horses, #3 "Only IN Lodi" and #1 "Garland Bot Joeefee".

Rick couldn’t race against his own trained horse, so we switched the driver on #4 and #6. After this, we were informed that the owner of #4 “Franky Provolone” was now owned by Luke Plano’s new wife “Nikki Hudson”. Luke could not drive against his wife so another change needed to be done. We placed Luke back on his wife’s horse, trained by his father Rick Plano and replaced Rick Plano of #6 “Sheila’s Dream” by James Kennedy. This situation is a rare occurrence that seldom takes place.
