**Entry Day**

The racing office was open this morning accepting entries for Thursday November 18. Eleven (11) races filled with eighty nine (89) horses scheduled to start.

**Double Entry Day and Scratches**

Scratch time for November 18 was held this morning in the racing office. Two (2) scratches and twenty six (26) driver changes were activated after the 9:00 a.m. deadline.

Entries were taken today for Friday, November 19 and Saturday, November 20. Fourteen (14) races were drawn for November 19. One hundred twenty one (121) horses are scheduled to start.

There are three (3) non-wagering (Sires Stakes) and fifteen (15) wagering events slated for November 20. One hundred thirty five (135) horses are scheduled to compete in what is anticipated to be about eight (8) hours of racing action.

Fourteen (14) races also filled for November 30. One hundred eleven (111) horses are scheduled to start.

**Tenth Race Inquiry**

The stewards posted the inquiry sign following this race after viewing third place finisher #10 "British Spirit" (Rocky Stidham) go on a 'break' entering the first turn. After film review, the stewards ruled out the possibility of any race interference. It was unanimously determined that "British Spirit" complied with California Horse Racing Board Rule #1722 and that no change in the order of finish was warranted.

**Friday**11/19/10 (1) **Kennedy Lindsey Ruling****Ruling # 47**

*Trainer Kennedy Lindsey, who started “Only In Lodi” in the Seventh Race on Thursday, November 18, 2010, is hereby fined the sum of Fifty Dollars (\$50) for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Late Arriving in Paddock).*

The ruling above was issued after the stewards were notified by Horse Identifier Carl Sobey that the Kennedy Lindsey trained “Only In Lodi” was late arriving in paddock prior to the seventh race November 18.

11/19/10 (2) **Executive Director Visit**

California Horse Racing Board Executive Director Kirk Breed spent roughly one (1) hour meeting with the stewards between the early stages of tonight’s fourteen (14) race card.

11/19/10 (3) **Off Track**

The stewards list the track condition as good for the first race then downgraded it to ‘sloppy’ for races two (2) through fourteen (14).

11/19/10 (4) **Tenth Race – Inquiry**

The stewards posted the inquiry sign after viewing fourth place finisher #6 “Beach Beach Beach” (Lemoyne Svendsen) go on a break in mid-stretch. After film review, the stewards unanimously ruled that this horse complied with the ‘breaking rule’ by losing ground. No change.

11/19/10 (5) **Thirteenth Race – Inquiry**

The stewards posted the inquiry sign after viewing second place finisher #5 “Preciosita” (Steve Wiseman) make a ‘break’ in mid-stretch. After ruling out the possibility of race interference, the stewards unanimously ruled that #5 “Preciosita” was not on his pacing gait for four (4) or five (5) strides and ‘lost ground’ following this brief break. No change.
