At the 1:30 p.m. draw, eighty one (81) horses were drawn to compete in ten (10) events. No Cal Bred races were used.

- 03/26/11 (3) **Qualifying Races**  
 Four (4) qualifying races were conducted commencing at 4:30 p.m. over a track rated 'sloppy'. Twelve (12) of eighteen (18) participants were successful in their qualifying effort.  
 The stewards, in recognition of the severe weather and track conditions, granted an allowance of six (6) seconds to those horses attempting to qualify.
- 03/26/11 (4) **Track Conditions**  
 The first two (2) races were conducted over a track rated 'sloppy'. At the conclusion of Race #2 the track condition was upgraded to 'good' and remained rated 'good' for the rest of the card.
- 03/26/11 (5) **Second Race – Inquiry/No Change**  
 The inquiry sign was posted to review the actions of #6 “Exquisite Gem” (Gene Vallandingham), the eventual fourth (4<sup>th</sup>) place finisher who broke stride after the start. After reviewing film, the stewards unanimously concluded that #4 complied with the breaking rule, thus no change.

 At the conclusion of Race #4 Provisional Driver Karen Isbell (#6 “Cheyne’s Train”, the second (2<sup>nd</sup>) place finisher was ordered to film review. More to follow.
