**Entries**

Entries were taken for tomorrow's double draw for Friday, October 14 and Saturday, October 15.

**Tuesday**

10/11/11 (1)

**Double Draw**

One hundred twenty five (125) horses were divided into fifteen (15) races for Friday. No Cal Bred races were used. Saturday's fifteen (15) race card also drew one hundred twenty five (125) entrants. No Cal Bred races were used.

**Scratches and Changes for Friday and Saturday**

Twenty two (22) scratches and numerous driver changes were submitted for Friday. There were also numerous driver changes made for Saturday.

**Financial Hearing – Case #11SW0051**

Groom Roman Herrera filed a financial complaint against Trainer Kennedy Lindsey for past wages in the amount of \$2,300.

Mr. Lindsey did not dispute the amount and promised to pay as soon as his income turned around.

An agreement to pay was signed by both parties and witnessed by the stewards. Mr. Lindsey will pay \$500 by November 1<sup>st</sup>, and another \$500 by December 1<sup>st</sup>, and the \$1,300 balance by December 15<sup>th</sup>.

10/14/11 (1) **Petrelli Ruling**

**Ruling #17**

*Driver Frank Petrelli, who drove "Goli Tie" in the Fourth Race on Friday, October 7, 2011 is hereby fined the sum of Fifty (\$50) Dollars for violation of California Horse Racing Board Rule # 1721 (K) (Driving Rules – Careless Driving – Raced Inside Pylon – in the Stretch).*

The above ruling was issued after Petrelli was contacted and admitted to misjudging the room needed to clear the last pylon coming off the turn into the stretch.

10/14/11 (2) **Luke Plano Ruling**

**Ruling # 18**

*Driver Luke Plano who drove "Larry Horse" in the Tenth Race on Saturday, October 8, 2011 is hereby fined the sum of Fifty (\$50) Dollars for violation of California Horse Racing Board Rule # 1721 (K) (Driving Rules – Careless Driving – Raced Inside Pylon – in the Stretch).*

The above ruling was issued after Plano accepted the penalty without argument.

10/14/11 (3) **Fourth Race – Inquiry/No Change**

#6 "Aston Boko" (Scott Cisco) went off stride before and after the half mile and ended up fourth (4<sup>th</sup>). After an inquiry and reviewing the actions of Aston Boko, it was determined that no violations occurred. No change.

10/14/11 (4) **Eighth Race – Recall**

#8 "Claim Jumper" (Steve Desomer) came to the gate in the seven position, causing a recall. A delay of five (5) minutes was the result as well as the following ruling, which Mr. Desomer accepted without argument:

**Ruling # 19**

*Driver Steve Desomer who drove #8 "Claim Jumper" in the Eighth Race on Friday, October 14, 2011 is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule # 1731 (D) (Come to the Starting Gate Out of Position) necessitating a recall.*

10/14/11 (5) **Tenth Race – Inquiry/Disqualification**

The inquiry sign was posted to review an incident in deep stretch involving fourth (4<sup>th</sup>) place finisher #5 "Sleigh Bells" (Luke Plano) and fifth (5<sup>th</sup>) place finisher #7 "Persuade Me" (Lemoyne Svendsen). After review and talking to the drivers, it was determined in an unanimous vote to disqualify #5 from fourth (4<sup>th</sup>) to fifth (5<sup>th</sup>) for interference. Tapes show

#5 come out in deep stretch, bumping wheels and impeding the progress of #7.

10/14/11 (6) **Another Recall – Fourteenth Race**

#3 “Girls Lie Too” (George Luster) came to the gate in the #2 position, causing a recall. A delay of five (5) or six (6) minutes resulted. Driver Luster will appear in the steward’s office tomorrow.

10/15/11 (1) **Luster Ruling**

**Ruling # 20**

*Driver George Luster who drove #3 “Girls Lie Too” in the Fourteenth Race on Friday October 14, 2011 is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule # 1731 (D) (Come to the Starting Gate Out of Position) necessitating a recall.*

The above ruling was issued after Luster appeared and apologized for the mix up. He stated that he assumed #2 had scratched and he could move down from the three to the two position. Unfortunately for Mr. Luster, the #2 was very much in the race.

10/15/11 (2) **Plano Ruling [Ref: 10/14/11 (5)]**

**Ruling # 21**

*Driver Luke Plano, who drove #5 “Sleigh Bells” in the Tenth Race on Friday, October 14, 2011 is hereby fined the sum of Two Hundred (\$200) Dollars for violation of California Horse Racing Board Rule # 1721 (J) (Driving Rules – Change Course After Selecting a Position in the*

*Homestretch, or Bear In or Out In Such a Manner as to Interfere With Another Horse or Cause Him to Change Stride or Break). Incident occurred in deep stretch – resulting in a disqualification.*

The above ruling was issued after Plano appeared and pled his case by attempting to place some blame on another horse and driver in the race in question. In the end, the stewards still felt the main culprit was Mr. Plano and his drive.

- 10/15/11 (3) **Covemaker In**  
Rookie Driver James Covemaker was in for instruction on the proper use of the whip. Mr. Covemaker was cautioned that one handed whipping will not be tolerated until the 1/8 pole is reached. He has been cutting it close.
- 10/15/11 (4) **Trainer and Owner In**  
Trainer Dario Solares and Lessee (Owner) Osmin Carrera were in concerning the performance of the gelding, #6 “Komoda’s Fantasy” in last night’s fifth race.  
“Komoda’s Fantasy” won in a time of 153<sup>4</sup> and the six year old’s previous lifetime best was 156<sup>2</sup>.  
This was the first start for the above connections and the stewards wanted an explanation for the drastic improvement.  
Solares related that numerous equipment changes were made by adding two headpoles, stretch hobbles, a cheek piece inside and going to an open bridle.  
The stewards informed the parties that a consistent form is expected and future races would be scrutinized.
- 10/15/11 (5) **Qualifying Races**  
Five (5) qualifying races were held prior to this evening’s fifteen (15) race pari-mutuel card. Of the twenty two (22) participants, seventeen (17) made the grade.
- 10/15/11 (6) **TV Production Problems**  
The graphics portion of tonight’s satellite feed was inoperable for tonight’s program. A computer melt down was cited as the cause. As a result, the overlay stating what race number was running, the odds, the running order, and finish order could not be generated. The finish and payoffs were shown on the tote board and video cameras were able to send that feed and a tote generated payoff screen was also available.  
The track handle was \$525,000 tonight versus \$598,000 last Saturday.
- 10/15/11 (7) **Ninth Race – Inquiry/No Change**  
The stewards posted the inquiry sign to review numerous horses going offstride during the running of the 9<sup>th</sup> Race. After review, it was determined all horses complied with the breaking rule and no change was warranted.
