PRE-MEET HAPPENINGS

Stewards Grant Baker and Will Meyers were present today to prepare for opening day at the California State Fair. The CHRB licensing office, adjacent to our office, was open and the stewards reviewed 'problem sheets' for the first three days of the meet. The judges' stand was inspected and was in good order. The stewards inspected the jockeys' room and met with Assistant Clerk of Scales Matt Nichols. We also stopped by the tote department and met with Tom Kelso, Michelle Arendt and Marilyn Taylor. Racing Secretary Tom 'Bomber' Doutrich was in his office and gave his assessment of this summer's Fair Circuit. We also met with Larry Swartzlander (California Authority of Racing Fairs Chief Operating Officer) who set up an additional computer in the stewards' office for them to use during the duration of the meet.

Thursday

07-12-12¹

INQUIRY – First Race – NO CHANGE

The stewards posted the inquiry sign following this first race of the 2012 meeting. This was a three hundred and fifty (350) yard quarter horse race with six (6) starters. At the midway point of this race third place finisher #4 NO JOHNY COME LATELY (Jesus Arriaga) ducks into the path of fourth place finisher #3 HAWKISH KNIGHT (Juan Arriaga) forcing the jockey of this rival to steady his mount. The stewards reviewed pan, head-on and ¼ pole camera angles of this incident. They also spoke to both jockeys involved. Following a review of the films the majority of the stewards felt these two (2) participants finish position was not affected by this incident and voted to make 'no change'. Steward Meyers dissented. Jockey Jesus Arriaga was ordered to see the stewards tomorrow for film review.

07-12-12²

JOCKEY OBJECTION – Seventh Race – NO CHANGE

Jockey Julien Couton, who rode sixth place finisher #2 ALONG FOR THE RIDE, lodged an objection against fourth place finisher #3 BUZZNALAWNG (Kerwin John) for alleged

interference while racing on the far (3/8th) turn. Film review shows #2 ALONG FOR THE RIDE being somewhat 'hard to place' before taking up while racing on the far turn. The stewards felt the action of #3 BUZZNALAWNG was not the reason jockey Couton steadied as BUZZNALAWNG was uneventfully folding into the turn. Earlier decision making prior to the 'point of the turn' could have led to a smoother trip for #2 ALONG FOR THE RIDE. The decision of the stewards was unanimous. No change.

07-13-12¹ **JESUS ARRIAGA FILM REVIEW / RULING NO. 01** (Ref: 07-12-12¹)

Jockey **Jesus Arriaga** appeared in the stewards' office to view his ride in yesterday's (July 12) first race. Jesus Arriaga was involved in an incident (Ref: 07-12-12¹) while riding #4 NO JOHNNY COME LATELY, who finished fourth after bothering third place finisher #3 HAWKISH KNIGHT (Juan Arriaga). Jesus Arriaga survived a stewards' Inquiry in this race after veering in and causing interference in mid-stretch. Jesus Arriaga was also ordered to the stewards' office at the Alameda County Fair in Pleasanton on July 4th (Ref: 07-04-12⁴) in another Quarterhorse race in which he was the subject of a stewards' inquiry.

The stewards reminded Arriaga it is his obligation to maintain a straight course. In a unanimous decision the following ruling was issued:

Jockey **JESUS ARRIAGA**, who rode **NO JOHNNY COME LATELY** in the first race on July 12, 2012 at the California State Fair (Sacramento) is suspended three (3) racing days (July 20, 21, and 22, 2012) for causing interference in the stretch; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-13-12² **TIM McCANNA COMPLAINT (Case No. 12GG098)**

Trainer **Tim McCanna** appeared for an informal hearing today at Cal-Expo. This matter originated at Golden Gate Fields when the McCanna trainee, GOLDEN CHILO, finished first in a race on May 25, 2012 and the official test sample taken showed a level of Phenylbutazone of 3.20 ug/ml.

McCanna told the stewards he was out of state prior to this race and that his groom improperly administered bute to his trainee while he was gone. CHRB veterinarian Forrest Franklin (Golden Gate Fields) made thorough recommendations of the proper use of bute to McCanna's stable in the future.

Trainer McCanna has a good medication record in California. An 'official warning' will now be entered into his license history in a unanimous vote of the stewards.

07-13-12³ **JUAN SANCHEZ FILM REVIEW**

Apprentice jockey **Juan Sanchez** appeared in the stewards' office to review his ride in yesterday's sixth race. Sanchez was aboard #1 JANS GOLD who finished fifth in this race. JANS GOLD was lugging out continuously while racing down the backstretch and bumping rival #4 DRAW TWO BUCK (Kerwin John). Apprentice jockey Sanchez said his saddle slipped slightly and race replays seemed to indicate this. The stewards told Sanchez he needs to make a stronger effort to hold a lugging horse straight in order to avoid constant bumping.

The majority of stewards voted for a warning in this matter while Steward Nevin felt a suspension was warranted.

07-13-12⁴ **RULING NO. 2 – PEDRO TERRERO**

Jockey **PEDRO TERRERO**, who was scheduled to ride JEHOVAH JIREH in the sixth race on July 12, 2012 is hereby fined the sum of one hundred dollars (\$100.00) for failure to fulfill his mount; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

Jockey Pedro Terrero failed to show up on Thursday, July 12 to ride #9 JEHOVAH JIREH in the sixth race. This resulted in apprentice jockey Irving Orozco being announced as a replacement rider. JEHOVAH JIREH went on to win this race at the odds of 38/1. Pedro Terrero was not excused from his mount and the stewards unanimously issued the ruling above.

07-13-12⁵ **ACCIDENT – INQUIRY – First Race – DISQUALIFICATION**

The stewards posted the inquiry sign following the running of this three hundred and fifty (350) yard mule race. In this race there was an accident after fourth place finisher, #1 OKIE PRIDE LARRY (Jonathan Roman), drifted out under left-handed whip bolting across the race track bumping sixth place finisher #8 JESSICA NELSON (David Essman) and #4 JUST BAILEY, who lost jockey Francisco Maldonado after the contact.

Jockey Maldonado rose to his feet and was checked on by the paramedic and EMT on duty. In a unanimous decision #1 OKIE PRIDE LARRY was disqualified and placed him unplaced.

Jockey Jonathan Roman will review race replays with the stewards tomorrow. #1 OKIE PRIDE LARRY was placed on the Stewards List and will need to have a safe/satisfactory workout before being allowed to enter. An accident report will be attached to these minutes.

07-13-12⁶ **EIGHTH RACE POOLS**

Cal-Expo management cancelled show wagering in today's eighth race. #2 LORD VRONSKY (Frank Alvarado) (odds 4/5) finished second in this six (6) horse race. #3 DO WHAT U DARE (Russell Baze) finished first at odds of 5/2.

Saturday07-14-12¹ **JONATHAN ROMAN FILM REVIEW / RULING NO. 3**

Jockey **Jonathan Roman** appeared in the stewards' office to review his ride in yesterday's (July 13) first race. He was accompanied by assistant trainer Ramon Pulido. Jockey Roman was involved in a stewards' inquiry and accident in this race (Ref: 07-13-12⁵). Film review shows Roman aboard original fourth place finisher #1 OKIE PRIDE LARRY, whipping left handed shifting out and bumping outside rival #3 STOCKYARD ELLIE (Anthony Ayala). After this initial bump he uses his left handed whip once again and his mount bolts across the racetrack bumping #4 JUST BAILEY and unseating jockey Francisco Maldonado. Original sixth place finisher #8 JESSICA NELSON was also severely impeded by #1 OKIE PRIDE LARRY.

The stewards felt OKIE PRIDE LARRY gave jockey Roman significant warning prior to the accident and that left hand whipping was causing his mule to drift out and initiate bumping. The final left handed whip caused his mount to bolt and led to a dangerous situation. In a unanimous decision the stewards issued the following ruling after a thorough film review.

Jockey **JONATHAN ROMAN**, who rode **OKIE PRIDE LARRY** in the first race at the California State Fair (Sacramento) on Friday, July 13, 2012, is suspended seven (7) racing days (July 21, 22, 25, 26, 27, 28, and 29, 2012) for causing interference in the stretch resulting in a disqualification of his mount from fourth to unplaced; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-14-12² **CARLOS VILLALOBOS FILM REVIEW / RULING NO. 4**

Jockey **Carlos Villalobos** appeared as ordered to the stewards' office this morning. Villalobos failed to show up yesterday (July 13) to fulfill his riding engagement aboard GOODUNDERTHEHOOD in yesterday's first race. This led to the 'late scratch' of this mule as no other jockeys wished to offer their services. Villalobos over ambitious morning schedule and freeway traffic led to his absence. We did not get a call from jockey Villalobos nor was he excused. The stewards unanimously voted to issue the following ruling:

Jockey **CARLOS VILLALOBOS** is hereby fined the sum of two hundred dollars (\$200.00) for failure to fulfill his engagement on Friday, July 13, 2012 in the first race on GOODUNDERTHEHOOD resulting in a late declaration; a violation of California Horse Racing Board rule #1872

(Failure to Fulfill Jockey Agreement).

07-14-12³ **JESUS VELAZQUEZ MEETING**

Jockey **Jesus Velazquez** appeared in the stewards' office today to discuss the second race at the Alameda County Fair in Pleasanton (Ref: 07-08-12⁴). Velazquez was aboard third place finisher #5 RED DEPUTY in this race. He lodged an objection against first place finisher #6 UNCLE ENROY (Julien Couton) in this race. The Pleasanton stewards felt this objection bordered on frivolous. He was told today that while jockey objections are not discouraged they should have at least some credibility or a monetary sanction could be warranted in the future.

07-14-12⁴ **NOR CAL ALUMNI RETURN**

Two (2) long time fixtures from northern California racing each paid the stewards a visit over the weekend. Former jockey Tony Noguez, who rode all breeds and was prominent in the jockey's standing on the fair circuit for over two (2) decades, now prepares horses for sale in Ocala, Florida. Former trainer Grey Gilchrist also stopped by and still calls the Bay Area home but told us he travels to Kentucky and Florida attending horse auctions while representing clients/owners. Gilchrist assisted trainer Duane Offield with a stable of horses here at Cal Expo back in 1974 prior to taking out his own trainer's license. The stewards appreciated the visits and wish both of these gentlemen good health and success in the future.

07-14-12⁵ **OBJECTION – Second Race – NO CHANGE**

Following the running of this 350 yards mule race jockey David Essman, who was aboard fourth place finisher #4 BLUE MCGEE PHD, lodged a claim of foul against second place finisher #5 IMA TOP GUN (Carlos Villalobos) and third place finisher #1 BAR JF EASY MONEY (Anthony Ayala).

Race replays showed several mules race in tight quarters during the final seventy (70) yards of this race. Jockey Essman steadied his mount in deep stretch. Film review showed #1 BAR JF EASY MONEY drift out slightly in this race's late stages. After patrol judge input the stewards spoke to all three (3) jockeys involved. In a unanimous decision the stewards ruled that no change in the order of finish was warranted.

07-14-12⁶ **THIRD RACE GATE TROUBLES**

This five (5) horse field, going 5 ½ furlongs, got off to a very bad start after the stewards scratched three (3) horses at the starting gate, acting on the recommendation of track veterinarian Audrey Clifton. #1 YARD BULLY (Francisco Duran) and #3 HANDSOME HARVEY JR (Kerwin John) reared and got cast in the gate almost simultaneously. Shortly after this incident #4 SOLD SHORT (Catalino Martinez) hurt himself in the starting gate necessitating another late scratch.

These three (3) late scratches forced the stewards to order place and show pools to be refunded to the public. The Quinella pool was also refunded in its entirety. The stewards spoke with the Cal-Expo tote department and Ted Shaine from Sportech headquarters here in Sacramento before making this two (2) horse field official. The activity at the starting gate prior to this race led to an eleven (11) minute delay.

07-14-12⁷ **INQUIRY – Fifth Race – NO CHANGE**

The stewards posted the inquiry sign after viewing two separate incidents between first place finisher #2 GOOD MANGO (Ronald Richard) and second place finisher #7 ELAINE'S TENACITY (Irving Orozco). In the first incident #7 ELAINE'S TENACITY veers in approaching the 3/16 pole and bumps eventual winner #2 GOOD MANGO. In a second incident, nearing the finish, #2 GOOD MANGO drifts out and bumps #7 ELAINE'S TENACITY.

The stewards felt these incidents offset each other and were relatively minor in nature. In a unanimous decision no change was made in the order of finish.

07-14-12⁸ **STEWARDS' AIDE INJURED**

While unsaddling GATA DE ORO (Russell Baze) following her seventh race victory, stewards' aide Joy McDuffie was injured while the horse was moving. The stewards contacted the human ambulance crew and Ms. McDuffie was attended to in the winner's circle by them before being transported to U. C. Davis Medical Center in Sacramento. This incident led to a nineteen (19) minute delay to the start of today's eighth (last) race as the stewards waited for a transfer ambulance to arrive at the track.

07-14-12⁹ **AFTER THE RACES ACTIVITY**

As the horses for the eighth race were being walked back to the stable area, #8 PERSONALITARY (Tr. Sergio Ledezma) struggled and fell with apparent heat related problems. The track's horse ambulance was summoned and quickly arrived on the scene. At this point horse ambulance driver George Hanford collapsed while assisting the fallen horse. Mr. Hanford was transported to the hospital and diagnosed with heat exhaustion and dehydration according to safety steward Wayne Oke. The horse PERSONALITARY was attended to on the racetrack by veterinarians and eventually walked off the racetrack on his own power.

07-15-12¹ **RULING NO. 5 – ESQUIVEL**

Exercise Rider **LORENZO ESQUIVEL** is hereby suspended pending an appearance before a Board of Stewards for failure to appear to answer charges of alleged violation of California Horse Racing Board rules #1489 (a) (c) (Grounds for Denial or Refusal of License, #1900 (Grounds for Suspension or Revocation of License) and #1902 (Conduct Detrimental

to Horse Racing); a violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of LORENZO ESQUIVEL are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

Exercise rider **Lorenzo Esquivel** failed to appear at a hearing for alleged violation of California Horse Racing Board rules #1489 (Grounds for Denial or Refusal of License), #1900 (Grounds for Suspension or Revocation) and #1902 (Conduct Detrimental to Horse Racing). The complaint in this case was prepared by CHRB investigator Barbara Chimero. The ruling above was issued after Esquivel failed to appear for his scheduled hearing.
