During the term of suspension, all licenses and license privileges of **CLAYTON ELROD** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Mr. Elrod failed to appear after requesting a continuance for yesterday. No payment on the bill has been received by **San Francisco Equine**.

06-09-07³ **RULING NO. 42 - CERIN** (Case #07GG047)

Trainer **VLADIMIR CERIN**, who started the horse SILVER AGAIN, who finished second in the first race at Golden Gate Fields on May 13, 2007, is fined the sum of four hundred dollars (\$400.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of CHRB rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone, in excess of permitted level - 7.78 ug/ml).

The above ruling was issued after Mr. Cerin contacted the stewards by phone from southern California. Vladimir accepted responsibility for the high test result but was of the opinion that an attending veterinarian may have administered the injection later in the day than was prudent.

06-09-07⁴ **LATE SCRATCH - Sixth Race - REFUND**

#3 KATISPSUBBLUE, trained by Leonard Powell, was scratched on the advice of track veterinarian Heather Kerr, after the horse flipped in the starting gate and injured himself. On Vet's List. The refund totaled \$43,677.76.

06-10-07² **RULING NO. 43 - MIRANDA** (Case #07GG046)

Trainer **EFRAIN MIRANDA**, who started the horse **YOUNIQUE CAT**, finishing first in the second race at Golden Gate Fields on May 10, 2007, is fined the sum of seven hundred fifty dollars (\$750.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of CHRB rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone, in excess of permitted level - 6.95 ug/ml).

The above ruling was issued after Efrain appeared and accepted responsibility for the high test results. Miranda suspected he may have inadvertently given the medication inside the twenty-four hour limit.

06-10-07³ **LATE SCRATCH - First Race - REFUND**

#7 SCUTARI, trained by Selwyn LaGrone, was scratched on the recommendation of Dr. Kerr as the field reared the starting gate after she reported the horse failed to warm up properly. On Vet's list. The refund was \$41,602.94.

06-10-07⁴ **STEWARDS' INQUIRY - First Race - DISQUALIFICATION**

The stewards lit the inquiry lamp to evaluate close quarters leaving the starting gate and approaching the 3/8. After a through review the stewards disqualified #3 SWEETVILLE (5th, Louis Contreras) and placed him sixth, behind #1 WRECKING MACHINE ridden by Luis Martinez.

Tapes showed that SWEETVILLE drifted in leaving the gate, putting pressure on #2 ABSOLUTE COURAGE (4th, Joel Rosario) and WRECKING MACHINE. Still on the inward drift, SWEETVILLE made contact with ABSOLUTE COURAGE who bumped WRECKING MACHINE causing the latter to take up sharply and, in the stewards' unanimous opinion, a chance at a better placing.
