09-18-09³ **RULING NO. 1 – DUPUIS** (Case 08GG118)

Trainer **JEAN-PIERRE DUPUIS**, who started the horse **SHAKE AND ROLL**, third place finisher in the fourth race at the Solano County Fair on July 20, 2008, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone – in excess of the permitted level – 5.59 ug/ml).

The preceding ruling was issued after Mr. Dupuis contacted the stewards telephonically and waived his right to a formal hearing.

Mr. Dupuis stated SHAKE AND ROLL had run twice in four days and the second start (07-20-08) was the first time the horse ran on Phenylbutazone. The horse was only treated on July 19, 2008 by Mr. Dupuis' veterinarian.

Mr. Dupuis acknowledged responsibility and accepted the penalty imposed.

09-18-08⁴ **RULING NO. 2 – NORTH**

Jockey Agent **MARK NORTH** is hereby fined the sum of three hundred dollars (\$300.00) for failure to handle his business in a proper manner causing the declaration of the horse **BORN TO BE WILD** in the second race on Friday, September 19, 2008; a violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration).

The foregoing ruling was issued as Mr. North accepted responsibility for entering the wrong horse for trainer **Doug Utley** that led to the declaration of BORN TO BE WILD.

09-18-08⁵ **OWNER REQUEST**

Owner **Jim Ford** e-mailed a request addressed to this Board of Stewards and the Board of Stewards at Fairplex and Oaktree, seeking control over future entries of horses he owns solely, or in part, in accordance with California Horse Racing Board rule 1894.

The four horses listed by Mr. Ford are co-owned by many others and not all parties are in agreement.

Our attempts to contact Mr. Ford to discuss this matter were unsuccessful.

09-18-08⁶ **OBJECTION – NO CHANGE – Third Race**

The stewards posted the objection sign following the third race at the request of jockey Saul Arias (#5 MR. LOGAN, 5th) who claimed foul against #6 BRADFORD FALLS (Reed Saldana), the winner.

After consulting with the patrol judges and reviewing the tapes, the stewards decided unanimously to dismiss the objection as there was no interference that warranted a disqualification.

Trainer **ALBERT M. LENZINI**, who started the horse **BEAMER BEE**, first place finisher in the fifth race at the Alameda County Fair (Pleasanton) on July 3, 2008, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule 1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule 1843 (a) & (d) (Medication, Drugs and Other Substances: more than one approved NSAIDS – Phenylbutazone – 1.08 ug/ml and Flunixin – 28 ng/ml).

The foregoing ruling was issued after Mr. Lenzini appeared and waived his right to a formal hearing.

The veteran trainer stated that BEAMER BEE trains and runs on bute, but on July 2, 2008, the five year old mare was inadvertently given Banamine and coupled with the bute she received the day before (July 1, 2008), he accepts the test results.

Trainer **STEVE MIYADI** is fined the sum of five hundred dollars (\$500.00) for failure to properly report the gelding of the horse **AGGRESSION** prior to the eighth race on Monday, July 21, 2008 at Solano County Fair (Vallejo), which is a violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

The preceding ruling was issued after Mr. Miyadi accepted responsibility for the first time starting two year old, **AGGRESSION**, being listed in the program as a colt instead of a gelding.

09-20-08⁴ **OBJECTION – NO CHANGE – Third Race**

The stewards posted the inquiry sign following the third race at the request of jockey Juan Ochoa (#3 BUEN MOZO) sixth, who lodged a claim of foul against #4 AWESOME SHINE (Omar Figueroa), the winner.

After interviewing the riders and reviewing the tapes, the stewards decided unanimously to let the original order of finish stand.

The tapes were inconclusive as to whom, if anyone, was to blame for #3 BUEN MOZO to bobble and steady going into the crowded first turn of this mile event.
