Pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: 16-Hydroxystanzolol – Class IV – Category D) and in accordance with California Horse Racing Board Directive 02-08, dated July 24, 2008 and supplement to Directive 02-08, dated July 28, 2008, official warnings are issued to trainer **STEVE MIYADI** for the following complaints:

10-11-08<sup>3</sup> **FORMAL HEARING** (Positive Test – 07GG056)

Owner **Jerry Hollendorfer** appeared representing the group that owns the gelding **GOLD RUCKUS**, that allegedly tested positive for 3-Hydroxy-xylazine (Class II) (Rompun) in the post race urine sample taken following the first race at Golden Gate Fields on June 2, 2008.

Mr. Hollendorfer requested time to consult his attorney and the hearing was delayed until Saturday, October 18, 2008.

10-11-08<sup>4</sup> **INQUIRY – NON STARTER – Fourth Race - REFUND**

The stewards posted the inquiry sign following the fourth race in order to review the start.

After a thorough review the stewards, in a split vote (McHargue dissenting), declared #6 ROARING SPRINGS (Francisco Duran) a non-starter, as the majority determined he had an unfair start and refunds were in the public's best interest. The refund amounted to \$19, 167.60.

The tapes show #6 ROARING SPRINGS rears up and unseats jockey Duran just before the starter dispatched the field and left the gate without a rider. Jockey Duran, who was thrown out the back of the stall, was uninjured.

10-11-08<sup>5</sup> **BREAKDOWN – Fifth Race**

#6 REFRESHING DREAM (Alfredo Miranda) was pulled up near the  $\frac{3}{4}$  pole and vanned off in the horse ambulance.

First report was lameness in his right foreleg.

10-11-08<sup>6</sup> **RIDER EXCUSED**

Jockey **Russell Baze** complained of soreness in his back following the first race and track physician David Seftel, M.D., recommended he be excused for the remainder of the day.

10-11-08<sup>7</sup> **OBJECTION – NO CHANGE – Ninth Race**

The stewards posted the objection sign following the ninth race at the request of assistant trainer KAY COOPER (#7, SCALDING PASSION) second, who claimed foul against #6 GHERIG (Alex Bisono), the winner.

10-12-08<sup>4</sup> **ACCIDENT – INQUIRY – First Race**

The stewards posted the inquiry sign following the first race for a review of an accident shortly after the start of the six furlong event.

The tapes show #1 STEALINTHEJACKPOT (Luis Martinez) broke with the field and then ducked in sharply, jumped the inside rail extension barriers and unseated jockey Martinez.

Mr. Martinez was on his feet quickly and after being examined was cleared to fulfill his remaining engagements.

The two year old gelding, STEALINTHEJACKPOT, will be placed on the Starter's List and required to work from the gate.
