Wednesday08-12-09¹ **CAL-BRED REPORT**

Purse \$12,500. For California bred or California sired three year olds and upward, claiming price \$10,000 at one mile and one sixteenth. The race was called off with one entry.

08-12-09² **PRE-MEET MEETING**

General Manager **Robert Hartman** stopped in to discuss the upcoming meet. Areas of mutual interest were discussed. This is the first of two Fair meetings to be run for the first time at Golden Gate Fields. The field sizes for the first few days are encouraging in regards to the horsemen support in the entry box and hopefully, will continue through the ten day meeting.

08-12-09³ **VERGARA FINANCIAL**

CHRB complaint 09GG271, filed against jockey **DANIEL VERGARA** by jockey agent **John Moresco**, was dismissed after Mr. Moresco reported the debt has been paid in full.

08-12-09⁴ **HORSE'S IDENTIFICATION IN QUESTION**

Horse Identifier **Patrick Kealy** informed the stewards that D.N.A. testing was being conducted on two horses, **GENUINE DELIGHT** and **DR. ARACELI BC**. Both horses at one time were trained by Greg James and DR. ARACELI BC is still under his care. GENUINE DELIGHT was claimed from Greg James and is now trained by Keith Bennett. Mr. Bennett also came to the office to voice his concerns. The true identities of the horses were questioned after Del Mar Horse Identifier Diane Piper checked the identification markings of GENUINE DELIGHT and the horse failed to match the markings which started the process of D.N.A. testing...more to come.

08-12-09⁴ **RULING NO. 1 – AYARZA**

Jockey **JORGE AYARZA**, who rode ALONGWAY BABY in the second race at the Sonoma County Fair (Santa Rosa) on Sunday, August 9, 2009, is suspended three (3) racing days (August 19, 20 and 21, 2009) for failure to make the proper effort to maintain a straight course leaving the starting gate and causing interference resulting in the disqualification of his mount from second to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The preceding ruling was issued after Mr. Ayarza, accompanied by agent **Ramon Silva**, reviewed the race and acknowledged guilt.

08-12-09⁵ **RULING NO. 2 – ALVARADO**

Jockey **FRANK ALVARADO**, who rode I WANNA GO FAST in the ninth race at the Sonoma County Fair (Santa Rosa) on Sunday, August 9, 2009, is suspended three (3) racing days (August 19, 20 and 21, 2009) for altering course without sufficient clearance and causing interference resulting in the disqualification of his mount from second to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Alvarado reviewed the race and failed to offer a valid reason for changing course and causing interference.

08-13-09² **MICHAEL TRUJILLO FORMAL HEARING**

A transcribed hearing was held today to address CHRB complaint 09GG266 filed against trainer **MICHAEL TRUJILLO** for alleged violation of California Horse Racing Board rules #1489(a) (Grounds for Denial or Refusal of License), #1530 (Cases Not Covered) and #1874(4) (Disorderly Conduct). Mr. Trujillo was cited after testing positive for the drug Hydrocortone while performing his duties.

Present at the hearing were stewards Darrel McHargue, John Herbuveaux and Grant Baker, Mr. Trujillo, Armando Calero – Winners Foundation representative, and CHRB investigators Anne Glasscock and Carol Nolan. Christine Niccoli, CSR, recorded the hearing.

After sworn testimony was taken and supporting documentation placed in the record, the matter was submitted for decision.

08-13-09³ **BARRINGTON HARVEY – Use of Whip Hearing**

A hearing was conducted for jockey **BARRINGTON HARVEY** for a possible violation of California Horse Racing Board rule #1688 (Use of Whips) during the running of the eighth race ran at Santa Rosa on August 9, 2009.

Present for the hearing, in addition to the steward Darrel McHargue, John Herbuveaux and Grant Baker, was Mr. Harvey.

After conducting a thorough review of the race and hearing Mr. Harvey's opinion and analysis of his use of the whip, the matter was submitted for decision.

08-13-09⁵ **INQUIRY – DISQUALIFICATION – Sixth Race**

The inquiry sign was posted following the running of the sixth race for a review of an observed incident soon after the start involving #1 MISS ALL THE POWER (Alex Bisono, 5th place) and #2 WYATT'S ARROW (Juan Avila, 4th place).

After talking with the Patrol Judge, the jockeys involved and reviewing the recorded views of the race, #2 was disqualified from fourth and placed fifth.

The tapes show #2 drifts in or angles inward as the field of horses left the chute and into the path of #1 which resulted in that rival catching a heel and causing it to stumble.

08-14-09² **RULING NO. 3 – TERRERO**

Apprentice Jockey **PEDRO TERRERO** is fined the sum of twenty-five dollars (\$25.00) for violation of California Horse Racing Board rule #1870 (Conditions of Meeting Binding Upon Licensees – Parking Violation).

The ruling was issued after Mr. Terrero appeared and pled guilty.

08-14-09³ **RULING NO. 4 – AVILA**

Jockey **JUAN AVILA**, who rode **WYATT'S ARROW** in the sixth race at Golden Gate Fields on Thursday, August 13, 2009, is suspended three (3) racing days (August 21, 22 and 23, 2009) for failure to make the proper effort to maintain a straight course soon after the start and causing interference resulting in the disqualification of his mount from fourth to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The preceding ruling was issued after Mr. Avila and trainer **Frank Miranda** came in to review the race and the explanation given was insufficient to absolve him of blame for the incident.

08-14-09⁴ **RULING NO. 5 – ANTONGEORGI, III**

Jockey **WILLIAM ANTONGEORGI, III**, who rode **SANFRAN** in the fifth race at Golden Gate Fields on Wednesday, August 12, 2009, is suspended seven (7) racing days (August 21, 22, 23, 26, 27, 28 and 29, 2009) for a violation of California Horse Racing Board rule #1692 (Requirements for Horse, Trainer and Jockey – Best effort required).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Antongeorgi, III, met with the stewards and reviewed the race but failed to offer a valid reason for the listless ride.

08-15-09³ **RULING NO. 6 – TRUJILLO**

Trainer **MICHAEL F. TRUJILLO** is suspended Wednesday, August 19, 2009 through the term of his license, October 31, 2011, pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for violation of California Horse Racing Board rules #1489(h) (Grounds for Denial or Refusal of License – Illegal substance, Hydrocortone), #1874 (Disorderly Conduct) and for violation of the terms of probation contained in Pacific Racing Association ruling #37, dated October 12, 2007.

Prior to being re-licensed, Mr. Trujillo shall show proof of completion of a six month in-house rehabilitation program acceptable to the Board of Stewards.

During the term of suspension, all licenses and license privileges of MICHAEL F. TRUJILLO are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The preceding ruling was issued after the stewards duly deliberated the matter. The length of the suspension was based on Mr. Trujillo’s lengthy history of drug use.
