Wednesday

09-16-09¹ **NON-RACING / HEARING DAY**

The stewards were present to preside over several hearings including this complaint (Case #09GG272) filed by trainer **Jerry Hollendorfer** against a former owner, **Bliss Canyon Investments**, which is owned by **Jose Mercado Mora**. The complaint alleged \$4,693.00 due from a past due training bill.

Assistant Trainer **Janet Hollendorfer** appeared but Mr. Mora did not. Should Mora's absence persist he will be suspended tomorrow.

09-16-09² **RE-INSTATEMENT - PART I**

Jockey **RODRIGO MATIAS** appeared seeking re-instatement of his license privileges. Matias had been suspended by the stewards at Del Mar for a substance abuse problem. His suspension was over on September 9, 2009.

Matias demonstrated compliance with the conditions contained in the ruling:

- 1) proof of completion of a 90-day in-house rehabilitation program
- 2) signed contract with the Winners Foundation
- 3) testing agreement with the California Horse Racing Board

Matias explained that while he is currently licensed as a jockey he only wants to exercise horses at the present time.

09-16-09³ **RE-INSTATEMENT – PART II**

Groom **ADRIAN ALBA** appeared with Winners Foundation counselor Armando Calero seeking re-instatement of his license privileges which were suspended for 90 days by this Board of Stewards on June 6, 2009 for alcohol related rule violations. As part of the ruling Alba was ordered to enter a 90 day in-house rehabilitation program and today he showed proof of completion thereof. He was placed on probation for the term of his license (03-31-10) and as conditions of probation he signed a contract with the Winners Foundation and a testing agreement with the California Horse Racing Board.

09-17-09²**RULING NO. 3 – MARTIN, JR.**

In the Matter of:

Owner/Trainer Francisco "Frank" Martin, Jr.

Having failed to abide by the terms of a financial payment agreement with San Francisco Equine, Inc., trainer FRANCISO MARTIN, JR. is hereby suspended pending satisfaction of the debt for violation of California Horse Racing Board rule #1876 (Financial Responsibility).

During the term of suspension, all licenses and license privileges of FRANCISCO MARTIN, JR. are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after we received written notice from San Francisco Equine that Martin had paid approximately \$1500 on a \$11,700 debt and no payments have been received since June. Attempts to contact Martin were unsuccessful.

09-17-09³**RULING NO. 4 – MERCADO MORA**

Owner JOSE MERCADO MORA (dba Bliss Canyon Investments), having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Wednesday, September 16, 2009, to answer charges of alleged violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending appearance before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Jose Mercado Mora (dba Bliss Canyon Investments) are suspended and Pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued after Mora's non-appearance at yesterday's scheduled hearing.

09-17-09⁴**LATE SCRATCH – REFUND – Eighth Race**

#3 CEESCREEN, trained by Alex Sywak, was scratched on the recommendation of track veterinarian Heather Kerr, D.V.M., during the warm-up after she diagnosed the mare as off in the right hind. On Vet's List. The refund totaled \$5,140.57.

09-19-09³ **STEWARDS' INQUIRY – DISQUALIFICATION – Eighth Race**

The stewards posted the inquiry sign to evaluate an incident in the clubhouse turn involving #4 **MCMURTRY** (4th, **Francisco Duran**). After a thorough review the stewards disqualified MCMURTRY from fourth and placed him seventh.

Tapes showed the MCMURTRY failed to negotiate the first turn and took three horses off their path. The three were #2 NAUGHTY CAL (7th, Michael Martinez), #5 MR. WOLVERRINE (6th, Alex Bisono) and #8 SUFFOLK PUNCH (3rd, Julio Garcia). SUFFOLK PUNCH came on to outfinish MCMURTRY but, in the stewards' opinion, NAUGHTY CAL

and MR. WOLVERINE were cost the opportunity at a better placing. Duran will review the tapes of the race with the stewards in the morning.

09-20-09³ **ROJAS EXTENSION – RULING NO. 9**

In the Matter of:

Apprentice Jockey **ALVARO O. ROJAS**

Pursuant to California Horse Racing Board rule 1500 (b) (Apprentice Jockey) and for good cause, the apprentice allowance of Alvaro Rojas is extended ninety-two (92) days from October 8, 2009 to January 7, 2010 or until Mr. Rojas has ridden forty (40) winners, whichever comes first.

The above ruling was issued after Rojas documented he was unable to compete while mending from injuries incurred in a riding mishap.

09-20-09⁴ **LATE DECLARATION – REFUND – Sixth Race**

#2 VENITO, trained by Jesus Mendoza, was scratched after Dr. Kerr observed the horse was off on the left front when it reached the starting gate. On Vet's List. Refund was \$6,312.83.

09-20-09⁵ **STEWARDS' INQUIRY – ACCIDENT – NO CHANGE – Sixth Race**

The stewards posted the inquiry sign to review an accident just before the finish line involving #3 **BROTHER JOHN**, ridden by **David Lopez**. The horse broke through the inner turf course rail causing Lopez to be thrown into the break-away rail. After a thorough review the stewards affirmed the order of finish posted on the tote board.

Tapes of the race show that the two year old, who was making his second start and first on the turf, ducked from a right handed whip and broke through the inside rail just before the finish line. Lopez was thrown and landed on a portion of the inside rail. No other horses were involved.

BROTHER JOHN suffered severe lacerations on the right hip which required extensive suturing and will keep the horse off the track for quite some time. Lopez complained of head pain and contusions to his arm but the injuries did not seem serious in nature. He was taken to Highland Hospital for observation.
