11-04-09³ **RULING NO. 6 – HARVEY** (09SW165) (Refer: 10-30-09⁵)

Jockey **BARRINGTON HARVEY** is suspended five (5) racing days (November 13, 14, 15, 18 and 19, 2009) for misuse of the whip while riding FREEDOM EVENT in the seventh race at the Big Fresno Fair on October 9, 2009; a violation of California Horse Racing Board rule #1688 (b) (3) (Use of Whips).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after the Board of Stewards considered the evidence and testimony presented at the hearing held on October 30, 2009.

Three prior whip violations by Mr. Harvey within one year resulted in fines (\$300.00, \$500.00, \$1,500.00) and the Board of Stewards believes this suspension is warranted with stiffer penalties for any further violations.

11-04-09⁴ **RULING NO. 7 – DILLENBECK** (09GG335)

Trainer **BRUCE DILLENBECK**, who started the horse EL GRAN BULL, third place finisher in the third race at Golden Gate Fields on September 30, 2009, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medications, Drugs and Other Substances: Prohibited Substance – Dexamethasone – Class 4).

The above ruling was issued after Mr. Dillenbeck appeared in response to a complaint filed against him alleging a violation of California Horse Racing Board rules #1843 (a & d), #1844 and #1887 (a).

Mr. Dillenbeck's horse, EL GRAN BULL, who finished third in the third race at Golden Gate Fields on September 30, 2009, showed the presence of Dexamethasone (Class 4) in the post race urine sample (GG07314).

Mr. Dillenbeck waived his right to a formal hearing and acknowledged he had treated his horse with Azium 72 hours prior to the race on September 30, 2009.

11-07-09³ **ACCIDENT – INQUIRY – Fifth Race**

The stewards posted the inquiry sign following the fifth race for a review of an accident near 5/16 pole.

#2 HOT TAMALE BABY (Michael Martinez) fell near the 5/16 pole while trailing the field.

Jockey Michael Martinez was uninjured and cleared to ride his remaining mounts on the advice of track physician David Seftel, M.D.

HOT TAMALE BABY suffered a broken left shoulder and was euthanized on the track by track veterinarian Heather Kerr, D.V.M.

11-07-09⁴ **INQUIRY – DISQUALIFICATION – Seventh Race**

The stewards posted the inquiry sign following the seventh race for a review of an incident at the start involving #1 BUCCANEER'S GOLD (Adan Landeros) 7th, and #2 SKY PROSPECTOR (Hector Romero), last.

After reviewing the tapes, interviewing the patrol judges and riders involved, the stewards decided unanimously to disqualify #1 BUCCANEER'S GOLD from seventh to last for coming out into the path of #2 SKY PROSPECTOR, causing the latter to clip heels, stumble and lose all chance of better placing.

11-07-09⁵ **OBJECTION – NO CHANGE – Tenth Race**

The stewards posted the objection sign following the tenth race at the request of jockey Anisete Leon (#2 FRI GUY – 7th) who lodged a claim of foul against #7 ALOTTADAR (Russell Baze) 3rd.

The tapes show #2 FRI GUY steady near the 5/16 pole but were inconclusive as to who was at fault.

The stewards decided unanimously to make no change in the original order of finish.

11-08-09³ **RULING NO. 9 – MARTINEZ**

Jockey **LUIS MARTINEZ** is fined the sum of fifty dollars (\$50.00)* for reporting an incorrect weight on Saturday, November 7, 2009; a violation of California Horse Racing Board rule #1682 (Weighing Out).

The above ruling was issued after Mr. Martinez appeared and apologized for failing to do his reported weight.

11-08-09⁴ **RULING NO. 10 – LANDEROS**

Jockey **ADAN LANDEROS**, who rode **BUCCANEER'S GOLD** in the seventh race at Golden Gate Fields on Saturday, November 7, 2009, is suspended five (5) racing days (November 18, 19, 20, 21 and 22, 2009) for failure to make a proper effort to maintain a straight course leaving the starting gate causing interference resulting in the disqualification of his mount from seventh to twelfth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Landeros and the stewards reviewed the tapes of the seventh race from November 7, 2009.

Mr. Landeros acknowledged he erred in allowing his mount to wander and cause interference and as this is his second riding offense in less than a month a five day suspension is warranted.
