The foregoing rulings were issued as the subjects failed to appear for a hearing regarding a financial complaint filed against them by Kim Kuhlmann, D.V.M., (dba San Francisco Equine) for veterinary services rendered.

The complaint included a Superior Court (Alameda County) small claims judgment (8-20-2010) awarding S. F. Equine \$1,679.30.

10-22-10⁴ **RULING NO. 4 - HALL** (09GG261)

In the matter of:

Trainer **MARK E. HALL**

Having resolved the outstanding financial obligation to San Francisco Equine, trainer MARK E. HALL is deemed eligible for re-licensing and Sonoma County Fair ruling #8, dated August 6, 2009 suspending Mr. Hall for violation of California Horse Racing Board rule #1547 (Failure to Appear), is hereby set aside.

The above ruling was issued as the Board of Stewards received confirmation from San Francisco Equine that Mr. Hall had satisfied his outstanding debt (\$920.58).

10-22-10⁵ **FILM REVIEW**

Apprentice jockey **Carlos Diaz** and the stewards reviewed the tapes of the fourth race from October 21, 2010.

Mr. Diaz made a commendable effort in trying to control his errant mount, #7 ARISTARCHY (Tr. Genaro Vallejo) and the three year old filly was placed on the stewards' list.

10-22-10⁶ **OFF TURF**

Two scheduled turf events, the fourth and seventh races, were switched to the main track as heavy rain has rendered the turf course unsafe.

10-22-10⁷ **OBJECTION – NO CHANGE – Sixth Race**

The stewards posted the objection sign following the running of the sixth race at the request of jockey **Frank Alvarado** (#1 LIL BABY ELSA, 2nd) who lodged a claim of foul against #6 NOISE OF THE CROWD (Juan Hernandez), the winner.

After considering the patrol judge's report, interviewing the riders involved and reviewing the tapes, the stewards decided unanimously to make no change in the original order of finish.

The tapes show #6 NOISE OF THE CROWD drift in, while clear, approaching the 1/16 pole and then inside the 1/16 pole duck out from a left handed whip. Although #1 LIL BABY ELSA may have been inconvenienced, neither incident affected the outcome.

10-22-10⁸ **RACE DELAY – LATE DECLARATION**

There was a delay in the start of the seventh race as #11 MOVIE STAR R.N. (Tr. Jerry Hollendorfer) was reluctant to load in the starting gate for this one mile event.

Starter **Todd Stephens** and his crew attempted various measures to get the six year old mare in the gate without success and requested she be scratched.
