After reviewing the tapes, interviewing the riders involved and considering the patrol judge's report, the stewards dismissed the objection as there was nothing to warrant a disqualification.

The above ruling was issued after Mr. Hernandez and his agent, Ramon Silva, met with the Board of Stewards regarding his claim of foul following the seventh race on Sunday, February 27, 2011.

Mr. Hernandez acknowledged there was nothing to justify his lodging a claim of foul and short of saying he was taking a shot, he now realizes there are consequences to such action.

For good cause (Physical Disability) the apprentice allowance of Abel Cedillo is extended fourteen (14) days and will now expire on May 16, 2011.

The foregoing ruling was issued as Mr. Cedillo provided documents indicating a race related injury that kept him on the sideline for two weeks.

03-04-11⁴ **ANTHONY BAZE** (10SW0134) (Refer 09-30-10)

The Board of Stewards met formally with Deputy Attorney General Allison Ross, representing the California Horse Racing Board and Brian Pitnick, counsel for **Anthony Baze**, the jockey's room color coordinator. CSR Christine Niccoli recorded the proceedings.

The purpose of this meeting was to review a stipulated agreement negotiated between the CHRB (Allison Ross) and Anthony Baze (Brian Pitnick) for final resolution of the complaint filed against Mr. Baze.

The complaint alleged Mr. Baze agreed to change the 'colors' worn by the rider of the horse MUTE RUDOLPH on July 15, 2010 at the California State Fair, Sacramento, California. The colors were not registered to the owner William Wilbur and the change was never reported to any racing authority (Clerk of the Course, announcer, stewards, etc.).

The Board of Stewards noted on the record their approval of the stipulated agreement and will issue a ruling memorializing the terms of the settlement.
