06-05-11<sup>3</sup>**RULING NO. 87 – RAMIREZ**

Groom **ALEJANDRO RAMIREZ** is fined the sum of fifty dollars (\$50.00) for participating at a race meeting without a valid license; a violation of California Horse Racing Board rule #1481 (Occupational Licenses and Fees).

**RULING NO. 88 – HENDERSON**

Trainer **FRANCES HENDERSON** is fined the sum of fifty dollars (\$50.00) for employing an unlicensed person on May 5, 2011; a violation of California Horse Racing Board rules #1482 (Employment of Unlicensed Person) and #1895 (Trainer's Duty to Insure Licensed Participation).

The rulings listed above were issued after Mr. Ramirez and Ms. Henderson met with the stewards and failed to offer reasons that would absolve them of penalties.

06-05-11<sup>4</sup> **RULING NO. 89 – RUSSELL**

Jockey **CHRIS J. RUSSELL**, who rode **ISLE BREEZE** in the sixth race at Golden Gate Fields on Saturday, June 4, 2011, is suspended five (5) racing days (June 12, 16, 17, 18 and 19, 2011) for failure to make the proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The preceding ruling was issued after Mr. Russell met with the stewards, reviewed the race and placed his fate in the hands of the stewards. Five days were issued due to the fact that Mr. Russell will serve a three day suspension for a prior riding infraction starting June 9.

Groom **ANTONIO MENDOZA**, who was cited in California Horse Racing Board complaint 11GG151 for violation of CHRB rule 1922 (Identification Required), was issued a warning. Mr. Mendoza holds a valid license however he had left the license in his room when taking a horse to the receiving barn.

06-09-11<sup>3</sup> **LENZINI HEARING – RULING NO. 90/ SHERLOCK Complaint Dismissed**  
(11GG0135)

Trainer **MICHAEL A. LENZINI**, substitute trainer for the horse **DINNR WITH NIKKI C**, second place finisher in the second race at Golden Gate Fields on April 1, 2011, is fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances: More than one approved medication; Phenylbutazone and Flunixin – [Class 4] ).

The foregoing ruling was issued after Mr. Lenzini met with the stewards and took full responsibility for the double medication violation. The record reflects the horse shipped to Golden Gate Fields to race on March 6, 2011 and raced two more times while under the care of Mr. Lenzini who is the sub-trainer of the horse.

CHRB complaint 11GG0135 filed against trainer **GARY L. SHERLOCK** for alleged violation of the same rules listed in the ruling above for the same horse was dismissed.

06-09-11<sup>4</sup> **RELEASE OF REGISTRATION PAPERS ON CLAIMED HORSES**

Golden Gate Fields has a house rule or condition of a meeting which states:

The foal certificate of all horses claimed at Golden Gate Fields will remain on file with the Racing Secretary for a period of 60 days from the time of the claim.

A meeting was held today attended by this Board, Executive Director Kirk Breed (via telephone), Robert Hartman, Golden Gate Fields Vice President and General Manager, and Racing Secretary Sean Greeley to address issues on the horizon that would affect eligibility and preference dates at future meets for those horses.

The intent of the house rule was to keep horses from being claimed and shipped out of state and it appears the rule has helped to protect the horse population for the meet.

After discussing those issues a subsequent e-mail received from Golden Gate Fields management reported the registration papers would be forwarded to the next race meet at Stockton which resolves those areas of concern.

06-09-11<sup>5</sup> **RULING NO. 91 – HARVEY**

Jockey **BARRINGTON HARVEY** is fined the sum of three hundred dollars (\$300.00) for violation of California Horse Racing Board rule #1688 (b) (1) (Use of Whips) while riding the horse THE LAST SPARK in the fifth race at Golden Gate Fields on June 5, 2011.

The preceding ruling was issued after Mr. Harvey met with the stewards, reviewed the race and failed to offer a valid reason for his continued use of the whip after his mount had obtained its maximum placing.

CHRB complaint 11GG164, filed against owner **Mersad Metanovic** by San Francisco Equine for unpaid veterinary services in the amount of \$4,664.61, was dismissed after Doris Walker, representing San Francisco Equine, reported the debt has been paid in full.

During the term of suspension, all licenses and license privileges of HAROLD WAYNE BARBER are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued after Mr. Barber failed to appear to address two financial complaints; Case #11GG157 filed by trainer **John F. Martin** in the amount of \$11,335.00 for training services and Case #11GG158 filed by **San Francisco Equine** for an alleged debt of \$1,901.00 for veterinary services.

06-11-11<sup>3</sup> **RULING NO. 93 – ZULAICA**

Owner **JOSE ZULAICA**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Friday, June 10, 2011, to answer charges of alleged violations of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending appearance before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of JOSE ZULAICA are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued after Mr. Zulaica failed to appear to address California Horse Racing Board complaint 11GG0159 filed by San Francisco Equine in the amount of \$1,750.50 for unpaid veterinary services.

06-11-11<sup>4</sup> **JOSE GODINEZ Financial Complaint #11GG154** (Refer: 05-30-11<sup>3</sup>)

At the prior hearing referenced above, **Mr. Godinez**, the respondent, was to produce proof of payment to this Board for the amount of \$640.00 and to the complainant, **Miguel Pedraza**, on or before June 8, 2011. After failing to produce those documents he decided to resolve the debt and paid Mr. Pedraza in full.

06-11-11<sup>5</sup> **HUNSUCKER FINANCIAL COMPLAINT #11GG160**

The financial complaint filed against owner **Lester Hunsucker** for a debt of \$1,870.60 was dismissed after Lynette Thompson, representing **Equine Sports Medicine and Surgery** reported the bill has been paid in full.

06-11-11<sup>6</sup> **ACCIDENT – INQUIRY – Eighth Race**

Following the running of the eighth race the inquiry sign was lit for a review of an accident involving #2 CHASE AFTER, ridden by jockey Hector Romero, near the 5/16 pole. After reviewing all the recordings of the accident no change was made to the placings and the race was made official.

The recordings show jockey Hector Romero lose his balance and fall after his mount swerves and suddenly shifts after racing next to the inside rail. Fortunately, due to quick reactions of jockey Frank Alvarado aboard the trailing horse #3 UNDENIABLE FACT, his mount missed the fallen rider. The horse was uninjured and jockey Hector Romero was transported to Highland Hospital in Oakland for further examination. Track physician Dr. David Seftel reported Mr. Romero sustained a severe concussion and would be retained overnight for further observation.

06-12-11<sup>3</sup> **OBJECTION – First Race – NO CHANGE**

Following the running of the first race the objection sign was lit for a review of jockey Russell Baze's #4 PUNCH UP, second place, against the winner #5 PRIMARY NOTICE, ridden by jockey Kevin Krigger, for alleged interference soon after the start. After talking to the riders involved and reviewing the race, the numbers posted were made official.

The recording shows both horses drift inward simultaneously with the rider of #4 steadying his mount momentarily. In the stewards' opinion, the incident did not rise to the level of affecting the placings. The decision was unanimous.

06-12-11<sup>4</sup> **INQUIRY – Ninth Race – NO CHANGE**

The stewards posted the inquiry sign to review the actions of #2 SHOOTIN HIGHER (8<sup>th</sup>, Diego Sanchez) and #4 SPORTS EDITION (3<sup>rd</sup>, Geovanni Franco) as the field came out of the turf course chute and onto the main track course. After a thorough review the stewards took no action with regard to the incident.

Tapes showed SHOOTIN HIGHER drifts out over the heels of SPORTS EDITION causing SHOOTIN HIGHER to clip heels and stumble. Since Sanchez caused his own problems there was no need to alter the placings.
