11-09-12² **TRAINER VALERIE RHODEN MEDICATION WARNING**

Traner **Valerie Rhoden** was in attendance today to address CHRB complaint 12GG156 filed against her for a post race test Phenylbutazone overage (3.20 ug/ml).

Ms. Rhoden was at a loss as to why the horse, JONNY T, tested above the permitted phenylbutazone level. She stated the horse had been tested on a prior occasion and the same administration procedures were followed with the horse testing within the permitted level. She also stated she would make administering adjustments for the horse to insure compliance with the rule. Ms. Rhoden's license history placed this in a warning stage for a Class D penalty and was given a warning.

11-10-12³ **INQUIRY – Fifth Race – DISQUALIFICATION**

Following the running of the fifth race the inquiry sign was posted for a review of the start involving #4 MOJAVE MANDATE (5th, Frank Alvarado), #6 DECISIVE FACT (6th, Francisco Duran) and #8 BLAST THE CAT (4th, Pedro Flores).

After reviewing the recorded views #8 was disqualified from fourth and placed sixth. The recording shows #8 lug inward and drift into #6 and #4, impedes both those horses to the extent that their placings were effected, thus the disqualification. The decision was unanimous.

Sunday11-11-12¹ **CAL-BRED REPORT**

Purse \$10,000. For California bred or California sired three year olds and upward, claiming price \$5,000 at one mile. The race was called off with five Cal-bred entries before it was opened up and used open with eight wagering interests.

11-11-12² **FILM REVIEW – Pedro Flores**

Jockey **Pedro Flores** was in to review the start of yesterday's fifth race. Mr. Flores' horse, #8 BLAST THE CAT, was disqualified for causing interference at the start. The recording shows Mr. Flores exhibit a determined effort to straighten his mount's wayward course with the horse failing to respond to his course corrections. The horse was clearly at fault and Mr. Flores was praised for his efforts.

11-11-12³ **RULING NO. 15 – SHERMAN**

Trainer **STEVE SHERMAN** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to have the horse TIZ HEAT properly shod (Toe grabs on the turf course) necessitating a late scratch in the fourth race on Saturday, November 10, 2012; a violation of California Horse Racing Board rule #1870 (Conditions of Meeting Binding on Licensees).

The ruling listed above was issued after Mr. Sherman contacted the stewards regarding his failure to have his horse properly shod to run on the turf. Mr. Sherman reported the error was due to an oversight by his blacksmith.

11-11-12⁴ **APPRENTICE JOCKEY JUAN SANCHEZ – WARNING ISSUED**

Apprentice jockey **Juan Sanchez** was invited in to review yesterday's eighth race (the stretch run) and was issued a warning about proper use of the whip. The inexperienced Mr. Sanchez was instructed to read the whip rules that are posted in the jockey's room and discontinue the use of the whip on horses that have gained their maximum placing and are way back in the field.

11-11-12⁵ **INQUIRY – Seventh Race – Start**

The inquiry sign was posted for a review of the seventh race start involving #3 PHOTO SHOPPED (unplaced, Frank Alvarado).

After reviewing the recorded views it was determined there was no malfunction of the starting gate therefore the horse was an official starter.

The recordings show the horse caused its own problem after becoming fractious prior to the start and lose its rider after breaking awkwardly and well behind the field. Neither rider nor horse was injured and the horse was caught by the outrider without further incident.
