WEST RULING CASE #08HP018

This ruling was issued after Mr. West telephoned the Board of Stewards and accepted the penalty without argument. He had no explanation for the positive test.

Trainer TED WEST, JR., who started the horse Joy's Comet, the winner of the second race at Santa Anita Park on April 17, 2008, is fined ONE THOUSAND DOLLARS* (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (A) & (D) (Medication, Drugs, and Other Substances – Indomethacin – Class IV).

MULLINS RULING CASE #08HP024

HRTH Ruling #63

Trainer JEFF MULLINS is fined ONE HUNDRED DOLLARS* (\$100.00) for violation of California Horse Racing Board rules #1852 (Reporting to the Receiving Barn – Late) and #1894 (Duties of Trainer) with his horse “Pathbreaking” on May 14, 2008 at Hollywood Park.

Mr. Mullins participated in a telephone hearing in which he stated he was unaware that his help had been tardy to the receiving barn. He said he expected the situation would improve after he deducted the amount of the fine from their paychecks.

The inquiry sign was posted following the finish of the fifth race to review a possible incident approaching the eighth pole involving #3 Mark Set Go (6th T. Baze) and #9 Sweet Dee's (5th J. Talamo). After conversations with the Patrol Judge and both jockeys, and a review of the videos, the vote was unanimous to let the original order of finish stand.

Jockey Baze did have to check, but in the stewards' opinion, his horse was uncomfortable with the direction in which Mr. Baze was trying to send him, and chose to go out on its own.

Trainer JOHN SADLER is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn – late) and #1894 (Duties of Trainer) with his horse Sensational Score on May 14, 2008, at Hollywood Park.

HRTH Ruling #71

Trainer FRANK MONTELEONE is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn – late) and #1894 (Duties of Trainer) with his horse Excessive Tale on May 16, 2008, at Hollywood Park.

CAYO RULING

Ruling #72 was issued after a thorough review with Mr. Cayo in the stewards' office. He was informed that his reaction time in correcting his mount as he left the gate yesterday was unacceptable. He stated he would do better in the future.

HRTH Ruling #72

Jockey DENIS CAYO is suspended for three (3) racing days (June 8, 11, and 12, 2008), for failure to have control of his mount leaving the starting gate, causing interference while riding T.V. Gold in the first race on May 31, 2008. This constitutes a violation of California Horse Racing Board rule #1699 (d) and (f) (Riding Rules – Careless Riding).
Terms of suspension shall not prohibit participation in designated races.

KITCHINGMAN RULING – CASE 08HP034

HRTH Ruling #73

Trainer ADAM KITCHINGMAN is fined THREE HUNDRED DOLLARS (\$300.00)* for failure to handle his business in a proper manner – late submission of a scratch request. California Horse Racing Board rule #1530 (Cases Not Covered by Rules or Regulations).

This ruling was published after a telephone hearing wherein Mr. Kitchingman stated he “dropped the ball” by not confirming that his practicing veterinarian had reported his horse’s illness to the official veterinarian.
