**MINUTES – TWELFTH WEEK of HOLLYWOOD PARK SPRING MEETING**

**WEDNESDAY  
07/09/08<sup>1</sup>**

**GARCIA RULING**

**HRTH Ruling #118**

Trainer JUAN GARCIA, who started the horse "Downtown Lover" the winner of the eleventh race at Hollywood Park on June 7, 2008, pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse), is fined FOUR HUNDRED DOLLARS\* (\$400.00) for violation of California Horse Racing Board rule #1844 (c) (more than one approved drug substance -Phenylbutazone and Flunixin).

This ruling was issued after assistant trainer Victor Garcia appeared representing trainer Juan Garcia. He stated that Mr. Garcia did not have an explanation as to how this double NSAID occurred due to the fact they do not have Flunixin available in the barn.

**KORINER RULING**

**HRTH Ruling #119**

Trainer BRIAN KORINER, who started the horse “Bewitching Bartok” the third place finisher in the first race at Hollywood Park on May 30, 2008, pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse), is fined FOUR HUNDRED DOLLARS\* (\$400.00) for violation of California Horse Racing Board rule #1844 (c) (more than one approved drug substance -Phenylbutazone and Flunixin).

A telephone hearing with Mr. Koriner was held during which the trainer said that “Bewitching Bartok” had been treated with Flunixin 48 hours prior to post time, which is the standard treatment for all runners from his barn. Therefore, he was unable to explain how this double NSAID occurred.

**INQUIRY SECOND RACE – NO CHANGE**

Following the running of the second race the inquiry sign was posted to review a possible infraction approaching the 1/8 pole involving #4 Red Ticket (1<sup>st</sup> Martin Garcia), #5 Quarter Moon (2<sup>nd</sup> Michael Martinez), and #9 Norco Pal (3<sup>rd</sup> Isaias Enriquez). After a review of the films, and conversations with the Patrol Judge and all the aforementioned jockeys, it was a unanimous decision to allow the original order of finish to become official. The #4 horse drifted in taking the path of the #5 horse, closing the opening before #5 could establish his position. #9 bumped and impeded #4 turning for home, but ultimately finished behind that horse, therefore no change was made to his placing.

**FILM REVIEW**

Jockey Martin Garcia visited the stewards to review Wednesday's second race. Mr. Garcia's mount drifted with marginal clearance. He left the office without penalty, vowing to do a better job in the future.

**07/10/08<sup>2</sup>**

**ENRIQUEZ RULING**

This ruling was posted after Mr. Enriquez came to the Stewards' office and fell on his sword. He humbly admitted that he made poor decisions during the running of the race and accepted his penalty without further comment.

**HRTH #120**

Jockey ISAIAS ENRIQUEZ is suspended for three (3) racing days (July 17, 18 and 19, 2008) for altering course without sufficient clearance, causing interference while riding "Norco Pal" in the second race at Hollywood Park on July 9, 2008. This constitutes a violation of California Horse Racing Board rule #1699 (d) and (f) (Riding Rules – Careless Riding). Terms of suspension shall not prohibit participation in designated races.

**VILLALOBOS RULING**

This ruling was issued after Ms. Villalobos appeared to address her failure to attend a hearing involving a domestic violence issue at the Santa Anita meeting. She stated that there had been a verbal confrontation with her boyfriend, with whom she was living. She was unaware her license had been suspended until she recently applied for renewal.

**HRTH #121**

Groom MARIA VILLALOBOS, having appeared before the Board of Stewards, is restored to good standing. LATS ruling #23, issued at Santa Anita on January 14, 2008, is set aside. Furthermore, Ms. Villalobos is fined FIFTY DOLLARS\* (\$50.00) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

**BLANCO RULING**

**HRTH #122**

Exercise rider PETER BLANCO, having appeared before the Board of Stewards, is declared eligible for licensing. OTTS Ruling #45, issued at Oak Tree Racing Association on November 04, 2005, is set aside with the following conditions:

- Subject shall remain on probation for the term of his license.
- Subject shall follow guidelines set forth by Winners' Foundation.
- Subject shall sign a testing agreement with the California Horse Racing Board.

After Mr. Blanco appeared for a fitness hearing, this ruling was published. In attendance, in addition to the Board of Stewards, was Senior Investigator Frank Fink and Winners' Foundation representative Bob Fletcher. After hearing all testimony, Mr. Blanco was declared eligible to be licensed with conditions attached.

**FLORES RULING**

**HRTH #124**

Trainer FRANCISCO FLORES is fined THREE HUNDRED DOLLARS\* (\$300.00) for violation of California Horse Racing Board rule #1845 (a) (Authorized Bleeder Medication) at Hollywood Park on July 11, 2008.

This ruling was issued as Mr. Flores advised the stewards that he did not have a lasix slip on file with the receiving barn before he made his entry.

**JOCKEY OBJECTION THIRD RACE – NO CHANGE**

Following the running of the 6 furlong contest, jockey Martin Garcia (#1 Paper Gain 7<sup>th</sup>) claimed foul against Clinton Potts aboard #2 More Humor, 5<sup>th</sup> place finisher, for interference at the five and one half furlong marker. After a review of the films and conversation with all jockeys involved, the stewards agreed that while Mr. Garcia had to check and take up, the pressure was being applied by #6 Wiredfortwotwenty (1<sup>st</sup> Joe Talamo), from the outside in a reverse stair step formation with three horses to his inside. When this configuration occurs, it is difficult to blame one particular rider; therefore the original order of finish was made official.

**INQUIRY NINTH RACE - NO CHANGE**

As the horses crossed the finish line, the stewards posted the inquiry sign to review the start. #5 Storm Anna reared and lunged as the gates opened, unseating apprentice jockey Michael Martinez; simultaneously, #12 Kessum Memories stumbled leaving the gate and dislodged rider Martin Garcia. The stewards agreed that both mishaps were initiated by the horses themselves, and declared the race official with no change. Accident reports attached.
