**MICHAEL MITCHELL HEARING**

Trainer MICHAEL MITCHELL appeared informally before the Stewards to discuss California Horse Racing Board case #09SA11 involving the horse “Legs Eleven”, the fifth place finisher in the third race at Santa Anita on March 26, 2009. The complaint alleged that the level of the Class 4 drug Phenylbutazone (5.80 ug/ml) was above the permitted limit in the post race blood sample. Mr. Mitchell felt the filly was thin and small of stature, perhaps explaining why the drug did not fully metabolize out of her system. The following Ruling was issued:

**HRT#004**

Trainer MICHAEL MITCHELL, who started the horse “Legs Eleven” which finished fifth in the third race at Santa Anita Park on March 29, 2009, is fined FIVE HUNDRED DOLLARS\* (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1844 (c) (1) (Authorized Medication –Phenylbutazone -Class IV, in excess of permitted level) and rule 1843 (a) (d) (Medication, Drugs and Other Substances).

**JOCKEYS REVIEW FILM**

Jockey VICTOR ESPINOZA met with the Stewards to review his ride aboard “Lanie’s Way” in Sunday’s fourth race. The horse shifted out turning for home, from left hand urging. Mr. Espinoza was cautioned to make a better effort going forward.

Jockey TYLER BAZE appeared to discuss two separate incidents from Sunday’s card. In the eighth race, Baze’s mount “Awesome Gem” made contact with “Wordly” at the sixteenth pole. Upon review, the Stewards felt there was mutual contact between both horses. The jockey finished first with “Seeuat Sticknstein” in the opener, but was disqualified to second for interference. Baze’s mount drifted out at the eighth pole from left hand urging, causing place horse “Gate to Wire” (R.Bejarano), to steady. Mr. Baze felt he should have gathered his horse earlier, prior to urging him. The Stewards deemed a three-day suspension was in order, as follows:

**HRTH #005**

Jockey TYLER BAZE, who rode Seeuat Sticknstein in the first at Hollywood Park on April 26, 2009, is suspended for THREE RACING DAYS (May 6, 7 and 8, 2009) for altering course without sufficient clearance, causing interference which resulted in disqualification of his mount from first to second position. This constitutes a violation of California Horse Racing Board rule # 1699 (Riding Rules- Careless Riding).

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule # 1766 ( Designated Races).

Mr. Rudd was cited by Santa Anita Stable Security Officer Franco, on April 16, 2009 at Santa Anita Park. Mr. Rudd offered no excuse. The following rule was issued:

**HRTH #006**

Exercise rider **JEFFREY RUDD**, is fined **FIFTY DOLLARS (\$50.00)\*** for smoking in the shed row, pursuant to California Horse Racing Board rule # 1437 (Conditions of Race Meeting).

**JOCKEY ALTERCATION**

Jockeys OCTAVIO VERGARA and DANNY SORENSON participated in an informal hearing to discuss a report of an altercation between the two riders in the jockeys' room between races yesterday. It appears that Mr. Sorenson had said something to Mr. Vergara's wife while walking back to the room that Mr. Vergara interpreted as an insult. Mr. Vergara followed Mr. Sorenson into the room and either punched or slapped him. After listening to both jockeys, we issued the following ruling:

**HRTH Ruling #008**

Jockey **OCTAVIO VERGARA**, is fined **TWO HUNDRED DOLLARS (\$200.00)\*** for violation of California Horse Racing Board rule #1874(Disorderly Conduct-altercation in Jockey's Room) following the seventh race on May 2, 2009.

**BECA HEARING**

Exercise rider JOSE BECA appeared in the office in response to complaint filed by the CHRB alleging that Mr. Beca had entered the women's restroom. Mr. Beca admitted that it is a normal practice of his because he believes that it is cleaner than the men's room. The following ruling was issued:

**HRTH Ruling #007**

Exercise rider **JOSE BECA**, is fined **FIFTY DOLLARS (\$50.00)\*** for violation of California Horse Racing Board rule #1874(Disorderly Conduct).

**JOCKEYS MEETING**

The stewards mediated a discussion between the jockey colony and Hollywood Park management that concerned the condition and maintenance of the track surface. The jockeys were able to put forth their concerns and management seemed amenable to suggestions.

05/03/09<sup>4</sup>

**INQUIRY/DISQUALIFICATION**

The stewards posted the inquiry sign following the third race to examine an incident at the eighth pole in which #8 Warrensgoodwarrior was bumped, fell and unseated her rider, Pedro Arambula. Video tapes revealed that the winner #3 Lunch Money, ridden by Jesus Rios, angled out in mid-stretch, forcing #7 Spirited Lady into #8 Warrensgoodwarrior, who then fell. After speaking with the patrol judges and riders involved, the stewards unanimously voted to disqualify the winner and move her to unplaced.

**INQUIRY/NO CHANGE**

Following the running of the fourth race, the stewards posted the inquiry sign to examine an incident at the eighth pole on the turf course in which the eventual winner appears to crossover in front of the second place finisher, causing that rival to check. Films revealed that the winner #7 Ocean Style, ridden by David Flores does drift in slightly while not clear, but films also revealed that #3 Mean Heat, ridden by Corey Nakatani, drifts out slightly. Since both horses contributed to the problem, no change was appropriate. While unnecessary given the analysis, the stewards further believed that the second place finisher was not cost the opportunity at a better placing. After speaking with the patrol judges and riders involved, the stewards unanimously voted to make no change.
