WEST RULING

Trainer TED WEST contacted the stewards by telephone to answer case number 09SA195 which embodied a complaint filed by the Official Veterinarian for being late to the receiving barn with one of his runners. He explained that his horse required a bath which made him late. Despite the explanation, we issued the following ruling as he had been warned in the recent past:

Trainer **TED WEST**, is fined **ONE HUNDRED DOLLARS (\$100.00)*** for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn-Late) and #1894 (Duties of Trainer) with his horse "Wickednwackyngrid" in the third race on October 12, 2009.

Jockey agent BRADLIE BAGGETT failed to appear at a scheduled hearing on Sunday based on a complaint (case number 09PM026) filed by Juan Sandoval in the amount of \$1,900.00. The following ruling was published:

During the term of suspension, all licenses and license privileges of Bradlie Baggett are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Baggett is denied access to all premises in this jurisdiction.

ROSARIO HEARING

The stewards held a formal hearing this morning into a complaint (case number 09PM001) that was filed by the CHRB against jockey JOEL ROSARIO alleging violation 1884 (Unsatisfactory Rides), 1692 (Requirements for Horse, Trainer and Jockey) and 1902 (Conduct Detrimental to Racing). The complaint centered around a ride at Del Mar in which Mr. Rosario’s mount finished fourth. Stewards Randy Winick, Albert Christiansen, and Kim Sawyer presided over the hearing (Stewards Scott Chaney and Tom Ward were considered to have conflicts as witnesses). The Board was represented by a Deputy Attorney General and Mr. Rosario was represented by attorney Roger Licht. Safety steward Luis Jauregui testified as a witness for the CHRB and trainer Gary Stevens and Jockey Guild representative Darrell Haire were taken out of order and testified on behalf of the Respondent. The hearing was closed for the day and second day was scheduled for December 3.

FINLEY HEARING AND DECISION

Dr. JENNIFER FINLEY contacted the stewards by telephone this morning regarding case number 09SA207 which involved a complaint filed by the Official Veterinarian alleging violation of CHRB rules 1842, 1843.5, concerning incorrect confidential reports. Dr. Finley explained that she had made a mistake and pledged that it would not happen again. A warning was issued.

CARAVA HEARING AND RULING

Trainer JACK CARAVA contacted our office in an informal hearing this morning to answer case number 09SA192 which was a complaint filed by the CHRB alleging that one of Mr. Carava’s runners’ blood sample contained an amount of Phenylbutazone in excess of the permitted level. Mr. Carava explained that the horse had been on oral bute before its entry and the cumulative nature of the administrations could have contributed to the positive. The following ruling was issued in accordance with the medication penalty guidelines:

HRTH #003

Trainer **JACK CARAVA**, who started the horse “Headache” which finished second in the second race at Santa Anita Park on September 30, 2009, is fined **FIVE HUNDRED DOLLARS* (\$500.00)** pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1844 (c) (1) (Authorized Medication –Phenylbutazone -Class IV, in excess of permitted level) and rule 1843 (a) (d) (Medication, Drugs and Other Substances).

GEORGIADIS RULING

Owner FOTIS GEORGIADIS failed to appear for a hearing (case number 09SA211) which was a financial complaint filed by Southern California Equine Foundation in the amount of \$562.97 for an unpaid bill incurred for veterinary services. The following ruling was therefore issued:

Owner **FOTIS GEORGIADIS**, having failed to appear before the Board of Stewards to answer a complaint alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility-Southern California Equine Foundation \$562.97), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Fotis Georgiadis are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Georgiadis is denied access to all premises in this jurisdiction.

BRANDENBURG DECISION

The following ruling was issued regarding the BRANDENBURG hearing referenced last week (see 11/15/09²).

HRTH #006

Veterinarian **KRISTIE BRANDENBURG**, is fined **THREE THOUSAND DOLLARS (\$3,000.00)*** and suspended for thirty (30) days (November 27, 2009 thru December 26, 2009) for violations of California Horse Racing Board rules #1842 (Veterinarian Report), #1843.5 (c)(g)(Medications, Drugs and Other Substances Permitted After Entry in a Race) and #1629 (Penalty For Late Declaration) which resulted in the declaration of eleven mules from the first and second races at Fairplex Park on September 17, 2009, and the subsequent cancellation of said races.

During the term of suspension, all licenses and license privileges of Kristie Brandenburg are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), she is denied access to all premises in this jurisdiction.

TARABA HEARING

Veterinarian **KEITH TARABA** appeared this morning to answer case number 09SA212 which involved a complaint filed by the Official Veterinarian alleging that he had turned in his confidential veterinarian reports after the required time. Dr. Taraba admitted to the error and explained that he had a fax machine malfunction. Decision to follow.

AREVALO HEARING

Hollywood Park security referred Auto Tote employee to us this morning after issuing a citation alleging speeding in the parking lot. Mr. Arevalo admitted to the speeding and accepted the following ruling:

Auto Tote employee **WILLIAM AREVALO** is fined **FIFTY DOLLARS (\$50.00)*** pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations-Speeding in Parking Lot).

BACKSIDE ALTERCATION

Grooms **MOISES BARAJAS** and **ARCENO CATALAN** were referred to our office by Hollywood Park security for an altercation on the backside. It appeared that there was some drinking involved and a continuing argument about the respective relative merits of their home countries. Both men worked for trainer Carl Callaghan. After consulting with Winners Foundation and their employer, we issued the following two rulings:

HRTH #008

Groom **ARCENO CATALAN** is fined **ONE HUNDRED DOLLARS (\$100.00)*** and placed on probation through July 31, 2010 for violation of California Horse Racing Board rule #1874 (Disorderly Conduct-Fighting in Shed Row) on November 16, 2009.

HRTH #009

Groom **MOISES BARAJAS** is fined **ONE HUNDRED DOLLARS (\$100.00)*** and placed on probation through August 31, 2010 for violation of California Horse Racing Board rule #1874 (Disorderly Conduct-Fighting in Shed Row-Intoxication) on November 16, 2009.

Furthermore, Mr. Barajas must comply with the guidelines of the contract set forth by the Winners's Foundation.

TILLEMA HEARING

Owner **HAROLD TILLEMA** met with the stewards in an informal hearing this morning to answer case number 09SA226 which was a complaint filed by the CHRB alleging violations of rules and regulations pertaining to syringe possession on the backside. Evidence showed the CHRB discovered a syringe and needle during a routine search of Mr. Tillema's truck on the backside. Mr. Tillema explained that he had tranquilized a horse that he had shipped in from the ranch and claimed that he didn't know that syringes in the hands of a person other than a veterinarian violated CHRB rules. Apparently, the CHRB had not received the test results from the syringe residue, so the record was held open until those results could be obtained. Decision to follow.

OBJECTION/NO CHANGE

Following the running of the sixth race, jockey **VICTOR ESPINOZA**, who rode third place finisher #2 Oldtophatandtails, claimed foul against the winner, #8 Scottish Diamond, alleging interference in the sixteenth pole. Mr. Espinosa claimed that the winner drifted out into his path nearing the wire. Films revealed that the winner does drift out slightly but that Mr. Espinoza was guiding his horse into a space between horses where there was not sufficient room. Therefore, after speaking with both riders and patrol judges, we unanimously voted to make no change to the original order of finish.
