VIZCARRA HEARING

A fitness hearing (case number 08HP009) was held today concerning DAVID VIZCARRA, who currently holds a CHRB license in the category of laborer. Mr. Vizcarra was convicted of a felony in 2008, served jail time, and is still on probation. His license expires on June 30, and apparently he believed that having the fitness hearing before the expiration would put him a better position to retain his license. ED Kirk Breed issued a directive last year that precluded a person who had a felony conviction from holding a license for five years after probation for the conviction had expired. It is our view that, given the conviction, any action we take would be moot, because upon renewal of the license, Mr. Vizcarra would automatically be denied and would have to appeal that decision to a hearing officer as outlined in Mr. Breed's directive. Therefore, no action was taken with respect to the complaint.

QUINONEZ HEARING

Jockey ALONSO QUINONEZ came to the office as directed by a complaint issued by the CHRB alleging violation of CHRB rule 1688 (Use of Whips). An informal hearing was held to determine if Mr. Quinonez had caused welts on his mount during the running of the sixth race on May 1 at Hollywood Park. With photographic evidence of the welts and the films of the race indicating that Mr. Quinonez appeared to make contact in the sensitive stifle area, Mr. Quinonez didn't offer a defense. Decision to follow.

McLAUGHLIN HEARINGS

Veterinarian LESLIE McLAUGHLIN came to the office for an informal hearing to answer two complaints (case numbers 10HP070 and 10HP076) which allegedly involved some paperwork errors with respect to veterinary services she had performed. The first complaint alleged that Dr. McLaughlin had turned in a bleeder slip late on one of the horses that she had treated with lasix for the races. She explained that she had turned in approximately twenty other slips on time but found the missing slip on the floor of her truck when contacted by the receiving barn. The second complaint alleged that Dr. McLaughlin had written a bute treatment for a runner listed on her confidential that she didn't give. She explained that she had gone into the barn to do the treatment, wrote it on her confidential but then had to tend to an emergency. One of her partners then gave the bute and correctly wrote it on his confidential. Decision to follow.

NIGHT RACING

FILM REVIEW

Jockey JOEL ROSARIO came to the office to discuss his ride in the third race last Sunday in which his mount drifted off of the fence turning for home, inviting a rival to attempt a pass on the inside, but then drifted back down to the rail as the horses were straightening out for their stretch run. Although there will be some movement at this point of the race when horses are changing leads, and the rival jockey (Victor Espinoza) handled the situation particularly well, we warned Mr. Rosario that this type of riding could result in suspension days in the future.

QUINONEZ RULING

The following ruling was issued after careful consideration of case number 10HP031 which alleged jockey ALONSO QUINONEZ violated the whip rule as described in 6/27/10²:

Jockey **ALONSO QUINONEZ** is fined **FIVE HUNDRED DOLLARS (\$500.00)*** for violation of California Horse Racing Board rule #1688 (Use of Whips-causing welts or breaks in skin-2nd offense) during the running of the sixth race at Hollywood Park on May 1, 2010.

McLAUGHLIN WARNING AND RULING

Veterinarian LESLIE McLAUGHLIN was issued a warning for the lasix slip infraction referenced in 6/27/10³ and was issued the following ruling with respect to the improper confidential in that same entry:

Veterinarian **LESLIE McLAUGHLIN** is fined **TWO HUNDRED DOLLARS* (\$200.00)** for violation of California Horse Racing Board rule #1842 (Veterinarian Report-incorrect confidentials).
