FINANCIAL HEARING CASE #10DM031

This complaint was filed by trainer Gus Headley involving a possible violation of CHRB rule 1876 (Financial Responsibility). In attendance were respondents-owners Ken Feher, Al Mizrahie, Dennis Alfieri, while owner Mary DiPietro was unavailable. Mariann Mizrahie sat in as an observer. Attorney Suzanne Porrazzo was available and represented the complainant.

Copies of training bills for the last three months were made available, distributed to the owners and the value of the three horses involved were discussed. The hearing was continued and will be rescheduled after the appropriate time for this information to be assessed by all parties involved.

CHITRAKAR HEARING CASE #10DM032

April Chitraker DVM reported to the Stewards' office for a formal hearing (requested by respondent) involving a possible violation of CHRB rule 1842 (Veterinarian Report). The complaint alleged that Dr. Chitrakar had inadequately included a treatment on her confidentials that she ultimately didn't perform. Representing the CHRB was Senior Special Investigator Jim Hamilton, also in attendance was Safety Steward Luis Jauregui. The hearing was recorded by Court Reporter Barbara Weinstein. The respondent was sworn in, and testimony was heard. It was in the Steward's opinion that this being Dr. Chitrakars' first offense in accordance with rule 1842 that an official warning was the appropriate penalty.

BROKKEN RULING

OTTH #005

Veterinarian **TODD BROKKEN, DVM** is fined **FIVE HUNDRED DOLLARS (\$500.00)*** for violation of California Horse Racing Board rule #1844 (Authorized Medication-double treatment).

This ruling was issued after practicing veterinarian Todd Brokken admitted he mistakenly treated a horse that had already been medicated to race.

MILLER HEARINGS CASE #10DM034 AND 10DM035

These two cases were conducted formally and recorded by Court Reporter Barbara Weinstein.

The first was a complaint filed against trainer Peter Miller by Official Veterinarian Jill Bailey, alleging violations of CHRB rules 1874 (Disorderly Conduct) 1854 (Exclusion From Receiving and Detention Barn), and 1930 (Obedience to Security Officers and Public Safety Officers). This case involved allegations of Mr. Miller bringing an alcoholic beverage into the Receiving Barn and becoming uncooperative when directed to leave. Senior Supervising Investigator Jim Hamilton representing the CHRB presented the case and Official Veterinarian Jill Bailey was available for testimony. All parties were sworn in, testimony was heard and the hearing was closed. Decision to follow.

The second case involved a possible violation of CHRB rule 1437 (Conditions of a Race Meeting). This case concerned a Del Mar Turf Club turf shoe policy. Mr. Miller's horse had worked on the turf course in the AM, and it was later discovered the horse had toe grabs on his hind shoes. Mr. Miller stated he had just claimed the horse in question and had checked the front shoes but not the hind shoes prior to the workout. All testimony will be taken into consideration and a decision will follow.

A complaint was filed by Official Veterinarian Jill Bailey for a possible violation CHRB rule 1852 (Reporting to Receiving Barn) and 1894 (Duties of Trainer) against trainer Peter Miller for being late to the Receiving Barn with one of his runners. Mr. Miller was issued a formal warning when the printout of licensee's license history attached to the complaint provided information that was ambiguous regarding a similar violation.

WINICK SETTLEMENT CASE #10PM006

This financial complaint was filed by Amy Nevens DVM against trainer Debbie Winick with a notice of entry of judgment from the Pomona Court House (small claims case no. POM 10S00846) in the amount of \$1,715.22, court cost included. A financial agreement was signed by both parties and the complaint was withdrawn.

RACE DELAY AND CARD CANCELLATION

Due to a torrential downpour of rain this AM the post time for the first race was delayed thirty minutes in order for track maintenance to make sure the cushion surface was in order. Representatives from the jockey colony which included Corey Nakatani, Joe Talamo, Mike Smith and David Flores went to an area on the track across from both gaps near the half mile marker and again near the five eighths pole to inspect the surface. The water run off from the stable area was channeled down the gaps and washed across the track at these two locations. The jockey colony unanimously agreed that the track at this time was unsafe for racing. All departments were notified at 1:45 PM that a cancellation had occurred.
