JOCKEY OBJECTION SEVENTH RACE (6 furlongs-turf)/NO CHANGE

Following the running of the race jockey Rafael Bejarano aboard #1 Robie the Cat (2nd) claimed foul against #7 Ain't No Other (Patrick Valenzuela 1st) for possible interference in the lane. After conversation with the Patrol Judge and both jockeys involved it was a unanimous decision to let the original order of finish stand. It was the Stewards' opinion that #7 did race erratically in the stretch, but there was no evidence that it impeded the #1 horse.

HRTH #001

Trainer **RUBEN GOMEZ** is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication-late registration) in the eighth race at Hollywood Park on April 21, 2011.

FILM REVIEW

Jockey Patrick Valenzuela met with the Stewards to review and discuss races from Thursday and Friday. Although none of the incidents warranted days it was made clear he needs to be more aware and make better efforts. He agreed with this advice and promised to get back on track.

Jockey Chantal Sutherland joined the Stewards to review the second race on April 21, 2011. Ms. Sutherland admitted she should have been more aware of her surroundings prior to shifting out for the stretch drive. She assured the BOS that she would make better efforts in the future and left the office without penalty.

APPRENTICE JOCKEY APPLICATION

Richard Humberto Aguilar Aragon met with the Stewards with his soon to be agent "Pepe" Aragon. He came before the Stewards applying for an apprentice jockey license. The documents raised some suspicion. Mr. Aragon was given the opportunity to produce more information verifying he started as an apprentice in 2009 and not 2007 as documented from the El Gerente De Hipodromo Del Jockey Club Del Peru Certifica. INQUIRY TENTH RACE (6 ½ furlongs-cushion) NON-STARTER

The inquiry sign was posted after it was apparent that #13 Chokeycherymary, with jockey Chantal Sutherland aboard, was not in the starting gate when the field was dispatched. The stewards received a message via the radio from starter Gary Brinson during the running of the race that indeed #13 was still behind the gates. After a review of the video replay of the start it was verified that while #13 was being led into the gate, the doors opened for the start of the race. In accordance with CHRB rule #1696, #13 was declared a non-starter and the race was made official.
