**CERIN FORMAL HEARING CASE #18SA0120**

A complaint was filed by the CHRB against trainer VLADIMIR CERIN for violation of CHRB rules 1843 (a)(d) (Medication, Drugs and Other Substances), 1844(c) (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1843.1 (b) (Prohibited Drug Substances).

Present before the BOS were, trainer Vladimir Cerin, representing the CHRB Supervising Investigator Phillip Miyazaki, court reporter Michelle Derieg recorded the proceedings and Safety Steward Paul Atkinson sat in as an observer.

Mr. Cerin's runner ROMAN TIZZY who finished third in the first race on April 13, 2018 at Santa Anita Park post-race tested, a level of Phenylbutazone (1.08 ug/ml) and Flunixin (18.6 ng/ml) this is a double NSAID positive which was analyzed by UC Davis Laboratory. It is a Class "4" drug with a Category "C" penalty.

Mr. Cerin had no explanation how this double medication occurred. Decision to follow.

**INQUIRY / ACCIDENT / SECOND RACE - 5/8**

Following the running of the race the inquiry sign was posted to review an accident that occurred near the 3/8 pole. Involved were #1 I'LL WRAP IT UP (S. Gonzalez DNF) who fell on its own and #2 TEMPLAR (T. Pereira DNF) could not avoid #1 and fell unseating its jockey. After a review of the available video the original order of finish was made official. Both Tiago Pereira and Santiago Gonzalez were removed from the remainder of their mounts. Mr. Pereira was transported to UC Irvine for further evaluation and Mr. Santiago refused the recommendation of further evaluation.

**VOIDED CLAIMS**

**CERIN RULING Ref 07-12-18<sup>2</sup>**

Mr. Cerin was issued the minimum penalty for a second offense in one year of a class four drug violation. This category C penalty is listed in the ruling issued below.

**INQUIRY / NO CHANGE / FOURTH RACE - 3/4**

Following the running of the race the inquiry sign was posted to review an accident leaving the starting gate. Involved were #4 IRISH BALLAD (K. McDaid DNF) who broke out sharply and #6 JUNE SIXTH (D. Sanchez 4th) who broke in sharply. Their hard contact with #5 IMAGINEIAMFASTEST (T. Connor 2nd) caused apprentice Kelly McDaid to lose connection with her mount and fall off. The track physician cleared her to ride the remainder of her mounts. The loose horse hit the outside fence near the paddock, was caught by the outrider and ambulance removed at the direction of Racing Veterinarian Dana Stead. As the fouled horse (#5) beat #6 there was no change to the order of finish and the race was made official.

**LATL RULING # 006**

Jockey HERIBERTO FIGUEROA is fined THREE HUNDRED DOLLARS (\$300.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – third offense; second offense on May 28, 2018), during the seventh race at Los Alamitos Race Course on July 13, 2018.
