Report of the Board of Stewards for the week of January 29, 2008 through February 2, 2008.

TUESDAY
01/29/2008

(1) DUTY STEWARD

Martin Hamilton was the duty Steward this week attending to all morning office duties and was responsible for recording the minutes during this reporting period.

(2) SCRATCHES FOR THURSDAY

One rider change was the only change for Thursday's program.

(3) ENTRIES FOR FRIDAY

Ten races were drawn for Friday consisting of four Thoroughbred and six Quarter Horse races. The draw was completed at 2:30 p.m.

(1) SCRATCHES FOR FRIDAY

One declaration, one equipment change and two rider changes were approved at the 9:00 a.m. scratch time for Friday.

(2) ENTRIES FOR SATURDAY

One Arabian, two Thoroughbred and eight Quarter Horse races make up Saturday's eleven race card, drawn at 1:30 p.m.

(1) SCRATCHES FOR SATURDAY

Two rider changes were the only changes made at the 9:00 a.m. scratch time for Saturday.

(2) RULINGS # 28- # 39

The above noted rulings were issued in regards to minor parking violation citations handed out by Los Alamitos Security.

(3) NEW JOCKEY

Exercise rider Santiago Mendez presented himself to the Board of Stewards today with an application for a jockey's license. All the finer aspects of being a jockey were discussed and all the paperwork was in order. The 20 year old waived his opportunity for an apprentice jockey license as he tacks 124 pounds. According to all queries, Mr. Mendez has demonstrated that he has a bright future.

(4) CAL-BRED REPORT

The Cal-Bred race written for mares four years old, claiming price \$8,000, at a distance of 300 yards received no entries.

This evening's eight race program progressed quietly without significant incident.

(1) DOMINGO RAMIREZ HEARING CONTINUED (REFER 01/26/08 (5))

Case # 08LA0003 for exercise rider Domingo Ramirez was reconvened this afternoon. Mr. Ramirez is accused of violation of California Horse Racing Board rules #1874 (disorderly conduct) and #1902 (conduct detrimental to horse racing).

Following testimony from remaining witnesses and at the conclusion of closing statements, the record was closed and the matter taken under submission for decision.

(2) RODOLFO VIRAMONTES RULINGRULING # 40

TRAINER RODOLFO VIRAMONTES IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1629 (PENALTY FOR LATE DECLARATION) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1588 (J) (HORSE INELIGIBLE TO START IN A RACE).

The above ruling was issued when trainer Viramontes failed to have the horse "Zoomo" on the association grounds 24 hours prior to the eighth race on Thursday, January 31, 2008 necessitating a late declaration. Said horse was vanned in from an unapproved stabling facility.

(3) JUAN LOPEZ RULINGRULING # 41

EXERCISE RIDER JUAN C. LOPEZ IS FINED TWENTY FIVE DOLLARS (\$25.00)* FOR VIOLATION OF STABLE AREA PARKING REGULATIONS. CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS).

The foregoing ruling was written when exercise rider Juan Lopez appeared after being cited for illegally parking in the trainer's parking lot. Mr. Lopez acknowledged the error.

(4) CAL-BRED REPORT

The Cal-Bred race offered for four year olds, claiming price \$4,000, going 300 yards failed to fill with only one entry received.

(5) INQUIRY – SIXTH RACE – DOUBLE DISQUALIFICATION

Following the sixth race (330 yards – Quarter Horse) the Stewards illuminated the Inquiry sign in order to review an observed incident at the start.

Films show # 3 "Rico Cake" (3rd – jockey J.R. Ramirez) came out while # 5 "Ima Strawfly" (4th – jockey Ramon Sanchez) came in and jostled # 4 "La Michoacana" (6th – Rodrigo Aceves) repeatedly costing the latter all chance at a better placing.

Following a thorough film review and after talking to the riders involved, # 3 and # 5 were disqualified from third and fourth and placed fifth and sixth, respectively, in a unanimous decision.

(6) INQUIRY – NINTH RACE – NO CHANGE

Following the ninth race, the Stewards posted the Inquiry sign to assess contact 100 yards after the start between # 2 "Philadelphia Patriot" (6th – jockey Sam Thompson) and # 1 "Gomez Palacio" (8th – jockey Eddie Garcia).

Films show # 2 ducked in and made contact with # 1, however, in the unanimous opinion of the Stewards, the incident did not rise to the level of disqualification and no change was made in the placings.

(2) ALEX BAUTSITA RULINGRULING #42

JOCKEY ALEX BAUTISTA IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1688 (USE OF WHIPS – WHIPPING IN POST PARADE) IN THE SEVENTH RACE ON FEBRUARY 1, 2008.

The foregoing ruling was issued when Alex came in and pleaded no contest to whipping his mount in the post parade prior to the second race last evening. Mr. Bautista was assured that future instances would bring increased penalties.

(3) CAL-BRED REPORT

The Cal-Bred race offered for mares four years old and upward, claiming price \$2,500, at a distance of 300 yards was called off with two entries passing the box.

(4) ROUTINE EVENING

This evening's eleven-race program was conducted with all matters being of routine nature.
