**TUESDAY**

(1) DUTY STEWARD

TRAINER FELIX GONZALEZ IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION, UNLICENSED OWNER) ON SUNDAY, OCTOBER 5, 2008.

The foregoing ruling was issued after Felix came in and took responsibility for failing to have his owner licensed prior to the fifth race on Sunday, October 5, 2008, necessitating a late declaration.

(4) GERALD BOBROSKY RULINGRULING # 245

IN THE MATTER OF: GERALD BOBROSKY

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER GERALD BOBROSKY ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING # 235, DATED SEPTEMBER 21, 2008, SUSPENDING GERALD BOBROSKY FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE.

The above noted ruling was issued after the Board of Stewards received a letter from Equine Sports Medicine that Mr. Bobrosky had paid his debt in full.

(1) ENTRIES FOR THURSDAY

Eight races were drawn for Thursday consisting of two Thoroughbred and six Quarter Horse races. The draw was completed at 12:30 p.m.

(2) CAL-BRED REPORT

The CAL-BRED race written for maiden two year olds, at a distance of 300 yards attracted only one entry and was called off.

(3) JAIME GOMEZ RULING (CASE# 06LA0108)

The Stewards conducted a formal hearing to address the above noted complaint which has been pending since 2006. Trainer Jaime Gomez entered into a stipulated agreement with the California Horse Racing Board and the case was remanded back to this Board of Stewards for execution of the agreement. Senior Special Investigator Thomas Blake presented the signed agreement to Stewards Randy Winick, James Dreyer, and Martin Hamilton. Court Reporter Barbara Weinstein recorded the proceedings.

Investigator Blake testified that Mr. Gomez elected not to appear, as he had already signed the agreement and was resigned to the sanction. After entering the document into the record, the matter was considered submitted, and the following ruling was issued.

RULING # 246

PURSUANT TO A STIPULATED AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD TRAINER JAIME GOMEZ WHO STARTED THE HORSE "FIRE FREE" IN THE TENTH RACE ON AUGUST 12, 2006 AT LOS ALAMITOS RACE COURSE IS FINED TWENTY-FIVE HUNDRED DOLLARS (\$2,500.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887 (A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A)(D) (MEDICATION, DRUGS AND OTHER SUBSTANCES – FLUPHENAZINE – CLASS II).

(4) ALEJANDRO S. ALVAREZ RULINGRULING # 247

OWNER ALEJANDRO ALVAREZ IS FINED TWENTY-FIVE DOLLARS (\$25.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – (UNLICENSED VISITOR) ON FRIDAY, OCTOBER 10, 2008.

The above ruling was issued after Mr. Alvarez came in and admitted to taking an unlicensed guest into the barn area without properly signing in at the Stable Gate.

(5) INQUIRY – 6<sup>TH</sup> RACE - DISQUALIFICATION

The Stewards posted the Inquiry sign following the sixth race in order to evaluate several factors during the course of the 300 yard Quarter Horse sprint.

In the first incident, # 5 "A Very Good Check" reared extremely high at the start and unseated jockey Ramon Sanchez. # 5 caused his own problem and was declared a starter. Jockey Sanchez regained his feet and was cleared to ride the remainder of the evening.

Later # 2 "BF End Game" (5<sup>th</sup> – jockey Cody Jensen) bore out into # 3 "Billy Budd" (6<sup>th</sup> – jockey Santiago Mendez) and pushed the latter into # 4 "SFR No Comment" (4<sup>th</sup> – jockey Juan Andrade) costing # 3 a chance at a better placing. # 1 drifted out thereafter, however, was deemed marginally clear and allowed to stand.

After reviewing the replays of the race and talking with the riders involved, the Stewards disqualified # 2 from fifth to sixth place in a unanimous decision.

JOCKEY CARLOS BAUTISTA IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON SATURDAY, OCTOBER 11, 2008.

The above ruling was issued when Carlos failed to return from out of town in time to fulfill his riding engagements last evening.

(3) FILM REVIEW

Jockey Saul Ramirez and Dihigi Gladney appeared, as directed, to review two separate incidents from last evening.

In the sixth race, Saul allowed his mount to drift in mid-race while marginally clear and was cautioned to be more attentive.

In the second race Dihigi bumped a rival to his outside at the top of the stretch while trying to avoid a stopping competitor. The contact was relatively minor, however, Dihigi was cautioned against the bump and run. Mr. Gladney concurred and avowed to do better.
