Report of the Board of Stewards for the week of June 21, 2011 through June 26, 2011.

TUESDAY

06/21/2011

(1) DUTY STEWARD

Albert Christiansen will be present for morning activities and shall author the week's minutes.

(2) CAL-BRED REPORT

Two races were offered Cal-Bred in the condition book. The sixth race for three year olds, claiming price \$10,000, going 330 yards, failed to attract an entry. The seventh race for three year olds and upward, claiming price \$2,500, going 300 yards, was called off with two Cal-Bred entries.

(3) THE DRAW

Ten races were drawn for Friday's program. Three Thoroughbred and seven Quarter Horse races make up the card.

WEDNESDAY

06/22/2011

(1) SCRATCHES

Four scratches and numerous rider changes completed scratch time at 9:00 a.m.

(2) CAL-BRED REPORT

Two races were offered Cal-Bred. The first race in the book for maidens two years old, claiming price \$5,000, going 300 yards, was used open with three Cal-Breds. The fourth race in the book for three year olds which have never won two races, going 300 yards, was called off with three Cal-Bred entries.

(3) THE DRAW

Ten races were drawn for Saturday's program. Four Thoroughbred and six Quarter Horse races complete the card.

THURSDAY

06/23/2011

(1) SCRATCHES

One rider change completed scratch time at 9:00 a.m.

(2) CAL-BRED REPORT

Three races were offered Cal-Bred in the condition book. The fourth race for maidens, fillies two years old, going 300 yards, failed to fill with two Cal-Bred entries. The sixth race for maidens, three years old and upward, claiming price \$2,500, going 300 yards, was used open with four Cal-Breds. The eighth race for three year olds and upward, claiming price \$10,000, going 350 yards, was called off with two Cal-Bred entries.

(3) THE DRAW

Ten races were drawn for Sunday's program. Four Thoroughbred and six Quarter Horse races make up the card.

FRIDAY

(1) SCRATCHES

One scratch completed scratch time at 9:00 a.m.

(2) MENDEZ RULINGRULING #121

JOCKEY SANTIAGO MENDEZ WHO RODE "DO YOU DO CORONA" IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, JUNE 19, 2011, IS SUSPENDED THREE (3) RACING DAYS (JULY 1ST, 2ND AND 3RD, 2011) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after jockey Santiago Mendez and his agent Frank Quesada appeared to review last Sunday's first race with the Stewards. The rider could not show an effort to keep his horse straight when a rival, inside of him, clipped his heels.

(3) FINANCIAL AGREEMENT

Owner Joaquin Murrieta appeared to address a financial complaint by Equine Sports Medicine in the amount of \$2,040. After much discussion a financial agreement was reached calling for \$1,000 on July 1, 2011 and the balance by July 15, 2011.

(4) MURRIETA RULINGRULING #122

OWNER JOAQUIN MURRIETA, HAVING NOW APPEARED BEFORE THE BOARD OF STEWARDS TO ANSWER CHARGES ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1876 (FINANCIAL RESPONSIBILITY) IS RESTORED TO GOOD STANDING. RULING # 106 ISSUED AT LOS ALAMITOS RACE COURSE ON JUNE 11, 2011 FOR FAILURE TO APPEAR IS HEREBY SET ASIDE.

This ruling was issued after Mr. Murrieta appeared to address the previous complaint.

(5) GONZALEZ RULINGRULING #123

JOCKEY MARIO GONZALEZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JUNE 24, 2011, TO ANSWER A COMPLAINT REGARDING CASE #11LA0175, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF MARIO GONZALEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE)

SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

This ruling was issued after Mr. Gonzalez failed to appear for his scheduled hearing. The complaint was for an alleged debt owed to Equine Sports Medicine.

(6) FIRST RACE – INQUIRY – DISQUALIFICATION

After the finish of the first race (Thoroughbred – 4½ furlongs) the Stewards posted the Inquiry sign to review an incident midstretch. Involved were the sixth place finisher #5 “Getaway Pancho” (jockey Dihigi Gladney) and the seventh place horse #1 “Ethiopian” (jockey Joel Cruz). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify #5 from sixth and place him seventh, behind #1, for interference in the stretch. Replays show #5 suddenly veer into the path of #1, costing the latter a chance of beating #5.

(1) GONZALEZ RULING (REFER 06/24/11 (5))

RULING #124

JOCKEY MARIO GONZALEZ, HAVING NOW APPEARED BEFORE THE BOARD OF STEWARDS TO ANSWER CHARGES ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1876 (FINANCIAL RESPONSIBILITY) IS RESTORED TO GOOD STANDING. RULING # 123 ISSUED AT LOS ALAMITOS RACE COURSE ON JUNE 24, 2011 FOR FAILURE TO APPEAR IS HEREBY SET ASIDE.

This ruling was issued when Mario Gonzalez appeared to address the scheduled complaint from yesterday. It was discovered that Mario Gonzalez was not the owner of the horse involved in the complaint.

(2) FINANCIAL SETTLED

A financial complaint submitted by horseshoer Jim Stump was paid in full by trainer Guillermo Morales.

(3) JOCKEY REVIEWS RACE

Jockey Santiago Mendez appeared to review last night’s ninth race with the Stewards. Upon review it was determined the rider made an acceptable effort to correct his mount.

Ten races were completed without a reportable incident.

(1) JOCKEY REVIEWS RACE

Jockey Daniel Sandoval appeared to review last night's fourth race with the Stewards. Although the rider did a reasonable job straightening his horse at the start, he was cautioned to have better control of his mount.

(2) THIRD RACE – INQUIRY – ACCIDENT – NO CHANGE

After the finish of the third race (Thoroughbred – 4½ furlongs) the Stewards posted the Inquiry sign to review an incident just past the quarter pole. Upon review it was determined that #2 "Copy That Dream" fell while racing in the clear, unseating jockey Alex Bautista. The rider was okay and the horse was euthanized on the track.

(3) NINTH RACE – JOCKEY OBJECTION – NO CHANGE

After the finish of the ninth race (Ed Burke Million Futurity – Grade I) the Stewards posted the Objection sign at the request of jockey Eduardo Nicasio aboard the tenth place finisher #8 "A Country Boy Can." Nicasio alleged interference at the start by the second place finisher #10 "Kindly Fellow" (jockey Juan Andrade). After talking with the riders involved and reviewing the taped replays, the Stewards unanimously agreed to make no change in the order of finish. Replays show #8 break out and ping pong back and forth. After a few strides from the start, #10 lugs in front of #8 and #9. All three horses contributed to the interference thus no change was warranted.
