(1) DUTY STEWARD

(1) JIMENEZ RULINGRULING #17

JOCKEY ALEX JIMENEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1680 (JOCKEYS AND DRIVERS TO REPORT – LATE TO JOCKEYS ROOM).

The above ruling was issued after Jockey Alex Jimenez failed to arrive in time to fulfill his riding engagement in the second race Sunday evening.

(2) SOSA RULINGRULING #18

OWNER RAUL L. SOSA IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – SIGNED IN AN UNAUTHORIZED VISITOR).

The foregoing ruling was issued after meeting with Owner Raul Sosa to address case #14LA0012. Mr. Sosa admitted signing his unlicensed son in and then failing to remain with him while he was in the barn area. Violation of Rule #1482 listed in the complaint was dismissed for good cause.

Although no one was impeded, we felt he needed to be made aware that this type of irresponsible riding will not be tolerated.

The first race of the evening was delayed approximately fifteen minutes when "So Pretty" attempted to flip in the gate, injuring Jockey Alex Jimenez. "So Pretty" had to be returned to the Paddock for a substitute rider. The injuries to Jockey Jimenez are unknown at this time.
