(1) CLERISSE RULING

RULING #153

APPRENTICE JOCKEY CASSIDY CLERISSE WHO RODE "TRUE GRIT SA" IN THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, SEPTEMBER 20, 2015, IS SUSPENDED THREE (3) RACING DAYS (OCTOBER 2ND, 3RD, AND 4TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HER MOUNT FROM FIRST TO SECOND. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after the Stewards met with Jockey Cassidy Clerisse concerning her ride in Sunday night's fifth race in which her mount was disqualified. Ms. Clerisse let her mount drift in, causing the horse to her inside to clip heels.

(2) CISNEROS RULING

RULING #154

IN THE MATTER OF: JUAN CISNEROS

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER JUAN CISNEROS ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #148, DATED SEPTEMBER 12, 2015, SUSPENDING MR. CISNEROS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND JUAN CISNEROS IS RESTORED TO GOOD STANDING.

The above ruling was issued after Equine Sports Medicine contacted the Stewards to inform them that Owner Juan Cisneros paid his bill in full.

(3) MACIAS RULING

RULING #155

JOCKEY OSVALDO MACIAS IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP – MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND - SECOND OFFENSE), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 20, 2015.

Jockey Osvaldo Macias appeared before the Stewards to review his ride in the sixth race on Sunday, September 20, 2015. Film review confirmed violation of Rule #1688(b)(6) (Use of Riding Crop).

(5) JONES RULING

RULING #156

TRAINER PAUL C. JONES IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION – WRONG HORSE BROUGHT TO RECEIVING BARN) ON SUNDAY, SEPTEMBER 20, 2015.

The preceding ruling was issued after Mr. Jones was contacted and informed that his help

inadvertently brought over the wrong horse for the seventh race on Sunday, September 20, 2015. The horse was declared, hence the penalty.

(6) ALL CLEAR

Tonight's racing program was conducted without incident.

(2) MARTINEZ COMPLAINT – CASE #15LA0147

Trainer Silverio Martinez was in to answer the above complaint regarding a positive test finding in the post-race test sample of the horse "Dragon Dance" who ran in the first race at Los Alamitos on July 10, 2015 for the prohibited drug substance clenbuterol, a class III, penalty "B" violation.

Present at this formal hearing were the respondent, Trainer Silverio Martinez, California Horse Racing Board Investigator Dennis Drulias, who presented the case, Investigator Tom Blake, and the three Board of Stewards. The proceedings were recorded by Court Reporter Michelle Derieg.

The investigative report was presented by Dennis Drulias, and a response was afforded by Mr. Martinez, who stated Owner/Groom Sosa gave the medication. Mr. Martinez was informed that since he is the trainer of record, the responsibility is with him.

The case will now be submitted for a review by the three Stewards, and a proposed decision will be forthcoming.

(3) SOSA HEARING – COMPLAINT #15LA0150

A second formal hearing was conducted to address a positive finding of the drug clenbuterol. The same individuals were present for Sosa's hearing with the exception of Silverio Martinez.

Mr. Sosa admitted giving a medication to the horse twenty-four days prior to race time. He received the medication from an unknown person off the racetrack. The record was closed. Proposed decision will follow.

(4) THIRD RACE – OBJECTION – NO CHANGE

Following the third race, Jockey Efrain Hernandez on #1 "Now You're It" (5th) lodged an Objection against #4 "Tough Ray" (1st). After speaking to the riders and reviewing the tapes, the Stewards observed #1 getting out going into the turn and elected unanimously to make no change.

(5) SIXTH RACE – ACCIDENT – INQUIRY – NO CHANGE

The Stewards posted the Inquiry sign immediately following the running of the sixth race to

evaluate an incident near the 1/8th pole in which #1 "The One We Stole" (Jockey G. Boag) broke down and fell, unseating Jockey Boag. The human ambulance was quickly on the scene to pick up the rider, who was complaining about his shoulder. Unfortunately, the horse had to be euthanized. Accident report attached.

(2) FOURTH RACE – INQUIRY - DISQUALIFICATION

The Stewards had the Inquiry sign posted following the running of the fourth race (Quarter Horse – 330 yards) to review an incident nearing the 1/8th pole. Involved were #8 "Apollitical Dynasty" (2nd – Jockey E. Nicasio) and #9 "KK Good Buddy" (8th – Jockey C. DeAlba). After speaking with the riders involved and reviewing the tape replays, the Stewards agreed to disqualify #8 from second to eighth position. Replays reflect #8 shifts out sharply, bumps and impedes #9, knocking the latter off stride and costing him an opportunity of better placement.

(3) SEVENTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the seventh race when Track Veterinarian Dr. Fitzgerald reported that #2 "Steely" was unsound. Declared by the Stewards. Refund: \$7,806.00.
