RULING # 123

JOCKEY SAMUEL MENDEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SUNDAY, MAY 8, 2016, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after jockey Samuel Mendez failed to show up to ride the first race on May 8, 2016. When he called he claimed he was too far away to get here in time to fulfill his engagement.

(3) FAILURE TO APPEAR VIOLATIONS – RULINGS #124 AND #125

OWNER ERIC SMITH HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON MAY 13, 2016, TO ANSWER A COMPLAINT REGARDING CASE #16LA0129, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

RULING # 125

OWNER EVALINE HERNANDEZ HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON MAY 13, 2016, TO ANSWER A COMPLAINT REGARDING CASE #16LA0130, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

The above rulings were issued after the individuals named in the complaints failed to appear to address the alleged violations.

JOCKEY CAYETANO CHAPARRO IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 8, 2016.

RULING # 127

JOCKEY JOSE M NICASIO IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-SECOND OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 13, 2016.

RULING # 128

JOCKEY RUBEN LOZANO IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON MAY 14, 2016.

RULING # 129

JOCKEY GENARO TAPIA IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-SECOND OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON MAY 14, 2016.

RULING # 130

JOCKEY JESUS RIOS AYALA IS FINED FOUR HUNDRED DOLLARS (\$400.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FOURTH OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 14, 2016.

RULING # 131

JOCKEY SANTIAGO MENDEZ IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-SECOND OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 14, 2016.

RULING # 132

JOCKEY MARTIN ARRIAGA IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 15, 2016.

RULING # 133

JOCKEY OSCAR M PEINADO IS SUSPENDED THREE RACING DAYS (MAY 27TH, 28TH, AND 29TH) FOR A BLATANT VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 15, 2016.

The forgoing rulings were issued after all of the riders named in the rulings above were guilty of violating California Horse Racing Board rule # 1688 b(6). Ruling #133 resulted in a suspension as the violation was so egregious. The horse was struck with the whip seventeen times in succession.

(5) CASE -#16LA0141

An informal hearing was held today to address the above referenced case. Dr. Hardgrove admitted the allegations were correct. She did think, however, that trainer Acuna was going to follow up and contact Dr. Fitzgerald, which he failed to do. A decision will be forthcoming.

(6) CASE - #16LA0142

A formal hearing was convened today to hear the above complaint. Present were the Board of Stewards, Supervising Investigator Tom Blake, Dr. Nicola Hardgrove, Nick Acuna and court reporter Dawn Young. Acunas version of the situation differed from Mr. Blakes. He denied telling Mr. Blake that Dr. Hardgrove or Dr. Manno examined the horses. He said he simply stated those were the two Vets he used. He also denied using any belligerent language. The fact remains the

two horses were scratched having never been examined which is his responsibility. A decision will be rendered.

JOCKEY BRANDON CHANCE BOULANGER IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON FRIDAY, MAY 21, 2016, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after jockey Boulanger rode the last race at Santa Anita and was then unable to get to Los Alamitos to fulfill his obligation in the first race.

(2) LARAMIE—RULING #135

RULING # 135

IN THE MATTER OF: GARY G. LARAMIE

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO VETERINARIAN DR. EILEEN GESOFF, THE LICENSE PRIVILEGES OF OWNER GARY G. LARAMIE ARE RESTORED AND HOLLYWOOD PARK RULING #24, DATED DECEMBER 6, 2000, SUSPENDING GARY G. LARAMIE FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND GARY G. LARAMIE IS RESTORED TO GOOD STANDING.

The above ruling was issued after owner Laramie finally cleared up debts dating back to 2000.

TRAINER NICK ACUNA IS FINED FOUR HUNDRED DOLLARS (\$400.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – FAILURE TO FOLLOW PROPER PROCEDURES IN REQUESTING

TWO VETERINARIAN SCRATCHES) ON SATURDAY MAY 7, 2016 AT
LOS ALAMITOS RACE COURSE.

After weighing all the information provided the foregoing ruling was issued.

(5) INQUIRY—NO CHANGE

The Stewards posted the inquiry following the fifth race to examine the break. #6 FDD SWEET VENGEANCE (4th- C. Mendez) broke in pushing #5 HOP SKIP N A COP (7th—G. Rangel) into #4 SAY IT BEST (8th—C. DeAlba) who in turn knocked #3 STOLIS DELIGHT (9th—O. Peinado) off stride. After speaking to the riders and reviewing the films the Stewards felt HOP SKIP N A COP caused the majority of the damage and voted unanimously to make no change.

JOCKEY CESAR DEALBA IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 21, 2016.

After speaking with Cesar via telephone, he accepted responsibility for the whip violation resulting in the foregoing ruling.

(2) DR. BECK VISITS

Dr. Beck stopped by this afternoon to discuss last evening's fiasco in the receiving barn. Fifteen minutes before the first race we were notified that Dr. Beck's secretary, Alice Reese, had been suspended by management and escorted off the property. When we contacted management, security to be exact, they were very evasive and would tell us nothing citing front office policy. Alice's replacement, Tami Craigmyle, is licensed as a pony person. Dr. Beck was quite upset over the way the situation was handled and with the replacement he got. Dr. Beck was very supportive of Mrs. Reese and felt she was unfairly treated. During our meeting Darrell McHargue called and informed us the Board would stand behind Dr. Beck with anything he needs. Racing Secretary Jay Conklin joined the discussion and was notified that by next week someone qualified needs to be in the receiving barn in Alice's position.
