TUESDAY9/15/09¹**SCRATCHES**

Three declarations and three rider changes for Wednesday's program were completed at 10:00 a.m.

WEDNESDAY9/16/09¹**SCRATCHES**

10:00 a.m. scratch time yielded five rider and two equipment changes.

9/16/09²**THE DRAW**

Saturday's card was drawn at 12:00 p.m. with a program of twelve races to be conducted.

9/16/09³**CAL-BRED RACES**

The eighth race on the card for Cal-Bred maiden allowance two year olds at a distance of six furlongs will have a field of nine face the starter.

9/16/09⁴**TATCH HEARING (Case #09DM0062)**

A formal hearing was conducted for owner MARK TATCH in the above-referenced case for violation of California Horse Racing Board rules #1874 (Disorderly Conduct) and #1902 (Conduct Detrimental to Horse Racing). The Complaint stated that Mr. TATCH was disorderly, argumentative, and threatening during a visit to the CHRB Investigators' office at Del Mar, when he came to inquire as to why his license was under suspension. It was learned that it was because he had not paid his fine for a ruling issued at Hollywood Park for a similar demonstration of his behavior to a licensee and also at that hearing.

Present at today's hearing were the respondent, owner MARK TATCH, Senior Special Investigators PHIL MIYAZAKI and RICK AMEIVA, who was called as a witness, CSR BARBARA WEINSTEIN and the Board of Stewards, ALBERT CHRISTIANSEN, RANDY WINICK, and LUIS JAUREGUI, filling in for SCOTT CHANEY who recused himself since he was going to be called as a witness.

Steward CHRISTIANSEN began the hearing by reading Mr. TATCH his rights and asking if he was ready to go forward, to which TATCH said that he was. Investigator PHIL MIYAZAKI presented the case and then called Investigator RICK AMEIVA as a witness to testify.

During Mr. AMEIVA's testimony, owner TATCH was disruptive, disorderly, and very aggressive, constantly interrupting the hearing. Mr. TATCH was continually advised and warned that he would have a chance to present his case but must adhere to proper decorum. TATCH's behavior continued to deteriorate and he was warned several times that the hearing would be ended and he would be suspended or fined. When no improvement or progress was made, the proceeding was halted and Mr. TATCH was advised that a decision and ruling would be forthcoming.

9/16/09⁵**APPRENTICE JOCKEY RECEIVES CERTIFICATE**

Newly licensed apprentice jockey JUAN PEDRO BRIANO was in to obtain his apprentice jockey certificate which was signed by the three presiding Stewards and has to be kept with him during the entire tenure of his apprenticeship.

9/16/09⁶**FILM REVIEW**

Jockey CHRISTIAN SANTIAGO-REYES was in, as requested by the Stewards, to review the film of a race from the previous Friday afternoon. He was cautioned to be more careful when trying to force his mount into a spot that was too small for him to fit into. A warning was issued along with a strong emphasis that future riding of this sort will result in a suspension.

9/16/09⁷**SUNDAY – 12TH RACE REVIEW**

The Stewards reviewed the running of the 12th race from Sunday afternoon (9/13) at the request of the California Horse Racing Board, due to numerous inquiries from the public concerning the large mutuel payoff of the winner.

After a thorough review of the tape replay, a discussion with the trainer, track veterinarian, and mutuel manager to detect any unusual patterns or inconsistencies, it was determined that nothing untoward appeared to have taken place.

9/16/09⁸**INQUIRY – FOURTH RACE – NO CHANGE**

The Stewards called for the Inquiry light to be lit after the finish of the fourth race (six furlongs – T.B.) to review a bumping incident inside the 1/16 pole between #8 GIRL OF MINE (1st – F. Valdez) and #1 NEW CITIZEN (2nd – M. Pedroza). Film does show #8 coming out and making slight contact with #1 in late stretch, causing that one to steady. However, it did not appear to cost #1 the opportunity at a better placing, which was 1 $\frac{3}{4}$ lengths for the win. The Stewards' decision was unanimous for the original order of finish to stand.

10:00 a.m. scratch time provided six rider changes, one equipment adjustment and two declarations.

9/17/09²**ENTRIES AND DRAW**

Twelve races were drawn at 11:30 a.m. for Sunday's card.

9/17/09³**CAL-BRED REPORT**

Two races are carded for California-Bred horses today – the eighth race is for maiden \$32,000 two-year-old fillies at six furlongs with a field of ten, and the tenth race is for \$40,000 optional claiming three year olds and up going six and one-half furlongs with a field of six going postward.

9/17/09⁴**WARNINGS ISSUED**

Trainers PATRICIA HARRINGTON and RAFAEL BECERRA were issued warnings for being late to the Receiving Barn at Del Mar.

9/17/09⁵**FILM REVIEW**

Jockey FELIPE VALDEZ appeared to review Wednesday's fourth race where he was the winner, but was involved in a Stewards' Inquiry for coming out in the stretch. Although there was no disqualification, Mr. VALDEZ was instructed to make more of an effort to keep his horses straight, to which FELIPE replied affirmatively.

9/17/09⁶**RULING #5**

Owner MARK TATCH is fined ONE THOUSAND DOLLARS (\$1,000.00) for violation of California Horse Racing Board rules #1874 (Disorderly Conduct – Abusive Behavior), and #1902 (Conduct Detrimental to Horse Racing).

The above ruling was issued to owner MARK TATCH for being continually abusive, disorderly, and generally out of control during his hearing on Wednesday. (Refer 9/16/09⁴)

9/17/09⁷**RULING #6**

JOHN SADLER, the trainer of the horses MY SPANISH FLING and QUE SERA SERA, which ran in the 10th race on August 15, 2009, at the Del Mar Thoroughbred Club, is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rules #1852 (Reporting to the Receiving Barn – Late) and #1894 (Duties of Trainer).

The above ruling was issued to trainer JOHN SADLER for being late to the Receiving Barn at Del Mar with two horses on August 15, 2009.

9/17/09⁸**RULING #7**

Trainer DAVID DWYER, having failed to appear before the Board of Stewards at the Los Angeles County Fair on September 16, 2009, to answer a complaint regarding Case number 09DM001, alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending appearance before the Board of Stewards pursuant to California Horse Racing Board Rule #1547 (Failure to Appear).

During the term of suspension, all license and license privileges of DAVID DWYER are suspended and pursuant to California Horse Racing Board #1528 (Jurisdiction of Stewards to Suspend or Fine), subject is denied access to all premises in this jurisdiction.

The above ruling was issued to Mr. DWYER for failing to appear as scheduled before the Board of Stewards to address charges alleging violation of the Financial Responsibility rule.

9/17/09⁹**COMPLAINT SETTLED (Case #09DM121)**

The above-referenced Complaint was dismissed for good cause as trainer VLADIMIR CERIN informed the Stewards that he was paid in full by owner EDWARD GOLDSTONE in the amount of \$2,325.00.

9/17/09¹⁰**STAKES PURSES REDUCED**

Los Angeles County Fair Racing Consultant TOM ROBBINS was in to make a request of the Stewards for reducing the purse value of three stakes races due to

lower expectations of business at the Fair this season. The Stewards approved reducing the three requested stakes by \$25,000 each, which are the Pomona Derby (\$50,000), the Las Madrinas (\$50,000) and the Ralph M. Hinds (\$100,000).

9/17/09¹¹**RACES CANCELLED**

After a lengthy discussion in the Stewards' office, Fairplex Park management decided to cancel the first and second races (350 yards – mules) when the Stewards were compelled to scratch 11 of the 14 competing mules due to the attending veterinarian's (Dr. Kristie Brandenburg) confidential report being incorrect as to the time of the pre-race treatment for multiple anti-inflammatory medications.

The Stewards thought that there were too many inconsistencies concerning all of the involved parties as to what was and wasn't true concerning those treatments. In the best interest of the public as well as this being in contravention of CHRB rules, the Stewards made this difficult decision. An investigation will be conducted in this matter in the near future and more will be forthcoming.

9/17/09¹²**FAIRPLEX VICE PRESIDENT VISITS STAND**

Fairplex Park Vice President of Finance and CFO MICHAEL SEDER visited the Stewards after the fifth race to gain further information on the mule race cancellations. The Stewards explained the rules violations that took place as described previously and the ramification if the races were allowed to run. Mr. SEDER explained how adversely this situation affected Fairplex financially and wondered if there would be penalties involved to the offending parties. The Stewards assured him there would be a full investigation and that sanctions would be meted out if appropriate.

9/17/09¹³**INQUIRY – ACCIDENT – NINTH RACE – NO CHANGE**

The Inquiry sign was posted after the finish of the 9th race (1-1/16 – T.B.) due to #4 SAINT'S CROWN (DNF – P. Arambula) clipping heels with #8 LA SWING (6th – M. Pedroza), approaching the ¼ pole the first time around in this three-turn race. It appeared that jockey PEDROZA was setting a slow pace on the lead and that jockey ARAMBULA was having a difficult time rating his mount behind PEDROZA and ran up on heels which caused the problem, resulting in the ensuing fall. After a review of the tape replay, the Stewards allowed the original order of finish to stand. Mr. ARAMBULA was reported to be slightly shaken up and told to take off his remaining mounts. 9/18/09¹**SCRATCHES**

Scratches for Saturday were completed at 10:00 a.m... and the result was four declarations, six weight corrections, and two rider changes.

9/18/09²**ENTRIES AND DRAW**

Wednesday's entries and draw were completed by 12:15 p.m., with the card consisting of twelve races, composed of ten thoroughbred and two mule events.

9/18/09³**CAL-BRED REPORT**

There are no California-Bred races scheduled for today's racing.

9/18/09⁴**RULING #8**

Trainer MIKE PENDER is fined THREE HUNDRED DOLLARS (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration), for violation of California Horse Racing Board rule #1843 (Medication, Drugs and Other Substances –

medicated too close to race), necessitating the late declaration of MARY THE PRINCESS from the third race on September 16, 2009.

The above ruling was issued to trainer MIKE PENDER as a result of a necessitated scratch of his horse due to improperly treating MARY THE PRINCESS too close to the race for which she was entered.

9/18/09⁵

RULING #9

Trainer HECTOR SANCHEZ is fined THREE HUNDRED DOLLARS (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration), for violation of California Horse Racing Board rule #1437 (Conditions of a Race Meeting – not enough works), necessitating the late declaration of STRAIT PROSPEK from the eleventh race on September 18, 2009.

The above ruling was given to trainer HECTOR SANCHEZ for a scratch being necessitated for the horse STRAIT PROSPEK from the eleventh race due to having insufficient works to participate.

9/18/09⁶

MORE MULE MISQUES – LATE DECLARATION

In a continuing problem from Thursday when two races were cancelled due to improper medication treatments reported on the attending veterinarian's confidential report, another impropriety was discovered in today's first race. The mule DASHN BOBI McGEE was reported to have received the corticosteroid Vetalog along with Phenylbutazone. This in contravention to CHRB rules in that only one approved medication can be given at 24 hours pre-race, and that Vetalog is not one of them. Additionally, it cannot be given within 48 hours of a race. The Stewards ruled that in light of this discovery, the mule DASHN BOBI McGEE must be scratched in the best interest of the public and all interests involved. There is an ongoing investigation into this issue.

FILM REVIEW

Jockey CHRISTIAN SANTIAGO REYES reviewed two races, one where he was a little too aggressive in pushing his way out of a crowded situation down the backside, and in the other, his horse was lugging inward coming out of the gate and again turning for home. In the first instance, Mr. REYES was told to be more patient and wait for an opening and in the other, he was counseled to be quicker in grabbing the reins to straighten his mount's inward motion. SANTIAGO was cooperative and understanding.

INQUIRY – THIRD RACE – DISQUALIFICATION

An Inquiry was called for after the finish of the third race concerning #3 SOLEMN PROMISE (4th – P. Arambula) coming over on #1 DADSALITTLEUNUSUAL (6th – A. Quinonez) to his inside, while moving through along the rail, causing him to take up sharply. After talking to both riders and reviewing the tape replay, the Stewards unanimously voted to disqualify #3 from fourth to sixth place, behind #1, for interference in the stretch, costing #1 the opportunity at a better placing.

9/19/09³**CAL-BRED REPORT**

Saturday's tenth race is for California-Bred three year olds and upward, optional claiming \$40,000 at 1-1/16. A field of seven is scheduled to face the starter.

9/19/09⁴**RULINGS #10 and #11**

#10 Owner SHIRLEY CUNNINGHAM, having failed to appear before the Board of Stewards at the Los Angeles County Fair on September 18, 2009, to answer a complaint regarding Case #09DM0122, alleging violation of California Horse Racing Board rule #1489(a) (Grounds for Denial or Refusal of License – Conspiracy to Commit Wire Fraud), is suspended pending appearance before the Board of Stewards pursuant to California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of SHIRLEY CUNNINGHAM are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), subject is denied access to all premises in this jurisdiction.

#11 Owner WILLIAM GALLION, having failed to appear before the Board of Stewards at the Los Angeles County Fair on September 18, 2009, to answer a complaint regarding Case #09DM0115, alleging violation of California Horse Racing Board rule #1489(a) (Grounds for Denial or Refusal of License – Conspiracy to Commit Wire Fraud), is suspended pending appearance before the Board of Stewards pursuant to California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of WILLIAM GALLION are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), subject is denied access to all premises in this jurisdiction.

The above rulings were issued to owners SHIRLEY CUNNINGHAM and WILLIAM GALLION for failing to appear for the hearings to suspend their owners' licenses as a result of being found guilty in U.S. District Court in Kentucky of conspiracy to commit wire fraud and aiding and abetting wire fraud.

9/19/09⁵**FILM REVIEW**

Jockey PEDRO ARAMBULA reviewed film this morning regarding his disqualification from Friday's third race. Mr. ARAMBULA's horse came in under right-handed whipping causing the horse to his inside to take up sharply, costing him position and momentum which affected a better placing. PEDRO gave the excuse that he thought there was enough room, and that the horse inside shied away from the rail – both of which were not plausible. The Stewards thought Mr. ARAMBULA could have been more aware of his position and done a better job in keeping his horse straight.

The following ruling, #12, was issued for careless riding:

Jockey PEDRO ARAMBULA, who rode SOLEMN PROMISE in the third race at the Los Angeles County Fair on Friday, September 18, 2009, is suspended THREE (3) racing days (September 26, 27, and 28, 2009) for failure to maintain a straight course, causing interference resulting in the disqualification of his mount from fourth to sixth place. A violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

9/19/09⁶**RULING #13**

Jockey/exercise rider OTABEK UMAROV, having complied with the provisions of California Horse Racing Board rule #1876 (Financial Responsibility), is restored to good standing. Ruling #6 issued at Del Mar Thoroughbred Club on July 22, 2006, is set aside.

The above ruling was written to restore jockey/exercise rider OTABEK UMAROV to good standing after a letter was received from trainer STACY YOUNG verifying payment in full regarding his financial responsibility to her.

9/19/09⁷**LATE DECLARATION – ACCIDENT – FIRST RACE**

As the horses were leaving the paddock for the first race, #4 BLUE MOON SLEW (R. Guce) unseated his rider and ran off loose up the seven furlong chute, necessitating a late scratch. Jockey RAMON GUCE was attended to by the track paramedics. (See attached Jockey Accident Report)

9/19/09⁸**INQUIRY – ACCIDENT – SIXTH RACE – NO CHANGE**

The Stewards posted the Inquiry sign to look at an incident approaching the 3/16 pole in the sixth race (about 4 furlongs – T.B.) where #8 ABSTRACT FACT (DNF – P. Arambula) was lugging out on the turn and came across the heels of #6 BRIDE IN BLUEJEANS (6th – A. Delgadillo) which caused her to stumble and unseat jockey ARAMBULA. PEDRO was quickly attended to by the track paramedics, who, after several minutes, placed him on a backboard and into the ambulance. (See attached Jockey Accident Report)

The Stewards reviewed the tape replay and determined that PEDRO ARAMBULA and his horse were responsible for the problem and that no other horses were compromised by the accident. The result was declared Official as originally finished.

9/19/09⁹**OBJECTION – ELEVENTH RACE – NO CHANGE**

Jockey DAVID FLORES lodged an Objection after the finish of the eleventh race, The Barretts Debutante, for alleged interference between #2 REPO (2nd – A. Quinonez) and his horse #5 KALOULA (4th), shortly after the start. Tape replays show that there was a chain reaction inward flow started from the extreme outside post positions - #10 and #11 angled inward on #9, who put pressure on #7 and #6, who squeezed Mr. FLORES' mount #5 down behind #2 and #1 who were coming outward from their inside position positions. DAVID's horse was already compromised from the outside pressure before the inside tandem came out and in front of him.

The Stewards ruled that #2 did not cost #5 the opportunity of a better placing by his actions and that he was also beaten by over six lengths for the next placing. No change was warranted.
