**THURSDAY**9/15/11<sup>1</sup>**BEAN FORMAL HEARING – CASE #11DM0030**

This Hearing involved CHRB rules #1843(a)(d) (Medication, Drugs, and Other Substances), #1844(c)(1) (Authorized Medication), #1887(a) (Trainer to Insure Condition of Horse), and #1866(d) (Veterinarian's List). The Hearing was recorded by court reporter JOYCE SILVERMAN. In attendance were trainer BOB BEAN and Safety Steward LUIS JAUREGUI, who sat in as an observer. Investigator PHILLIP MIYAZAKI presented the case for the CHRB.

Mr. BEAN stated he fed the horse PLUG IN THE JUG two bute pills the night before the workout. He acknowledged the horse was a slow eater and this was his reason for the

overage. Due to the fact that this was Mr. BEAN's first medication violation and the level was 5.58 mg/ml, he was eligible for and received an Official warning.

**JOCKEY OBJECTION/NO CHANGE – FIRST RACE (about 4 furlongs)**

After the running of the race, the jockey of #2 MR. DAY TRIPPER (5<sup>th</sup>, M. Santiago, Jr.) lodged a claim of foul against #1 LET ME FINISH (1<sup>st</sup>, V. Carrero) and #8 ANDY ONE (4<sup>th</sup>, S. Garcia) for possible interference in the stretch run.

After a review of the video, conversation with the Patrol Judges and all jockeys involved, it was the consensus that #2 MR. DAY TRIPPER had to steady behind both #1 LET ME FINISH and #8 ANDY ONE in the stretch but was not cost the opportunity of a better placing and the race was made Official.

Exercise rider ENRIQUE ZERIMAR is fined FIFTY DOLLARS (\$50.00) for failure to follow track workout procedures at Santa Anita on September 10, 2011. This constitutes a violation of California Horse Racing Board rule #1437 (Conditions of a Race Meeting).

The above ruling was issued after an informal hearing with Mr. ZERIMAR. He was very candid admitting his mistake of working a horse while the siren and lights were on at Santa Anita. He promised it would not occur again.

**FLORES RULING – LAFP #009**

Jockey DAVID FLORES, who rode MAJESTIC CITY in the eighth race at Del Mar Thoroughbred Club on September 7, 2011, is suspended for THREE (3) racing days (October 6, 7, and 8, 2011) for failure to make the proper effort to maintain a straight course in the stretch and causing interference which resulted in the disqualification of his mount from second to third position. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – Careless Riding).

Term of suspension shall not prohibit participation in designated races in California.

The above ruling was issued after DAVID FLORES and his agent CRAIG O’BRIEN met with the Board of Stewards to review the eighth race at Del Mar on September 7, 2011. Mr. FLORES allowed his mount to drift out under a left-hand stick causing interference. Mr. FLORES admitted he should have made a correction, but felt he was focused on trying to win the race.

9/18/11<sup>2</sup>

**FONG RULING – LAFP #010**

Jockey FREDDY FONG, JR., who rode TOUCH LUCK in the fifth race at Fairplex Park on September 16, 2011, is suspended for THREE (3) racing days (September 23, 24, and 25, 2011) for failure to ride his mount to the finish, costing him a better placing. This constitutes a violation of California Horse Racing Board rule #1692 (Requirements for horse, trainer and jockey).

Term of suspension shall not prohibit participation in designated races in California.

The above ruling was issued after a film review of the race in question. Mr. FONG stated his horse was tired and he was too. He also took responsibility for his mount’s loss of a better placing.

**FILM REVIEW**

Jockey VICTOR CARRERO met with the Board of Stewards to review the first race on September 15, 2011. Mr. CARRERO was cautioned to make sure he was clear when guiding his horse in or out during the race.. He promised to be more aware in the future. Jockey OCTAVIO VERGARA also met with the Stewards to review the tenth race on September 16, 2011. Approaching the first turn in the 6 ½ furlong event, Mr. VERGARA guided his horse inward and caused a horse to his inside to steady. In a majority vote, Mr. VERGARA was given a warning. Steward STAUFFER felt a three-day penalty was warranted.



The full Board of Stewards was in attendance each day of this reporting period.
