**Wednesday****09-24-14<sup>1</sup> SCRATCHES FOR FRIDAY / ENTRIES FOR SATURDAY**

A few jockey changes were taken for Friday. No scratches were submitted. Saturday's card consists of 10 races and a total of 88 horses/mules entered. The card has 1 mule, 1 Arabian, 1 Quarter Horse and 7 Thoroughbred races.

**Thursday****09-25-14<sup>1</sup> SCRATCHES FOR SATURDAY / ENTRIES FOR SUNDAY**

Two jockey changes were made for Saturday. No scratches were submitted. Sunday's card consists of 9 races. 1 mule, 1 Arabian and 7 Thoroughbred races make up Sunday's races. 74 horses/mules are entered for Sunday.

**Friday****09-26-14<sup>1</sup> SCRATCHES & CHANGES FOR SUNDAY**

1 scratch and 1 jockey change were made at scratch time.

**09-26-14<sup>2</sup> RULING NO. 2 – GUILLERMO PRECIADO**

Trainer **GUILLERMO PRECIADO** is hereby fined three hundred dollars (\$300)\* pursuant to California Horse Racing Board (CHRB) Rule #1629 (Penalty for Late Declaration) for violation of CHRB Rule #1845 (Authorized Bleeder Medication) for failure to properly treat COOL ICE necessitating a late declaration from the third race at Stockton, California on September 21, 2014.

The above ruling was issued when a communication problem arose between Preciado and his veterinarian Ken Allison as to placing the horse on the bleeder list. Preciado failed to

have the horse treated because he didn't realize Allison had already turned in the paperwork to the Receiving Barn.

09-26-14<sup>3</sup> **RULING NO. 3 – SILVIO AMADOR**

Jockey **SILVIO AMADOR** who rode **WALLOPING LULA** in the fourth race at the San Joaquin County Fair (Stockton) on September 21, 2014 is suspended three (3) racing days (October 3, 4, 5, 2014) for failure to make a proper effort to maintain a straight course at the start and causing interference. A violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The above ruling was issued after Mr. Amador appeared and failed to show this board an effort to straighten his mount at the start.

09-26-14<sup>4</sup> **FREY WARNING**

Jockey Kyle Frey was in to review last Sunday's 9<sup>th</sup> race. Mr. Frey rode the winner #9 DARCURTS HOPE and let his horse drift out slightly at the wire. Mr. Frey was cautioned to stay straight through the finish.

09-26-14<sup>5</sup> **RACE #1 – INQUIRY/OBJECTION – MULES – DISQUALIFICATION**

The inquiry sign was posted to review this 350 yard mule event. Tapes show #5 BAR JF LOTTOTICKET (2<sup>nd</sup> - Francisco Maldonado) come in under right hand whipping interfering with #4 OUTA IDAHO (4<sup>th</sup> – Dionicio Navarro) and #3 RAFTER F NELLY (5<sup>th</sup> – Salvador Ibarra). Jockey Dionicio Navarro also lodged a claim of foul. #5 was unanimously disqualified and placed 5<sup>th</sup> for interference.

09-26-14<sup>6</sup> **RACE #3 – STEWARDS' REVIEW**

#3 WHISP O CAJUN SPIRIT (Martin Arriaga) broke tardy from the gate. The stewards replayed the start for the public and determined no reason existed for an inquiry.

09-26-14<sup>7</sup> **RACE #4 – CLAIM VOIDED**

The claim submitted by Jerry Weaver for TOSS THE DICE was voided after state veterinarian Don Dooley reported that the gelding was lame. The horse was given back to trainer Salvador Naranjo.

09-27-14<sup>1</sup> **RULING NO. 4 – FRANCISCO MALDONADO**

Jockey **FRANCISCO MALDONADO**, who rode **BAR JF LOTTOTICKET** in the first race at the San Joaquin County Fair (Stockton) on September 26, 2014 is hereby suspended three (3) racing days (October 4, 5, 9, 2014) for failure to make a proper effort to maintain a straight course and causing interference resulting in a disqualification from second to fifth. A violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The above ruling was issued after Mr. Maldonado appeared and admitted to making an error in judgment by allowing his mount to bear in without being clear of rivals.

09-27-14<sup>2</sup> **RACE #3 – DOUBLE INQUIRY – NO CHANGE**

The stewards posted the inquiry sign to review two incidents in this 350 yard Quarter Horse event. The first incident involved #1 FRENCH FURY (Samuel Mendez) ducking in hitting the rail. No other horses were involved. No change. The second incident involved #2 PRIMERCARTEL (4<sup>th</sup> – Luis Godoy) and #3 Z BEST CONTENDER (3<sup>rd</sup> – Juan Arriaga). After review and talking to the riders involved no change was ordered. Tapes show that both horses contributed to a bump midway through the race.

09-27-14<sup>3</sup> **RACE #3 – WAGERING CLOSED EARLY**

A glitch in the tote system control from the stewards’ stand caused the wagering to close approximately 30 seconds before the start. No cause was determined and no further problems arose.

09-27-14<sup>4</sup> **RACE #5 – CLAIM VOIDED**

The claim submitted by Salvador Naranjo for FRENCH DYNASTY was voided after state veterinarian Don Dooley reported that the gelding was lame. The horse was returned to W.L. McDaniel’s barn.

09-27-14<sup>5</sup> **RACE #6 –INQUIRY – NO CHANGE – ACCIDENT**

The inquiry sign was posted to review the finish concerning #5 SHOWMEWHATYOUOGOT who went wrong and fell at the wire. After a thorough review it was determined #5 finished the race. #4 LITTLE LINDA lost rider Jake Samuels while trying to avoid the fallen horse. Since the incidents occurred after the wire, no change was warranted. Accident reports will be attached.

**Sunday****09-28-14<sup>1</sup> RULING NO. 5 – BRENDAN BAKIR (TACHYCARDIA STABLES) (CASE: 14GG0098)**

Owner **BRENDAN BAKIR (DBA TACHYCARDIA STABLES)**, having failed to respond to charges alleging violation of California Horse Racing Board Rule #1876 (Financial Responsibility) is suspended for violation of C.H.R.B. Rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of **BRENDAN BAKIR (DBA TACHYCARDIA STABLES)** are suspended pursuant to C.H.R.B. Rule #1528 (Jurisdiction of Stewards to Suspend or Fine). **BRENDAN BAKIR** is denied access to all premises in this jurisdiction.

The above ruling was issued after Mr. Bakir failed to appear on a financial complaint alleging a debt of \$3,263 for veterinary services provided by San Francisco Equine, Inc.

**09-28-14<sup>2</sup> FINANCIAL SETTLED – SUZANNE RODRIGUEZ (CASE: 14GG0097)**

The stewards were contacted by Steward George Slender at Los Alamitos who said that Suzanne Rodriguez presented him with a check for \$195.00 to satisfy a bill owed to San Francisco Equine, Inc.

**09-28-14<sup>3</sup> RULING NO. 6 – KYLE FREY**

Jockey **KYLE FREY** is hereby fined fifty dollars (\$50)\* for violation of California Horse Racing Board Rule #1680 (Reporting to Jockey's Room – Late to Report) on Saturday, September 27, 2014 at the San Joaquin County Fair (Stockton).

The above ruling was issued when Frey failed to arrive at the prescribed time.

**09-28-14<sup>4</sup> RULING NO. 7 – ANTHONY DEMARCO**

Trainer **ANTHONY DEMARCO** is hereby fined three hundred dollars (\$300)\* pursuant to California Horse Racing Board (CHRB) Rule #1629 (Penalty for Late Declaration) for violation of CHRB Rule #1845 (Authorized Bleeder Medication) for failure to properly treat ARTAKSEZ necessitating a late declaration from the third race at Stockton, California on September 28, 2014.

The above ruling was issued after the stewards notified DeMarco who failed to have his horse on the grounds in time for treatment. The horse arrived at 11:20 a.m. and the scheduled time for Lasix administration was 10:21 a.m.

**09-28-14<sup>5</sup> RACE #4 – INQUIRY & OBJECTION – ACCIDENT – NO CHANGE**

#2 GET YOUR PRAISE ON appears to clip heels with #3 EXPENSIVE JET near the 4½ furlong marker. Jockey Juan Sanchez was unseated in the incident and transported to the hospital. Blame could not be placed on any individual horse. No change. #2 was euthanized by track veterinarian Sarah Sporer. Accident report attached.

Separately, jockey Catalino Martinez aboard 2<sup>nd</sup> place finisher #7 DENOMINATOR lodged a claim of foul against the winner #3 EXPENSIVE JET and jockey Stephen Herrera for alleged interference in the stretch drive. After talking to the riders and reviewing the race no change was ordered. #3 comes out slightly in the stretch but does not interfere with #7.

**09-28-14<sup>6</sup> RACE #5 – INQUIRY – ACCIDENT – NO CHANGE**

#5 SECRET MEMO went wrong and fell near the 3/16 pole while racing in the clear. No change. Jockey Joe Crispin was transported to the hospital. Accident report is attached.

09-28-14<sup>7</sup> **RACE #8 – INQUIRY – DISQUALIFICATION**

The inquiry sign was posted to review the stretch drive involving #6 ROGUE STATUS (Pedro Flores) who finished second and #4 TIME TO GLOW (Bryan Pena) who finished 4<sup>th</sup>. After talking to the jockeys involved and reviewing all angles of the race the stewards voted to disqualify #6 and place him 4<sup>th</sup> in a unanimous decision. Tapes clearly show #6 bear in causing #4 to alter course and check sharply behind another rival losing all momentum and a chance at a better placing.
