Jockey Richard Migliore was excused from his mounts for the afternoon. The stewards were notified by his agent, Ron Anderson, that Mr. Migliore was ill. Replacement riders were named.

**MORNING MATTERS ROUTINE**

Racing was scheduled for today to replace the day missed last Friday, February 08, while the track renovation was completed. Morning business was routine.

02/13/08<sup>4</sup>**JOCKEYS' ROOM MEETING**

After the fifth race, the stewards were called to the jockeys' room because the riders had some issues concerning the track condition. In attendance were General Manager George Haines, Director of Racing Mike Harlow, Track Superintendent Richard Tedesco, Jockeys' Guild representative Darrell Haire, jockeys and the stewards.

Mr. Tedesco advised the group that his crew could make repairs to the surface immediately, but would need more time than scheduled between races. The work was done, resulting in a 19 minute delay of the sixth race, and the colony seemed satisfied that the track was racing safe.

Morning matters were all routine.

02/14/08<sup>2</sup>**STEWARDS' INQUIRY - DISQUALIFICATION**

Following the running of the fifth race (about 6 ½ on the turf), the stewards posted the inquiry sign to review an incident at the top of the stretch. Involved were the winner #6 "Sportie's Squeeze" (apprentice jockey Jose Campos) and #3 "Gold Chant" (jockey Joe Talamo), the last place finisher, as well as several other horses.

After speaking with the riders and the patrol judges, and reviewing the tape replays, the stewards unanimously voted to disqualify #6 from 1<sup>st</sup> to 11<sup>th</sup>, behind #3, for interference into the stretch. Replays show that #6 came out and made hard contact with #3. This caused a chain reaction with several horses, causing #3 to lose all opportunity at a better placing.

02/15/08<sup>2</sup>**FILM REVIEW**

Apprentice jockey JOSE CAMPOS met with the stewards to discuss his ride in the fifth race yesterday in which his mount was disqualified from the win and placed last for interference at the head of the stretch on the hillside turf course.

Prior to his individual meeting, jockeys Aaron Gryder and David Flores spoke to the stewards on behalf of Mr. Campos. Both riders believed that the extension rail which connects the hill to the main grass course was misaligned and that that was the proximate cause of the interference rather than any careless riding by the apprentice.

After viewing the films, the stewards agreed that the course configuration and the horse herself could be blamed for the interference, and therefore warned Mr. Campos to be more aware in the future concerning this unique aspect of racing at Santa Anita.

02/15/08<sup>3</sup>**FROUSIAKIS HEARING**

The Stewards held a formal hearing regarding case 07HP138 which involved a complaint filed by the CHRB against trainer GEORGE FROUSIAKIS for violation of CHRB rules 1843 (A) (D) and 1844 (B). The complaint alleged an overage of the NSAID banamine (class VI) in the amount of 3,795 ng/ml, which is approximately 67 times the permitted limit. It also alleged that, given the exceptionally high amount, the medication was given on race day and therefore a violation of the twenty four hour rule.

Testifying at the hearing were Mr. Frousiakis and Dr. Rick Arthur (CHRB Equine Medical Director). Presenting the case on behalf of the CHRB was Senior Investigator Frank Fink, and recording the proceedings was Barbara Weinstein.

Mr. Frousiakis objected to the complaint as a whole because he believed that he should have been informed of all potential violations when deciding whether to request a split sample. He also claimed that the overage was the result of his groom accidentally administering banamine paste instead of the anti-ulcer medication omeprazole. He believed, however, that the last administration was at least twenty four hours before the race and presented some hearsay evidence to support that claim.

Dr. Arthur testified that the unusually high amount of banamine was due to an administration in the twenty four hours preceding the race, although he believed that the administration was probably accidental. Decision to follow.

**CONLON HEARING AND PURSE REDISTRIBUTION**

The Stewards conducted two formal hearings involving related matters with respect to the post race clenbuterol positive of Tommys Luck, trained by Melody Conlon. Case number 07HP0152 involved a stipulated agreement between the CHRБ and Ms. Conlon, as well as a disqualification and purse redistribution. The owner of the horse, John Liviakis, was noticed but did not attend. The stewards approved the stipulated agreement and will memorialize its terms as well as the disqualification in rulings to follow.

**INQUIRY / DISQUALIFICATION**

Following the running of the third race, the stewards posted the inquiry sign to examine an incident at the five and a half on the synthetic surface, in which jockey Joel Rosario’s mount, #4 Cupid’s Kitty, appeared to clip heels and stumble, unseating Mr. Rosario (see enclosed accident report).

After reviewing the films, the stewards determined that #5 Clashoftheswords (A. Gryder) drifted down slightly into the path of #4, setting up the circumstances under which that rival clips heels. The stewards voted unanimously to disqualify #5 Clashoftheswords and place him unplaced.

**FILM REVIEW**

Jockey Aaron Gryder met with the stewards to discuss his ride in the third race yesterday, in which his mount was disqualified and jockey Joel Rosario was unseated when his horse clipped heels. After reviewing the video tapes, it was the stewards' opinion that Mr. Gryder's horse drifted in only slightly, that Mr. Rosario's horse drifted out slightly, and that Mr. Rosario should have eased out of the spot in which he found himself rather than continuing in a difficult situation.

Although not absolving Mr. Gryder of blame for the incident, the stewards did not believe that it rose to the level of careless riding.

**LaCROIX HEARING**

The stewards conducted a formal hearing into case number 07HP159, which involved a post race clenbuterol (class III) overage discovered in a horse trained by DAVID LaCROIX. The CHRB entered into a stipulated agreement with Mr. LaCroix, the terms of which included a three thousand dollar fine. The stewards approved the agreement.

With respect to the disqualification, Mr. LaCroix, as part owner of the horse, was present and did not contest the redistribution based on CHRB 1859.5 (Disqualification Upon Positive Test Finding). Therefore the following rulings were issued:

**LATS #111**

Based upon a report from the University of California, Davis Laboratories, an official laboratory for the California Horse Racing Board, that urine sample #HP03184, obtained from the horse "Happyhour Athebrig", the second place finisher in the fourth race on December 1, 2007 at Hollywood Park Race Track, contained the drug Clenbuterol (Class III) in excess of the permitted level, it is ordered that "Happyhour Athebrig" be disqualified from all purse monies earned in said race, in accordance with California Horse Racing Board rule #1859.5 (Disqualification upon Positive Test Finding).

It is further ordered that the purse money earned in said race (\$2,800.00) be returned by owners Larry Katz, Meadowbrook Farm, Inc., and Frank Scarano to the Paymaster of Purses at Hollywood Park by March 09, 2008, for redistribution in accordance with the revised order of finish.

It is further ordered that the purse money earned in said race (\$10,200.00) be returned by owner John Liviakis to the Paymaster of Purses at Hollywood Park by March 09, 2008, for redistribution in accordance with the revised order of finish.

**FILM REVIEW**

Jockey IGGY PUGLISI met with the stewards to discuss his ride in the eighth race yesterday, in which his mount makes solid contact with another rival nearing the wire. While films seemed to support Mr. Puglisi's argument that his horse ducked out suddenly, it was the stewards' opinion that he could have reacted more quickly. A warning was issued to Mr. Puglisi with the caveat that a similar slow reaction would result in suspension days in the future.

02/18/08<sup>2</sup>**FROUSIAKIS RULING**

After careful consideration of the Frousiakis matter referenced above, the stewards issued the following ruling. Although it was trainer Frousiakis' only NSAID infraction in the last twelve months, the stewards believed that the evidence suggested a race day administration (albeit an accidental one) and therefore felt that the standard penalty was inadequate.

**LATS #114**

Trainer GEORGE FROUSIAKIS, who started the horse "One Bullet Fife" in the eighth race at Santa Anita Park on November 01, 2007, is fined SEVEN HUNDRED and FIFTY DOLLARS (\$750.00)\* for violation of California Horse Racing Board rules #1843 (A) & (D) (Medication, Drugs, and other Substances) and #1844 (B) (Authorized Medication – administration within twenty four hours of race time).

02/18/08<sup>3</sup>**INQUIRY – NO CHANGE**

Following the running of the eighth race, the stewards posted the inquiry sign to examine the circumstances under which jockey Joe Talamo, aboard fourth place finisher #8 Shermeen (IRE), steadies sharply approaching the wire on the turf course. Films seemed to show Mr. Talamo's mount being squeezed by the first and second place finishers in this grade 2 event. However, upon further examination and after speaking with the patrol judges and riders involved, the following became clear: (1) first place finisher #4 Costume was clear when she drifted outward and therefore was not a factor in the incident; and (2) second place #7 Black Mamba (IRE) maintains a straight path throughout the stretch and that if anything, Mr. Talamo's mount caused her own problems by drifting out over heels.

Given this analysis, the stewards voted unanimously to make no change to the original order of finish.
