11/07/09² **VIDEO REVIEW**

Jockey Rajiv Maragh was in the office this morning to review the fifth race (Breeders' Cup Juvenile Fillies) to review the stretch run, during which his mount, #10 Negligee, was responsible for interference. The horse he bothered finished in front of him so there was no need for an inquiry. After review of the video and discussing the incident with Maragh, the Stewards – Mr. Chaney dissenting – opted to give Maragh a pass. While he could have made the effort sooner, it was the majority's opinion that it did not give rise to a sanction.

11/07/09³ **JOCKEY OBJECTION/NO CHANGE**

The objection sign was posted after the seventh race as Manoel Cruz(5th, #6 Mambo Meister) lodged a claim of foul against Calvin Borel(2nd, #10 Ready's Echo) for interference during the stretch run. Cruz felt that Borel's mount came in during the late stages, causing him to steady and lose a position. After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the incident the Stewards voted unanimously to dismiss the objection. There were two incidents between the two during the stretch run. The first occurred near the 1/8th pole and was the responsibility of Mambo Meister as that horse drifted out to bump Ready's Echo on two occasions. While Ready's Echo did drift in nearing the finish, Cruz steadied momentarily. It was the opinion of the Stewards that Cruz was not denied a placing due to the actions of the second place horse. Additionally, it was also felt that the incidents offset one another.

11/07/09⁴ **REFUND**

The Stewards ordered a refund in the ninth race(Breeders' Cup Classic) as #12 Quality Road became extremely fractious during the loading process, suffering minor injuries and leading Racing Veterinarians Barrie Grant and Dana Stead to recommend the horse be declared. Several methods were employed in attempting to load the unruly three-year-old, but they only succeeded in making him mad. It

became a dangerous situation as Quality Road started to kick with a purpose and it was very fortunate that no one was injured.
The refund amounted to \$2,189,356.07

WHAT A CLASSIC!!!

The Breeders' Cup Classic certainly lived up to its billing as the brilliant five-year-old mare Zenyatta put on a clinic, coming from last place with her trade mark late run to humble a group of the best horses in the world. The crowd of over 58,000 let out a roar not heard at this venue in decades, and continued to cheer her well after she returned to the Winners Circle.
