Jockey **FELIPE VALDEZ**, who rode the horse "Breakmark" in the ninth race at Hollywood Park on November 21, 2010, is suspended for three (3) racing days (January 9, 13, and 14, 2010) for violation of California Horse Racing Board rule #1688 (Use of Whips-causing welts or breaks in the skin).

The above ruling was issued after a hearing was held with Mr. Valdez by telephone. The penalty given involved aggravating circumstances pertaining to CHRB rule 1688; this was Mr. Valdez's fourth offense within the last year. Once again Mr. Valdez was informed he needs to change his style of whipping to avoid further penalties.

During the term of suspension, all licenses and license privileges of Mauricio Sanchez are suspended pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), he is denied access to all premises in this jurisdiction.

The above rulings were issued after neither licensee appeared for their scheduled hearing.

INQUIRY 4th RACE (7/8-Dirt)/NO CHANGE

Following the running of the race the inquiry sign was posted to review an incident approaching the 1/16 marker. Involved in a three horse spread starting with the inside horse were, # 2 Marquisite (3rd P. Valenzuela), in the middle #4 Great Bernardine (2nd J. Verenzuela), and on the outside # 5 Elle Dehere (1st K. John). After a review of all angles of the incident and conversation with the Patrol Judge and all jockeys involved it was a unanimous decision to let the original order of finish stand. It was the Stewards' opinion that #5 and # 4 both contributed to their initial contact, # 2 was also brushed but none of this action affected their opportunity of better placings.

After a formal hearing and deliberation, it is the decision of the Board of Stewards that owner Dan Horowitz is indebted to owner Marsha Davis in the amount of \$2,015.00. Such indebtedness must be resolved by February 8, 2011. In the event that Dan Horowitz does not comply with the terms of this ruling, he will be suspended for violation of California Horse Racing Board rule #1876 (Financial Responsibility).

TARABA RULING

LATS #023

Veterinarian **KEITH TARABA**, is suspended for violation of California Horse Racing Board rule #1876(Financial Responsibility-Southern Cal. Equine Foundation \$5,865.04-failure to fulfill financial agreement).

During the term of suspension, all licenses and license privileges of Keith Taraba are suspended pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Taraba is denied access to all premises in this jurisdiction.

The above ruling was distributed after the Stewards were informed that Dr. Taraba had failed to make agreed financial payments.

INFORMAL DISCUSSION

Trainer Carlos Lopez along with his counsel Suzanne Porrazzo, and owner Jose Zulaica met with the Stewards to discuss a financial dispute that also involved a missing set of foal registration papers. It was apparent the parties involved were not going to agree to resolve this situation without a complaint being filed first. They were instructed to visit the investigators to start the proper procedure.
