VETERINARIAN MEETING

The Stewards met with our team of veterinarians this morning – Official Veterinarian Jill Bailey, and Racing Veterinarians Dana Stead and Tim Grande – in order to exchange thoughts on the most expeditious manner in which to place horses on and remove horses from the Veterinarian's List. At issue was the fact

that a horse was removed from the list as the trainer had not been informed within 72 hours of the horse being placed on the list. Such notification is mandated by rule #1866. A healthy discussion was had and changes will be implemented.

RIDER EXCUSED

Corey Nakatani was excused from his mounts this afternoon as he was suffering from a sore throat. Track physician Dr. Sotomayor examined the rider and found him unfit to perform. Replacement riders were named.

RULING LATS #075

Apprentice jockey **TYLER KAPLAN** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for violation of California Horse Racing Board rules #1930 (Obedience to Security Officers and Public Safety Officers-failure to review video when so ordered).

This ruling was issued after Mr. Kaplan gave his explanation of his failure to attend the mandatory weekly meeting of apprentice riders with former jockey, and now Safety Steward, Luis Jauregui. None of the excuses held water; therefore the fine was assessed.

RULING LATS #076

Jockey **CHANTAL SUTHERLAND** is fined **ONE HUNDRED DOLLARS (\$100.00)*** pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations-late to the paddock).

This ruling was issued after Ms. Sutherland, in the company of her agent, Brian Beach, came to the office to explain her tardiness to the paddock for the seventh race this past Sunday. She explained that she was a participant in the George Woolf award ceremony, and did not have time to prepare for the succeeding race. It was pointed out to her that while other riders also participated, they did not have a problem getting to their mounts in a somewhat timely manner.

RULING LATS #077

Trainer **ERIC REED** is fined **SEVEN HUNDRED AND FIFTY DOLLARS (\$750.00)*** for failure to properly report the gelding of the horse "RUN ARNIE RUN", which ran in the ninth race at Santa Anita Park on February 13, 2011. This constitutes a violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

This ruling was issued after a telephonic hearing with Mr. Reed into his failure to report the gelding of first time starter Run Arnie Run when entering for the ninth race on February 13, 2011. Mr. Reed, who has returned to his home in Kentucky to recuperate from an illness he suffered while in California, explained that the horse was gelded at a farm while it was a yearling and he was not aware of the castration. He further stated that he was not aware of the California rule and accepted the penalty.

CHATTONG HEARINGS

Two cases filed by Board investigators against owner Vichien Chattong were heard this morning. The formal hearings, requested by Chattong, were for violation of California Horse Racing Board rules #1876(Financial Responsibility) and #1877(Checks) as it was alleged that he owed former employee Jesus Ospina wages and also had written a check to Ospina which was not honored by the bank. Present were the Board of Stewards, Chattong, Ospina, and Board investigator Rick Ameiva. Safety Steward Luis Jauregui acted as the interpreter for Ospina, while Barbara Weinstein recorded the proceedings.

Ospina said he presented the check at his bank and used his debit card as identification. He was told that there were not sufficient funds to cover the check. Chattong maintained that there were funds, and that the bank told him Ospina did not have valid ID for them to cash the check. We believe Ospina. Chattong subsequently gave Ospina \$1,200.00 in cash to make the check good and also partial payment on wages. The second matter was adjudicated as the two compromised on the amount owed and settled for \$390.00. Consequently, an official warning was issued for the dishonored check.

Jockey **ALONSO QUINONEZ** is fined **ONE HUNDRED DOLLARS (\$100.00)*** pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations-late to the paddock-March 23, 2011, second race).

This ruling was issued after Mr. Quinonez came to the office to explain his extreme tardiness in coming to the walking ring prior to the second race on Wednesday. Quinonez said that after weighing out, he suffered the onset of a gastrointestinal problem which left him unable to leave the loo. He was told that he at least should have informed someone in authority about his problem as that way the horses would not have left the saddling barn.

COMPLAINTS DISMISSED

Three financial complaints filed by trainer Doug O'Neill against clients were withdrawn as O'Neill called and said he had agreements in place. He was asked if he understood that he could not re-file should the licensees not live up to the terms of the agreement. He said he was aware of this but still wanted to withdraw the complaints.

OWNER IN

Owner Earnest Johnson was in the office this morning to voice his concerns over the fact that his horse Road to the Throne, an eight-year-old, 0 for 35 maiden,

was scratched after a pre-race examination by Official Veterinarian Jill Bailey. Mr. Johnson acknowledged that he was not at the barn when his horse was examined but said that in his opinion there was nothing wrong with the horse. In fact, he felt the horse had an excellent chance to end the winless streak this afternoon. He was informed that we would contact Dr. Bailey and get details which prompted the scratch.

MANDELLA HEARING

A formal hearing was held this morning into a complaint filed by the Board against trainer Richard Mandella, whose horse Champ Pegasus, which finished first in the third race at Santa Anita on February 19, 2011, tested positive for the drug Methocarbamol. Present were the Board of Stewards and Investigator Rick Amieva, who presented the case for the Board. Mr. Mandella could not attend as he is in Dubai for the World Cup but instructed the Stewards to proceed in his absence. He said that the horse did receive the medication found in the post-race test and that it was simply a mistake in the barn which caused the problem. Ruling to follow.

BACKSTRETCH RULINGS

Twenty-one rulings were issued for security citations issued for non-compliance with stable area fire regulations or failure to display licenses.

MINUS POOL

A minus pool was created in the second race as #2 Tokubetsu, the odds-on favorite at 3-5, finished second. A total of \$9,127.51 was needed to balance.

ACCIDENT/HORSE EUTHANIZED

The fifth race this afternoon was marred by an accident at the top of the stretch. Just as the field passed the 3/16th pole, #8 Brenthurst, with Martin Pedroza aboard, suffered a catastrophic injury to the left front fetlock and fell suddenly.

Fortunately, Pedroza was thrown clear and was given a clearance to ride after examination by the track physician. Brenthurst, however, had to be euthanized on the track by Racing Veterinarian Dana Stead. Accident report attached.
