HARRIS HEARING CASE #11PM015

A complaint was filed by the CHRB against Stable Foreman Milton Alfred Harris for a possible violation of CHRB rule 1874 (Disorderly Conduct). This complaint was pursuant to a security violation from Hollywood Park dated 09-23-11. Mr. Milton appeared with his employer, trainer Stanley Waterman. There were no representatives from Hollywood Park Security and no witnesses were present. Mr. Harris denied he threw a chair while eating at the backside Mini Mart and will eat at offsite locations in the future. Mr. Harris was issued a warning.

EKINS HEARING CASE #0011

The complaint filed by the CHRB alleging a violation of rule # 1895 (Trainer's Duties to Insure Licensed Participation). Trainer Dennis Ekins

was cited for employing Cole Jackson, who did not have a current CHRB license. After a telephonic hearing and taking into account Mr. Ekins' explanation of the chain of events he was issued a warning. Mr. Ekins explained that he did have a licensed employee, but due to a minor injury to that person Mr. Jackson offered to paddock the horse. Upon discovery of the expired license, Mr. Ekins' licensed groom took charge of the horse before entering the receiving barn.

INQUIRY/DISQUALIFICATION/SECOND RACE 5 1/2 FURLONGS (dirt)

Following the running of the race the inquiry sign was posted to review a possible infraction near the 1/16 pole. Involved were # 5 Two Violins (3rd K. John) and # 6 Howmuchisit (7th V. Espinoza). After talking with the Patrol Judges and both jockeys involved it was a unanimous decision to disqualify # 5 and place it seventh behind # 6. It was the Stewards' opinion that # 5 drifted out without sufficient clearance into the path of #6 causing that one to take up and steady for several strides, denying it the opportunity of a better placing.
